Where any of those Primary Care Contracts or Arrangements expire or are terminated, they will be deemed removed from the list contained in this Contractual Notice as from the date of expiry or termination. However, the ICB will remain responsible for dealing with any post-termination issues.

3. General provisions

- 3.1. Any terms defined in the Delegation Agreement have the same meaning in this Contractual Notice.
- 3.2. This Contractual Notice is given by NHS England pursuant to clause 6.4 of the Delegation Agreement and takes effect as a variation to the Delegation Agreement.

- 3.3. If there is any conflict between the provisions of this Contractual Notice and the terms of the Delegation Agreement, the provisions of this Contractual Notice shall prevail.
- 3.4. Except as expressly varied by this Contractual Notice, the Delegation Agreement shall remain in full force and effect.
- 3.5. As set out in clause 7.1.2 of the Delegation Agreement, the ICB is required to exercise the Delegated Functions in accordance with this Contractual Notice.
