Administration of typhoid Vi polysaccharide vaccine to overseas travellers at risk of exposure to *Salmonella enterica serovar typhi* (*S. typhi*) in accordance with recommendations from the National Travel Health Network and Centre (NaTHNaC).

This PGD is for the administration of typhoid Vi polysaccharide vaccine by registered healthcare practitioners identified in Section 3, subject to any limitations to authorisation detailed in Section 2.



<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<b>Clinical condition or situation to which this PGD applies</b>	<p>Indicated for the active immunisation of individuals against <i>S. typhi</i> infection in accordance with national recommendations in <a href="#">Chapter 33</a> of Immunisation Against Infectious Disease: “The Green Book” and <a href="#">NaTHNaC</a> recommendations for typhoid vaccination for travel.</p>
<b>Criteria for inclusion</b>	<p>Adults and children over 2 years old who:</p> <ul style="list-style-type: none"> <li>intend to travel, where typhoid vaccination is currently recommended for travel by <a href="#">NaTHNaC</a> (see the <a href="#">Travel Health Pro</a> website for country-specific advice on typhoid vaccination)</li> </ul> <p>Children aged 12 months up to 2 years (<a href="#">off-label use</a>) who:</p> <ul style="list-style-type: none"> <li>intend to travel, where typhoid vaccination is currently recommended for travel by <a href="#">NaTHNaC</a> and if the risk of typhoid fever is considered high (see the <a href="#">Travel Health Pro</a> website for country-specific advice on typhoid vaccination)</li> </ul>
<b>Criteria for exclusion<sup>2</sup></b>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>are under 12 months of age</li> <li>have had a confirmed anaphylactic reaction to a previous dose of typhoid Vi polysaccharide vaccine or to any components of the vaccine (including trace components from the manufacturing process which may include formaldehyde, see SPC)*</li> <li>are at increased risk of <i>S. typhi</i> infection because of their occupation (eg laboratory personnel who may handle <i>S. typhi</i> in the course of their work)</li> <li>are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul> <p>*Note: Severe reactions to a previous dose of non-Vi typhoid vaccines do not contraindicate the subsequent use of a Vi-containing vaccine.</p>
<b>Cautions including any relevant action to be taken</b>	<p>Individuals who are immunosuppressed or have HIV infection may not make a full antibody response; consider whether postponing vaccination until the end of the disease or treatment is appropriate. Otherwise, vaccination is recommended even if the antibody response may be limited and the importance of scrupulous attention to personal, food and water hygiene must be emphasised.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>
<b>Action to be taken if the patient is excluded</b>	<p>Individuals under one year of age are not recommended typhoid vaccine. Where vaccine is not recommended (and even when it is), the importance of stringent personal, food and water hygiene measures should be reinforced.</p>
Continued over page	Individuals who have had a confirmed anaphylactic reaction to a

<p><b>Action to be taken if the patient is excluded</b> (continued)</p>	<p>previous dose of typhoid Vi polysaccharide vaccine or any components of the vaccine should be referred to a clinician for specialist advice and appropriate management.</p> <p>Individuals who are solely at occupational risk of <i>S. typhi</i> infection should be referred to their employer's occupational health provider for vaccination.</p> <p>Individuals suffering acute severe febrile illness should postpone immunisation until they have recovered; immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>In a GP practice setting, inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications.</p> <p>Document advice given and the decision reached.</p> <p>In a GP practice setting, inform or refer to the GP as appropriate.</p>
<p><b>Arrangements for referral for medical advice</b></p>	<p>As per local policy</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	<p>Typhoid Vi polysaccharide vaccine, 0.5ml dose containing 25 micrograms Vi polysaccharide of <i>S. typhi</i> (Ty2 strain) eg:</p> <ul style="list-style-type: none"> <li>• TYPHIM Vi<sup>®</sup> vaccine, solution for injection in a pre-filled syringe</li> </ul> <p>Note: This PGD does not cover the supply or administration of the live oral (Ty21a) typhoid vaccine, Vivotif<sup>®</sup>.<sup>3</sup></p>
<b>Legal category</b>	<p>Prescription only medicine (POM)</p>
<b>Black triangle▼</b>	<p>No</p>
<b>Off-label use</b>	<p>TYPHIM Vi<sup>®</sup> vaccine may be administered off-label to children between the age of 12 months and two years if the risk of typhoid fever is considered to be high, in accordance with the recommendations in <a href="#">Chapter 33</a> of “The Green Book” and <a href="#">NaTHNaC</a>.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route / method of administration</b>	<p>Administer by intramuscular injection into the deltoid region of the upper arm.</p> <p>When administering at the same time as other vaccines, care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each was given should be noted in the individual’s records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be given by deep subcutaneous injection to reduce the risk of bleeding (see “The Green Book” <a href="#">Chapter 4</a>).</p> <p>Typhoid Vi polysaccharide vaccine is a clear colourless solution. The vaccine should be visually inspected for particulate matter and discoloration prior to administration. In the event of any foreign particulate matter and/or variation of physical aspect being observed, do not administer the vaccine. Shake well immediately before administration.</p> <p>The vaccine’s SPC provides further guidance on administration and is available from the electronic Medicines Compendium website:</p>

<sup>3</sup> PHE do not currently plan to produce a PGD for live oral (Ty21a) typhoid vaccine (Vivotif<sup>®</sup>) because, as a 3 dose oral course, an appropriately labelled supply would be required. Since the availability of such supplies cannot be assured when writing a national PGD template, oral vaccines may be better suited to provision by normal prescription and dispensing services.



<b>Route / method of administration</b> (continued)	<a href="http://www.medicines.org.uk">www.medicines.org.uk</a>
<b>Dose and frequency of administration</b>	<p>A single 0.5ml dose.</p> <p>Vaccination should occur at least 2 weeks prior to potential exposure to infection with <i>S. typhi</i>. Based on individual risk assessment, vaccination may be considered up until departure but protection may be limited.</p> <p>Revaccination:</p> <p>Individuals who plan to travel to an area where typhoid vaccination is currently recommended for travel by <a href="#">NaTHNaC</a>, and who have not received typhoid vaccine in the preceding 3 years should be re-vaccinated against <i>S. typhi</i>.</p> <p>Individuals who remain at risk of exposure to <i>S. typhi</i> should be revaccinated every three years (see <a href="#">Special Considerations</a> section).</p> <p>Note: Typhoid Vi polysaccharide vaccine may be used for revaccination when individuals have received non-Vi typhoid vaccine for the preceding dose.</p>
<b>Duration of treatment</b>	<p>Single dose.</p> <p>Revaccination may be indicated for individuals who remain at risk of typhoid fever (see <a href="#">Dose and frequency of administration</a>).</p>
<b>Quantity to be supplied / administered</b>	Single 0.5ml dose.
<b>Supplies</b>	<p>Typhoid vaccine is not centrally supplied and should be obtained directly from manufacturers/wholesalers.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see <a href="#">protocol for ordering storage and handling of vaccines</a> and Green Book <a href="#">Chapter 3</a>).</p>
<b>Storage</b>	<p>Store between +2°C to +8°C.</p> <p>Store in original packaging in order to protect from light.</p> <p>Do not freeze.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of at the end of a session by sealing in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01: Safe management of healthcare waste</a> (Department of Health, 2013).</p>

<p><b>Drug interactions</b></p>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of drug interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Identification &amp; management of adverse reactions</b></p>	<p>Local reactions following vaccination are very common ie pain, swelling, erythema and induration at the injection site.</p> <p>Adverse reactions to typhoid Vi polysaccharide vaccines are usually mild and transient, disappearing a few days after immunisation.</p> <p>Other reported reactions to typhoid Vi polysaccharide vaccination include general symptoms such as fever, general aches, malaise, headache, nausea and itching.</p> <p>Hypersensitivity reactions and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the SPC , which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Reporting procedure of adverse reactions</b></p>	<p>Healthcare professionals and individuals/parents/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme at: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<p><b>Written information to be given to patient or carer</b></p>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p>
<p><b>Patient advice / follow up treatment</b></p>	<p>Inform the individual/parent/carer of possible side effects and their management.</p> <p>The individual/parent/carer should be advised to seek medical advice in the event of an adverse reaction.</p> <p>The individual/parent/carer should be advised that Typhoid Vi polysaccharide vaccine offers protection against typhoid fever caused by <i>S. typhi</i>, it does not prevent paratyphoid fever or infection with any other serotypes of <i>S. enterica</i>.</p> <p>The individual/parent/carer should be advised that protection by vaccination may be less if a large number of infective organisms are ingested. Because of the limited protection offered by the vaccine, the importance of scrupulous attention to personal, food and water hygiene must still be emphasised for those travelling to endemic areas.</p> <p>When applicable, advise individual/parent/carer when the subsequent dose is due.</p> <p>When administration is postponed advise the individual/parent/carer when to return for vaccination.</p>

<p><b>Special considerations / additional information</b></p>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone.</p> <p>Protective antibody titres to Vi antigen fall over time. Re-vaccination is necessary when continuing protection is required. Additional doses of Vi vaccine do not boost serum antibody levels; re-vaccination returns antibody levels to those achieved after the primary immunisation.</p> <p>Non-conjugated polysaccharide vaccines are poorly immunogenic in infants and young children. There is little definitive data on the efficacy of Vi vaccine in children aged less than 18 months.</p> <p>There is no evidence of risk from vaccinating pregnant women or those who are breast feeding with inactivated vaccines. Since typhoid polysaccharide vaccine is an inactivated (subunit) vaccine, the risks to the foetus are negligible and it should be given where there is a definite risk of infection.</p> <p>Local Health Protection Team (HPT) should be informed immediately whenever a patient is suspected of having typhoid fever. Typhoid vaccine is not recommended for close contacts of either cases or carriers, or during an outbreak of typhoid fever in the UK. Both cases and carriers of <i>S. typhi</i> should be advised to be scrupulous in their hygiene practices. Carriers should be referred for specialist clinical management.</p>
<p><b>Records</b></p>	<p>Record:</p> <ul style="list-style-type: none"> <li>• that valid informed consent was given</li> <li>• name of individual, address, date of birth and GP with whom the individual is registered</li> <li>• name of immuniser</li> <li>• name and brand of vaccine</li> <li>• date of administration</li> <li>• dose, form and route of administration of vaccine</li> <li>• quantity administered</li> <li>• batch number and expiry date</li> <li>• anatomical site of vaccination</li> <li>• advice given, including advice given if excluded or declines immunisation</li> <li>• details of any adverse drug reactions and actions taken</li> <li>• supplied via Patient Group Direction (PGD)</li> </ul> <p>Records should be signed and dated (or a password controlled immunisers record on e-records).</p> <p>All records should be clear, legible and contemporaneous.</p> <p>When vaccine is administered to individuals under 19 years of age, notify the local Child Health Information Systems team (Child Health Records Department) using the appropriate documentation/pathway as required by any local or contractual arrangement.</p> <p>A record of all individuals receiving treatment under this PGD should also be kept for audit purposes in accordance with local policy.</p>
