## Human papillomavirus vaccine for gay, bisexual, and men who have sex with men (GBMSM) Patient Group Direction (PGD)

This PGD is for the administration of human papillomavirus (HPV) vaccine to GBMSM, who attend Specialist Sexual Health Services (SSHS) and/or HIV clinics.

This PGD is for the administration of HPV vaccine by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

**The UK Health Security Agency (UKHSA) has developed this PGD to facilitate the delivery of publicly funded immunisation in England in line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>1</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition, authorising organisations must not alter section 3 'Characteristics of staff'. Only sections 2 and 7 can be amended within the designated editable fields provided.

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.

**Individual practitioners must be authorised by name, under the current version of this PGD before working according to it.**

Practitioners and organisations must check that they are using the current version of the PGD. Amendments may become necessary prior to the published expiry date.




<b>Continued training requirements</b>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from the UKHSA and/or NHSE and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<b>Clinical condition or situation to which this PGD applies</b>	Indicated for the active immunisation of individuals aged 45 years and under <sup>2</sup> who are GBMSM and who attend SSHS and/or HIV clinics, for the prevention of human papillomavirus infection in accordance with the recommendations given in <a href="#">Chapter 18a</a> of Immunisation Against Infectious Disease: The 'Green Book'.
<b>Criteria for inclusion</b>	Individuals who: <ul style="list-style-type: none"> <li>are GBMSM aged 45 years and under<sup>2</sup> who attend a SSHS and/or HIV clinic</li> </ul>
<b>Criteria for exclusion<sup>3</sup></b>	Individuals for whom no valid consent has been received. For further information on consent see <a href="#">Chapter 2</a> of the Green Book. Individuals who: <ul style="list-style-type: none"> <li>are females</li> <li>are aged less than 25 years who are immunocompetent and are not HIV positive, and have received one dose of HPV vaccine</li> <li>are aged 46 years and over, except those who have received a partial course of HPV vaccination<sup>2</sup></li> <li>are under 9 years of age</li> <li>are men who do not have sex with men</li> <li>have had a confirmed anaphylactic reaction to a previous dose of HPV vaccine or to any component of the vaccine</li> <li>are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<b>Cautions including any relevant action to be taken</b>	Facilities for management of anaphylaxis should be available at all vaccination sites (see <a href="#">Chapter 8</a> of the Green Book) and advice issued by the <a href="#">Resuscitation Council UK</a> .  Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.  The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. Vaccination should proceed in accordance with the national recommendations. However, re-immunisation may need to be considered (see Green Book <a href="#">Chapter 7</a> ). Seek medical advice as appropriate.
<b>Action to be taken if the patient is excluded</b>  Continued over page <b>Action to be taken if the patient is excluded</b>	If female, this PGD does not apply. Refer to the <a href="#">UKHSA HPV PGD</a> for vaccination in accordance with the national HPV programme if appropriate.  Individuals aged 46 years and over are not eligible to commence a course of HPV vaccination under the NHS commissioned service. However, courses commenced before 46 years of age as part of the pilot or national programme can be completed under this PGD.  JCVI has advised that there should no longer be a lower age limit for the HPV immunisation of GBMSM. However, HPV vaccine administration to

<sup>2</sup> Anyone eligible for the HPV vaccination programme for GBMSM that started, but did not complete the schedule before reaching the age of 46 years, should complete the vaccination course, providing the first dose was given as part of the pilot or national programme.

(continued)	<p>those under 9 years of age is off-label and is not covered by this PGD so a PSD would be required.</p> <p>Vaccination of individuals who are not GBMSM is not covered by this PGD. Vaccination should be offered to individuals attending SSHS or HIV clinics who have a similar risk profile to that seen in the GBMSM population. This includes some transgender individuals, sex workers, and those living with HIV infection. These individuals should be assessed on a case-by-case basis and a PSD would be required. Vaccine centrally procured for the HPV GBMSM programme should not be used for this purpose. If HPV vaccine is indicated but use is outside of the HPV GBMSM programme, vaccines should be purchased directly from the manufacturer or pharmaceutical wholesaler.</p> <p>If a confirmed anaphylactic reaction has been experienced after a previous dose of HPV vaccine or any of its components, specialist advice should be sought. If immunisation is recommended do not administer under this PGD; a PSD will be required.</p> <p>Individuals suffering acute severe febrile illness should postpone immunisation until they have recovered; immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged at the earliest opportunity.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the individual's clinician as appropriate.</p>
<b>Action to be taken if the patient or carer declines treatment</b>	<p>Informed consent, from the individual or a person legally able to act on the individual's behalf, must be obtained for each administration.</p> <p>Advise the individual about the protective effects of the vaccine, the risks of infection and potential complications.</p> <p>Document the advice given and the decision reached.</p> <p>Inform or refer to the individual's clinician as appropriate.</p>
<b>Arrangements for referral for medical advice</b>	As per local policy

## 5. Description of treatment

<b>Name, strength and formulation of drug</b>	Human papillomavirus 9-valent vaccine [types 6, 11, 16, 18, 31, 33, 45, 52, 58] (recombinant, adsorbed): <ul style="list-style-type: none"> <li>Gardasil® 9, suspension for injection in a pre-filled syringe or vial</li> </ul>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>The use of a one-dose schedule of Gardasil® 9 is off-label, however it is in accordance with national recommendations by <a href="#">JCVI</a> and <a href="#">Chapter 18a</a> of the Green Book.</p> <p>Administration of a two-dose course with a 0, 6-24 month schedule differs slightly from the schedules in the SPC, but is in accordance with official recommendations and <a href="#">Chapter 18a</a> of the Green Book.</p> <p>Completion of a HPV vaccine course using Gardasil® 9 when it was not commenced with the same HPV vaccine product is off-label but is in accordance with official recommendations and <a href="#">Chapter 18a</a> of the Green Book.</p> <p>The HPV vaccine SPC states that 'vaccinees should be observed for approximately 15 minutes after vaccine administration'. In line with advice in <a href="#">Chapter 4</a> of the Green Book, recipients of any vaccine should be observed for immediate adverse drug reactions. There is no evidence to support the practice of keeping individuals under longer observation.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route and method of administration</b>	<p>Administer by intramuscular injection. The preferred site is the deltoid region of the upper arm.</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>Individuals with bleeding disorders may be vaccinated intramuscularly if, in the opinion of a doctor familiar with the individual's bleeding risk, vaccines or similar small volume intramuscular injections can be administered with reasonable safety by this route. If the individual receives medication/treatment to reduce bleeding, for example treatment for haemophilia, intramuscular vaccination can be scheduled shortly after such medication/treatment is administered. Individuals on stable anticoagulation therapy, including individuals on warfarin who are up to date with their scheduled INR testing and whose latest INR was below the upper threshold of their therapeutic range, can receive intramuscular vaccination. A fine needle (equal to 23 gauge or finer calibre such as 25 gauge) should be used for the vaccination, followed by firm pressure applied to the site (without rubbing) for at least 2 minutes. If in any doubt, consult with the clinician</p>

**Route and method of administration**





<b>Disposal</b>	Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority arrangements and guidance in the <a href="#">technical memorandum 07-01</a> : Safe management of healthcare waste (NHSE, 2022).
<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>Gardasil® 9 may be administered concomitantly with dTaP, dT/IPV or dTaP/IPV with no significant interference with antibody response to any of the components of either vaccine. See the Green Book <a href="#">Chapter 18a</a> for full details of the vaccines that can be given at the same time as Gardasil®9.</p> <p>A detailed list of drug interactions is available in the SPC, which is available from the <a href="#">electronic Medicines Compendium website</a>.</p>
<b>Identification and management of adverse reactions</b>	<p>Local reactions following vaccination are very common i.e., pain, swelling or redness at the injection site.</p> <p>Mild side effects such as headache, nausea, dizziness, fatigue, fever, injection-site haematoma and injection-site pruritus are reported as common.</p> <p>Other adverse events have been reported in post-marketing surveillance but the frequency of these is not known.</p> <p>Hypersensitivity reactions and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the SPC which is available from the <a href="#">electronic Medicines Compendium website</a>.</p>
<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the <a href="#">Yellow Card reporting scheme</a> or search for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's clinician should be informed.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer the marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>If applicable, inform the individual/parent/carer that PIL with large print, Braille or audio CD can be ordered from the manufacturer (see <a href="#">electronic medicines compendium</a>).</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">HPV for MSM: Information leaflet</a></li> <li>• <a href="#">Information on HPV vaccination</a></li> </ul> <p>Available via the <a href="#">UKHSA Immunisation Collection</a> webpage.</p>
<b>Patient advice and follow up treatment</b>  Continued over page <b>Patient advice and follow up treatment</b> (continued)	<p>Inform the individual of possible side effects and their management. The individual should be advised to seek medical advice in the event of an adverse reaction.</p> <p>Advise individual when the next dose is due. If administration is postponed advise the individual when to return for vaccination.</p> <p>Advise that individuals should continue to take appropriate precautions to protect themselves from sexually transmitted diseases.</p> <p>Advise individuals that using a condom during sex can help to prevent an HPV infection. However, condoms don't offer complete protection. HPV can</p>

	<p>be present all over the area around the genitals and anus and is spread through skin-to-skin contact of the genital area.</p> <p>As fainting can occur following vaccination, individuals, where appropriate, should be advised not to drive or use machinery until symptoms have cleared (see <a href="#">Cautions</a>).</p>
<p><b>Special considerations and additional information</b></p>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>HPV vaccination is for prophylaxis against future HPV infection. It will not treat pre-existing HPV infection.</p> <p>Gardasil® 9 vaccine will protect against HPV types 6, 11, 16, 18, 31, 33, 45, 52 and 58. Appropriate precautions against sexually transmitted diseases should continue to be used.</p> <p>There may be considerable benefit in offering the HPV vaccine to individuals attending SSHS or HIV clinics who were not eligible for the routine HPV programme and are deemed to have a similar risk profile to that seen in the GBMSM population. This includes some transgender individuals, sex workers, and men and women living with HIV. Those whose risk of acquiring HPV is considered equivalent to the risk of GBMSM eligible for the HPV vaccine, should be offered vaccination. However, this PGD does not cover the vaccination of these individuals so a PSD may be required.</p> <p>For those who have previously completed a course of HPV vaccination as part of the school HPV programme, no further doses need be given.</p> <p>There is no data on fewer than 3 doses of HPV vaccine among HIV-positive or immunocompromised populations. Therefore, a 3-dose schedule should be offered to individuals who are known to be HIV positive, including those on antiretroviral therapy, or who are known to be immunocompromised at the time of immunisation.</p> <p>For individuals who started but did not complete an HPV vaccine schedule, the course can be completed with Gardasil® 9, the vaccine currently in use in the UK HPV programme for GBMSM.</p>
