This PGD is for the administration of typhoid Vi polysaccharide vaccine to overseas travellers at risk of exposure to *Salmonella enterica serovar typhi* (*S. typhi*) in accordance with recommendations from the National Travel Health Network and Centre (NaTHNaC).

This PGD is for the administration of typhoid Vi polysaccharide vaccine by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

**The UK Health Security Agency (UKHSA) has developed this PGD to facilitate the delivery of publicly funded immunisation in England in line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>1</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition, authorising organisations must not alter section 3 (Characteristics of staff). Sections 2 and 7 can be edited within the designated editable fields provided, **but only for the purposes for which these sections are provided, namely the responsibilities and governance arrangements of the NHS organisation using the PGD. The fields in Section 2 and 7 cannot be used to alter, amend or add to the clinical content. Such action will invalidate the UKHSA clinical content authorisation which is provided in accordance with the regulations.**

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.

**Individual practitioners must be authorised by name, under the current version of this PGD before working according to it.**

Practitioners and organisations must check that they are using the current version of the PGD. Amendments may become necessary prior to the published expiry date.



<b>Continued training requirements</b>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from the UKHSA, NHSE and other sources of medicines information.</p> <p>Note: the most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations outside of criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<b>Clinical condition or situation to which this PGD applies</b>	Indicated for the active immunisation of individuals against <i>S. typhi</i> infection in accordance with national recommendations in <a href="#">Chapter 33</a> of Immunisation Against Infectious Disease: the Green Book and <a href="#">NaTHNaC</a> recommendations for typhoid vaccination for travel.
<b>Criteria for inclusion</b>	<p>Adults and children over 2 years old who:</p> <ul style="list-style-type: none"> <li>intend to travel, where typhoid vaccination is currently</li> <li>recommended for travel by <a href="#">NaTHNaC</a> (see the <a href="#">Travel Health Pro</a> website for country-specific advice on typhoid vaccination)</li> </ul> <p>Children aged 12 months up to 2 years (<a href="#">off-label use</a>) who:</p> <ul style="list-style-type: none"> <li>intend to travel, where typhoid vaccination is currently recommended for travel by <a href="#">NaTHNaC</a> and if the risk of typhoid fever is considered high (see the <a href="#">Travel Health Pro</a> website for country-specific advice on typhoid vaccination)</li> </ul>
<b>Criteria for exclusion<sup>2</sup></b>	<p>Individuals for whom valid consent or a best-interests decision in accordance with the Mental Capacity Act 2005, has not been obtained (for further information on consent, see <a href="#">Chapter 2</a> of the Green Book). Several resources are available to inform consent (see <a href="#">written information to be given to individual or carer</a> section).</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>are under 12 months of age</li> <li>have had a confirmed anaphylactic reaction to a previous dose of typhoid Vi polysaccharide vaccine or to any components of the vaccine, including trace components from the manufacturing process which may include formaldehyde or casein* (see <a href="#">SPC</a>)</li> <li>are at increased risk of <i>S. typhi</i> infection because of their occupation (such as laboratory personnel who may handle <i>S. typhi</i> in the course of their work)</li> <li>are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul> <p>*Note: severe reactions to a previous dose of non-Vi typhoid vaccines do not contraindicate the subsequent use of a Vi-containing vaccine.</p>
<b>Cautions including any relevant action to be taken</b>	<p>Facilities for management of anaphylaxis should be available (see <a href="#">Chapter 8</a> of the Green Book and advice issued by the <a href="#">Resuscitation Council UK</a>).</p> <p>Individuals who are immunosuppressed or have HIV infection may not make a full antibody response; consider whether postponing vaccination until the end of the disease or treatment is appropriate. Otherwise, vaccination is recommended even if the antibody response may be limited. The importance of scrupulous attention to personal, food and water hygiene must be emphasised.</p> <p>Syncope (fainting) can occur following, or even before any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p> <p>As with all injectable vaccines, TYPHIM Vi<sup>®</sup> must be administered with caution to individuals with thrombocytopenia or a bleeding disorder since</p>

<b>Cautions including any relevant action to be taken</b> (continued)	bleeding may occur following intramuscular administration to these individuals (see <a href="#">Chapter 4</a> of the Green Book).
<b>Action to be taken if the individual is excluded</b>	<p>Individuals under one year of age are not recommended typhoid vaccine. Where vaccine is not recommended (and even when it is), the importance of stringent personal, food and water hygiene measures should be reinforced.</p> <p>Individuals who have had a confirmed anaphylactic reaction to a previous dose of typhoid Vi polysaccharide vaccine or any components of the vaccine should be referred to a clinician for specialist advice and appropriate management.</p> <p>Individuals who are solely at occupational risk of <i>S. typhi</i> infection should be referred to their employer's occupational health provider for vaccination.</p> <p>Individuals suffering acute severe febrile illness should postpone immunisation until they have recovered; immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Specialist advice on typhoid management is available from NaTHNaC's <a href="#">advice line</a>. Otherwise, seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account. The importance of scrupulous attention to personal, food and water hygiene must be emphasised.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<b>Action to be taken if the individual or carer declines treatment</b>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual, parent or carer about the protective effects of the vaccine, the risks of infection and the potential complications.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the GP as appropriate.</p>
<b>Arrangements for referral for medical advice</b>	As per local policy



## 5. Description of treatment

<b>Name, strength and formulation of drug</b>	<p>Typhoid Vi polysaccharide vaccine, 0.5ml dose containing 25 micrograms Vi polysaccharide of <i>S. typhi</i> (Ty2 strain):</p> <ul style="list-style-type: none"> <li>TYPHIM Vi<sup>®</sup> vaccine, solution for injection in a pre-filled syringe</li> </ul> <p>Note: This PGD does not cover the supply or administration of the live oral (Ty21a) typhoid vaccine, Vivotif<sup>®</sup>.<sup>3</sup></p>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>TYPHIM Vi<sup>®</sup> vaccine may be administered off-label to children between the age of 12 months and 2 years if the risk of typhoid fever is considered to be high, in accordance with the recommendations in <a href="#">Chapter 33</a> of the Green Book and <a href="#">NaTHNaC</a>.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage</a> section below. However, in the event of an inadvertent or unavoidable deviation of these conditions, refer to <a href="#">Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual, parent or carer that the vaccine is being offered outside of product licence but in accordance with national guidance.</p>
<b>Route and method of administration</b>	<p>Administer by intramuscular injection, preferably into the deltoid muscle of the upper arm.</p> <p>When administering at the same time as other vaccines, care should be taken to ensure that the appropriate route of injection is used for all vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each was given should be noted in the individual's records.</p> <p>Individuals with bleeding disorders may be vaccinated intramuscularly if, in the opinion of a doctor familiar with the individual's bleeding risk, vaccines or similar small volume intramuscular injections can be administered with reasonable safety by this route. If the individual receives medication or other treatment to reduce bleeding, for example treatment for haemophilia, intramuscular vaccination can be scheduled shortly after such medication or treatment is administered. Individuals on stable anticoagulation therapy, including individuals on warfarin who are up to date with their scheduled INR testing and whose latest INR was below the upper threshold of their therapeutic range, can receive intramuscular vaccination. A fine needle (equal to 23 gauge or finer calibre such as 25 gauge) should be used for the vaccination, followed by firm pressure applied to the site (without rubbing) for at least 2 minutes. The individual or carer should be informed about the risk of haematoma from the injection.</p> <p>Typhoid Vi polysaccharide vaccine is a clear colourless solution. The vaccine should be visually inspected for foreign particulate matter and other variation of expected appearance prior to preparation and</p>

<sup>3</sup> The UKHSA do not currently plan to produce a PGD for live oral (Ty21a) typhoid vaccine (Vivotif<sup>®</sup>) because, as a 3 dose oral course, an appropriately labelled supply would be required. Since the availability of such supplies cannot be assured when writing a national PGD, oral vaccines may be better suited to provision by normal prescription and dispensing services.

<b>Route and method of administration</b> (continued)	<p>administration. Should either occur, do not administer the vaccine and discard the syringe in accordance with local procedures.</p> <p>Shake well immediately before administration.</p> <p>Further guidance on administration is available from the product <a href="#">SPC</a>.</p>
<b>Dose and frequency of administration</b>	<p>A single 0.5ml dose.</p> <p>Vaccination should occur at least 2 weeks prior to potential exposure to infection with <i>S. typhi</i>. Based on individual risk assessment, vaccination may be considered up until departure, but protection may be limited.</p> <p><b>Revaccination</b></p> <p>Individuals who plan to travel to an area where typhoid vaccination is currently recommended for travel by <a href="#">NaTHNaC</a>, and who have not received typhoid vaccine in the preceding 3 years should be revaccinated against <i>S. typhi</i>.</p> <p>Individuals who remain at risk of exposure to <i>S. typhi</i> should be reassessed and if appropriate, revaccinated at intervals of not less than 3 years (see <a href="#">special considerations and additional information</a> section).</p> <p>Note: Typhoid Vi polysaccharide vaccine may be used for revaccination when individuals have received non-Vi typhoid vaccine for the preceding dose.</p>
<b>Duration of treatment</b>	<p>Single dose.</p> <p>Revaccination may be indicated for individuals who remain at risk of typhoid fever (see <a href="#">Dose and frequency of administration</a>).</p>
<b>Quantity to be supplied and administered</b>	<p>Single 0.5ml dose.</p>
<b>Supplies</b>	<p>Typhoid vaccine is not centrally supplied and should be obtained directly from manufacturers or their wholesalers.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see the Green Book <a href="#">Chapter 3</a>).</p>
<b>Storage</b>	<p>Store between +2°C to +8°C.</p> <p>Store in original packaging in order to protect from light.</p> <p>Do not freeze.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">Vaccine Incident Guidance</a>.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant sharps box, according to local authority arrangements and NHSE guidance (HTM 07-01): <a href="#">Management and disposal of healthcare waste</a>.</p>
<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of drug interactions is available in the product's <a href="#">SPC</a>.</p>

<b>Identification and management of adverse reactions</b>	<p>Local reactions following vaccination are very common, such as pain, swelling, erythema and induration at the injection site.</p> <p>Adverse reactions to typhoid Vi polysaccharide vaccines are usually mild and transient, disappearing a few days after immunisation.</p> <p>Other commonly reported reactions to typhoid Vi polysaccharide vaccination include fatigue, fever, headache, malaise and myalgia.</p> <p>Hypersensitivity reactions and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the product's <a href="#">SPC</a>.</p>
<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals, parents or carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the <a href="#">Yellow Card reporting scheme</a> or by searching for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to individual or carer</b>	<p>Offer the marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>For resources in accessible formats and alternative languages, please visit <a href="#">Home - Health Publications</a>. Where applicable, inform the individual or carer that large print, Braille or audio CD PILs may be available from emc accessibility (freephone 0800 198 5000) by providing the medicine name and product code number, as listed in the product's <a href="#">SPC</a>.</p>
<b>Advice and follow up treatment</b>	<p>Inform the individual, parent or carer of possible side effects and their management.</p> <p>The individual, parent or carer should be advised to seek medical advice in the event of an adverse reaction and report this via the <a href="#">Yellow Card reporting scheme</a>.</p> <p>The individual, parent or carer should be advised that Typhoid Vi polysaccharide vaccine offers protection against typhoid fever caused by <i>S. typhi</i>. It does not prevent paratyphoid fever or infection with any other serotypes of <i>S. enterica</i>.</p> <p>The individual, parent or carer should be advised that protection against <i>S. typhi</i> by vaccination may be reduced if a large number of infective organisms are ingested.</p> <p>The importance of scrupulous attention to personal, food and water hygiene must be emphasised for all those travelling to endemic areas.</p> <p>When applicable, advise the individual, parent or carer when the subsequent dose is due.</p> <p>When administration is postponed advise the individual, parent or carer when to return for vaccination.</p>
<b>Special considerations and additional information</b>  (continued over page)	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone.</p> <p>Protective antibody titres to Vi antigen fall over time. Revaccination is necessary when continuing protection is required. Additional doses of Vi vaccine do not boost serum antibody levels; revaccination returns antibody levels to those achieved after the primary immunisation. Non-conjugated polysaccharide vaccines are poorly immunogenic in infants and young children. There is little definitive data on the efficacy of Vi vaccine in children aged less than 18 months.</p>

<b>Special considerations and additional information</b> (continued)	<p>There is no evidence of risk from vaccinating individuals who are pregnant or breastfeeding with inactivated vaccines. Since typhoid polysaccharide vaccine is an inactivated (subunit) vaccine, the vaccine should be given in pregnancy or breastfeeding where there is an identified risk of infection.</p>
<b>Records</b>	<p>The practitioner must ensure the following is recorded:</p> <ul style="list-style-type: none"> <li>• that valid informed consent was given</li> <li>• name of individual, address, date of birth and GP with whom the individual is registered</li> <li>• name of immuniser</li> <li>• name and brand of vaccine</li> <li>• date of administration</li> <li>• dose, form and route of administration of vaccine</li> <li>• quantity administered</li> <li>• batch number and expiry date</li> <li>• anatomical site of vaccination</li> <li>• advice given, including advice given if excluded or immunisation declined</li> <li>• details of any adverse drug reactions and actions taken</li> <li>• supplied via PGD</li> </ul> <p>Records should be signed and dated (or password controlled on e-records).</p> <p>All records should be clear, legible and contemporaneous.</p> <p>This information should be recorded in the individual's GP record. Where vaccine is administered outside the GP setting, appropriate health records should be kept and the individual's GP informed.</p> <p>Where applicable, the local Child Health Information Systems team (Child Health Records Department) must be notified using the appropriate documentation or pathway as required by any local or contractual arrangement.</p> <p>A record of all individuals receiving treatment under this PGD should also be kept for audit purposes in accordance with local policy.</p>
