## **Pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed) Risk Groups Patient Group Direction (PGD)**

This PGD is for the administration of pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed) (PCV13) to individuals from 6 weeks of age with an underlying medical condition which puts them at increased risk from pneumococcal disease.

This PGD is for the administration of pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed) (PCV13) by registered healthcare practitioners identified in Section 3, subject to any limitations to authorisation detailed in Section 2.

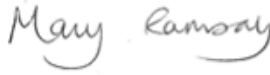

<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals with an underlying medical condition which puts them at increased risk from pneumococcal disease in accordance with the national immunisation programme and recommendations given in <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a> of Immunisation Against Infectious Disease: 'The Green Book'.</p> <p>This PGD does not cover the routine childhood PCV13 immunisation programme which is covered by the PHE PCV PGD.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals who are:</p> <ul style="list-style-type: none"> <li>• under 2 years who have, or are anticipated to have (see <a href="#">Special considerations / additional information</a>), asplenia, splenic dysfunction, complement disorder or severe immunocompromise<sup>2</sup></li> <li>• from 2 years to under 10 years of age who are previously unvaccinated or partially vaccinated (such that they did not complete the routine PCV course as part of the national schedule) and who have a medical condition included in <a href="#">Appendix A</a></li> <li>• over 2 years of age and have, or are anticipated to have (see <a href="#">Special considerations / additional information</a>), severe immunocompromise<sup>2</sup></li> </ul> <p>Note: all individuals with a medical condition included in <a href="#">Appendix A</a> should receive a dose of PPV23 after their second birthday (see PPV PGD).</p>
<p><b>Criteria for exclusion<sup>3</sup></b></p>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are less than 6 weeks of age</li> <li>• have had a confirmed anaphylactic reaction to a previous dose of pneumococcal vaccine or to any component of the vaccine including diphtheria toxoid</li> <li>• have received a dose of PCV13 within the last 4 weeks (Note: national schedule recommends an 8-week interval, see <a href="#">Dose and frequency of administration</a> section)</li> <li>• are aged 10 or above and received a dose of PPV23 within the last 2 years</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p>	<p>The immunogenicity of the vaccine could be reduced in immunosuppressed individuals; however vaccination is still recommended.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>

<sup>2</sup> Examples of severe immunocompromise include bone marrow transplant patients, patients with acute and chronic leukaemia, multiple myeloma or genetic disorders affecting the immune system (such as IRAK-4, NEMO)

<sup>3</sup> Exclusion under this PGD does not necessarily mean the medication is contraindicated, but it would be outside this PGDs remit and another form of authorisation will be required

<p><b>Action to be taken if the patient is excluded</b></p>	<p>If aged less than 6 weeks defer immunisation and provide an appointment as appropriate.</p> <p>If a dose of PCV13 was received within the last 4 weeks defer immunisation for an appropriate interval (see <a href="#">Dose and frequency of administration</a>).</p> <p>In case of postponement due to acute severe febrile illness, advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications of disease.</p> <p>Document the advice given and the decision reached.</p> <p>Inform or refer to the GP as appropriate.</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	Pneumococcal polysaccharide conjugate vaccine (13-valent, adsorbed), PCV13: <ul style="list-style-type: none"> <li>• Prevenar® 13 suspension for injection in a pre-filled syringe</li> </ul>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>Administration of a two-dose primary series of Prevenar® 13 to pre-term infants &lt;37 weeks gestation, with asplenia, splenic dysfunction, complement disorder or severe immunocompromise<sup>2</sup>, is contrary to the 3-dose primary schedule detailed in the SPC but is in accordance with PHE recommendations for individuals with asplenia, splenic dysfunction, complement disorder or severe immunocompromise in <a href="#">Chapter 7</a> and <a href="#">Chapter 25</a> of the 'Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route / method of administration</b>	<p>Administer by intramuscular injection, preferably into the anterolateral aspect of the thigh in infants under one year of age. The deltoid region of the upper arm may be used in individuals over one year of age.</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be administered in accordance with the recommendations in the 'Green Book' <a href="#">Chapter 4</a> to reduce the risk of bleeding.</p> <p>The vaccine's normal appearance is a uniform white suspension which may sediment during storage. Shake the prefilled syringe well to uniformly distribute the suspension before administering the vaccine.</p> <p>The vaccine should be visually inspected for particulate matter and discoloration prior to administration. In the event of any foreign particulate matter and/or variation of physical aspect being observed, do not administer the vaccine.</p>

<p><b>Route / method of administration</b> (continued)</p>	<p>The SPC provides further guidance on administration and is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Dose and frequency of administration</b></p> <p>continued over page</p>	<p>Single 0.5ml dose per administration</p> <p><b>Individuals under 1 year of age</b></p> <p>Individuals at increased risk of pneumococcal disease due to asplenia, splenic dysfunction, complement disorder or severe immunocompromise<sup>4</sup> should receive:</p> <ul style="list-style-type: none"> <li>• a 2-dose priming schedule of PCV13 vaccine with an 8-week interval* between priming doses administered in the first year of life (commencing no earlier than 6 weeks of age), then</li> <li>• a booster dose to be administered at one year of age (on or after the first birthday), then</li> <li>• a further booster dose, 8 weeks after the first booster.</li> </ul> <p>*The immunisation interval may be reduced to 4-weeks if necessary to ensure the immunisation schedule is completed.</p> <p>All other individuals under 1 year of age should be fully vaccinated in accordance with the routine PCV13 immunisation programme (see the PHE PCV PGD and the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a> guidance).</p> <p><b>Individuals from 1 year to under 2 years of age</b></p> <p>Individuals with asplenia, splenic dysfunction (see <a href="#">Appendix A</a>), complement disorder or severe immunocompromise<sup>4</sup>, aged between their first and second birthday should receive the PCV13 booster routinely scheduled on or shortly after their first birthday followed by an additional booster dose of PCV13 with an interval of 8 weeks between the PCV13 booster doses. Note: This is the schedule to follow regardless of whether the child had none, one or two routine primary doses of PCV13 in infancy. The intervals may be reduced to one month if necessary to ensure that the immunisation schedule is completed.</p> <p><b>Individuals from 2 years to under 10 years of age</b></p> <p>Individuals from 2 years to under 10 years of age, with a medical condition included in <a href="#">Appendix A</a> (excluding the severely immunocompromised<sup>4</sup>), who have completed the routine PCV immunisation schedule (with PCV7 or PCV13) do not require further PCV13.</p> <p>Individuals from 2 years to under 10 years of age who are previously unvaccinated or partially vaccinated (such that they did not complete a PCV course as part of the national schedule) and who have a medical condition included in <a href="#">Appendix A</a> should receive a single dose of PCV13.</p> <p>Severely immunocompromised<sup>4</sup> individuals, who have not received an additional booster of PCV13 recommended to severely immunocompromised individuals presenting between one and two years of age, should be offered a single dose of PCV13 irrespective of any routine childhood vaccinations they have already received.</p>

<sup>4</sup> Examples of severe immunocompromise include bone marrow transplant patients, patients with acute and chronic leukaemia, multiple myeloma or genetic disorders affecting the immune system (such as IRAK-4, NEMO)

<p><b>Dose and frequency of administration</b> (continued)</p>	<p><b>Individuals from 10 years of age</b></p> <p>Individuals from 10 years of age, with a medical condition included in <a href="#">Appendix A</a> (excluding the severely immunocompromised<sup>4</sup>) do not require PCV13.</p> <p>Severely immunocompromised<sup>4</sup> individuals should be offered a single dose of PCV13 irrespective of any routine childhood vaccinations they have already received.</p> <p><b>Pneumococcal polysaccharide vaccine (PPV23)</b></p> <p>Additionally, all individuals with a medical condition included in <a href="#">Appendix A</a> should receive a dose of PPV23 after their second birthday (see PPV PGD).</p> <p>Individuals eligible for both PCV13 and PPV23 should have the PCV13 dose first followed by PPV23 at least 2 months later.</p>
<p><b>Duration of treatment</b></p>	<p>Single 0.5ml dose</p>
<p><b>Quantity to be supplied / administered</b></p>	<p>Single 0.5ml dose per administration.</p>
<p><b>Supplies</b></p>	<p>PCV13 for additional doses from one year of age for at risk groups is not centrally procured and these should be ordered from the manufacturer/wholesaler. Details are given in the Green Book <a href="#">Chapter 25</a>.</p> <p>Centrally purchased vaccines for the national routine childhood immunisation programme for the NHS can only be ordered via ImmForm, that is vaccines for use for primary immunisation and the booster at one year of age. Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see the Green Book <a href="#">Chapter 3</a>).</p>
<p><b>Storage</b></p>	<p>Store at +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.</p> <p>Prevenar 13 is stable at temperatures up to 25°C for four days. At the end of this period Prevenar 13 should be used or discarded. These data are intended to guide health care professionals in case of inadvertent temporary temperature excursions only.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p>
<p><b>Disposal</b></p>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01</a>: Safe management of healthcare waste (Department of Health, 2013).</p>

<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Identification &amp; management of adverse reactions</b>	<p>Local reactions following vaccination are very common such as pain, swelling or redness at the injection site. A small painless nodule may form at the injection site.</p> <p>The most commonly reported adverse reactions include vaccination-site reactions, fever, irritability, decreased appetite, increased and/or decreased sleep, rash, vomiting, diarrhoea, arthralgia, myalgia and headache.</p> <p>Hypersensitivity reactions, such as bronchospasm, angioedema, urticaria, and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals/parents/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme on: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer the marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Splenoectomy leaflet</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
<b>Patient advice / follow up treatment</b>	<p>Inform the individual/parent/carer of possible side effects and their management.</p> <p>Vaccination may not result in complete protection in all recipients.</p> <p>Individuals at especially increased risk of serious pneumococcal infection (such as asplenic and those who have received immunosuppressive therapy for any reason), should be advised regarding the possible need for early antimicrobial treatment in the event of severe, sudden febrile illness.</p> <p>The individual/parent/carer should be advised to seek medical advice in the event of an adverse reaction.</p>
<b>Special considerations / additional information</b>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>Minor illnesses without fever or systemic upset are not valid reasons to postpone immunisation. If an individual is acutely unwell, immunisation may be postponed until they have fully recovered.</p>

<p><b>Special considerations / additional information</b> (continued)</p>	<p>Neonates diagnosed at increased risk of pneumococcal disease due to asplenia, splenic dysfunction, complement disorder or severe immunocompromise should be offered immunisation as soon as appropriate (such as with their first primary immunisations) and do not need to wait until the routine offer of PCV13 at 12 weeks of age.</p> <p>Individuals on Eculizumab (Soliris®) therapy are not at increased risk of pneumococcal disease and do not require PPV23 or additional doses of PCV13.</p> <p>Wherever possible, immunisation or boosting of immunosuppressed individuals should be either carried out before immunosuppression occurs or deferred until an improvement in immunity has been seen (see <a href="#">Chapter 25</a>). Immunisation of these individuals should not be delayed if this is likely to result in failure to vaccinate.</p> <p>Splenectomy, chemotherapy or radiotherapy should never be delayed in order to allow time for vaccination.</p>

## APPENDIX A

### Clinical risk groups who should receive the pneumococcal immunisation

(Green Book [Chapter 25](#) Table 25.2)

Clinical risk group	Examples (decision based on clinical judgement)
<b>Asplenia or dysfunction of the spleen</b>	This also includes conditions such as homozygous sickle cell disease and coeliac syndrome that may lead to splenic dysfunction.
<b>Chronic respiratory disease</b>	This includes chronic obstructive pulmonary disease (COPD), including chronic bronchitis and emphysema; and such conditions as bronchiectasis, cystic fibrosis, interstitial lung fibrosis, pneumoconiosis and bronchopulmonary dysplasia (BPD). Children with respiratory conditions caused by aspiration, or a neurological disease (e.g. cerebral palsy) with a risk of aspiration. Asthma is not an indication, unless so severe as to require continuous or frequently repeated use of systemic steroids (as defined in Immunosuppression below).
<b>Chronic heart disease</b>	This includes those requiring regular medication and/or follow-up for ischaemic heart disease, congenital heart disease, hypertension with cardiac complications, and chronic heart failure.
<b>Chronic kidney disease</b>	Nephrotic syndrome, chronic kidney disease at stages 4 and 5 and those on kidney dialysis or with kidney transplantation. (Re-immunisation with PPV23 is recommended every 5 years)
<b>Chronic liver disease</b>	This includes cirrhosis, biliary atresia and chronic hepatitis.
<b>Diabetes</b>	Diabetes mellitus requiring insulin or oral hypoglycaemic drugs. This does not include diabetes that is diet controlled.
<b>Immunosuppression</b>	Due to disease or treatment, including patients undergoing chemotherapy leading to immunosuppression, bone marrow transplant, asplenia or splenic dysfunction, complement disorder, HIV infection at all stages, multiple myeloma or genetic disorders affecting the immune system (such as IRAK-4, NEMO)  Individuals on or likely to be on systemic steroids for more than a month at a dose equivalent to prednisolone at 20mg or more per day (any age), or for children under 20kg, a dose of 1mg or more per kg per day.
<b>Individuals with cochlear implants</b>	It is important that immunisation does not delay the cochlear implantation.
<b>Individuals with cerebrospinal fluid leaks</b>	This includes leakage of cerebrospinal fluid such as following trauma or major skull surgery.
