## Haemophilus influenzae type b and meningococcal C conjugate vaccine (Hib/MenC) Patient Group Direction (PGD)

This PGD is for the administration of *Haemophilus influenzae* type b and meningococcal C conjugate vaccine (Hib/MenC) to individuals from their first birthday to under 10 years of age in accordance with the national immunisation programme; and to individuals of any age for the prevention of secondary cases of meningococcal group C (MenC) disease.

This PGD is for the administration of Hib/MenC by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

**Public Health England has developed this PGD to facilitate the delivery of publicly-funded immunisation in line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>1</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition, authorising organisations must not alter section 3 'Characteristics of staff'. Only sections 2 and 7 can be amended.

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.

<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals, against <i>Haemophilus influenzae</i> type b and meningococcal group C disease, from their first birthday to under 10 years of age; and to individuals of any age for the prevention of secondary cases of meningococcal group C disease, in accordance with the national immunisation programme; recommendations given in <a href="#">Chapter 16</a> and <a href="#">Chapter 22</a> of Immunisation Against Infectious Disease: the 'Green Book' and <a href="#">Guidance for Public Health Management of Meningococcal Disease in the UK</a>.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are aged from their first birthday to under 10 years of age and require a booster or primary dose of MenC and a Hib booster (this immunisation is usually offered on or after their first birthday)</li> <li>• are aged from their first birthday to under 10 years of age and are unimmunised or incompletely immunised against <i>Haemophilus influenzae</i> type b or MenC</li> <li>• require vaccination for the prevention of secondary cases of MenC disease, following specific advice from Public Health England Health Protection Teams</li> </ul>
<p><b>Criteria for exclusion<sup>2</sup></b></p>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are less than 1 year of age, unless indicated for the prevention of secondary cases of MenC disease</li> <li>• are aged 10 years and over, unless indicated for the prevention of secondary cases of MenC disease</li> <li>• have had a confirmed anaphylactic reaction to a previous dose of Hib or MenC containing vaccine or to any components of the vaccine, including any conjugate vaccines where tetanus toxoid is used in the conjugate.</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p> <p>Continued over page</p>	<p>If a seizure associated with a fever occurred within 72 hours of a previous immunisation, immunisation should continue as recommended if a cause is identified or the child recovers within 24 hours. However, if no underlying cause has been found and the child did not recover completely within 24 hours, further immunisation should be deferred until the condition is stable (as assessed by an appropriate clinician such as their GP or paediatrician).</p> <p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. Vaccination should proceed in accordance with the national recommendations. However, re-immunisation may need to be considered. Seek medical advice as appropriate.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia</p>

<p><b>Cautions including any relevant action to be taken</b> (continued)</p>	<p>and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>
<p><b>Action to be taken if the patient is excluded</b></p>	<p>If aged less than 1 year, Hib/MenC is not routinely indicated.</p> <p>If aged 10 years and over or has received a dose of Hib and MenC conjugate containing vaccine from 1 year of age, Hib/MenC immunisation is not indicated unless the individual requires immunisation for the prevention of secondary cases of MenC disease.</p> <p>Individuals suffering acute severe febrile illness should postpone immunisation until they have recovered; immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	<i>Haemophilus influenzae</i> type b and meningococcal group C conjugate vaccine (conjugated to tetanus toxoid as carrier protein): <ul style="list-style-type: none"> <li>Menitorix<sup>®</sup>, powder in vial and solvent for solution for injection in a prefilled syringe</li> </ul>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>Administration of Menitorix<sup>®</sup> to individuals aged 2 years and over is off-label but is indicated until 10 years of age under this PGD in accordance with PHE recommendations for the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a> and the relevant chapters of the 'Green Book'.</p> <p>The Menitorix<sup>®</sup> SPC states "Menitorix<sup>®</sup> should be used in accordance with official recommendations". The use of Menitorix<sup>®</sup> to provide a single priming dose of MenC to individuals from their first birthday is not covered by the SPC but is in accordance with PHE recommendations following advice from JCVI (see <a href="#">MenC vaccination schedule: planned changes from July 2016</a>).</p> <p>The Menitorix<sup>®</sup> SPC also states "The timing of the booster dose should be from the age of 12 months onwards and at least 6 months after the last priming dose." However, when primary vaccination has been delayed, the Hib booster dose may be given at the scheduled visit provided it is at least 1 month since the last primary dose was administered in accordance with PHE recommendations for the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a>.</p> <p>Administration of Hib/MenC for the prevention of secondary cases of MenC disease is not covered by the Menitorix<sup>®</sup> SPC, but Hib/MenC vaccine may be given as an alternative to MenACWY in accordance with PHE <a href="#">Guidance for Public Health Management of Meningococcal Disease in the UK</a>.</p> <p>Administration of Menitorix<sup>®</sup> by deep subcutaneous injection to patients with a bleeding disorder is off-label administration in line with advice in <a href="#">Chapter 4</a> and <a href="#">Chapter 22</a> of the 'Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>

<p><b>Route / method of administration</b></p>	<p>The vaccine must be reconstituted in accordance with the manufacturer's instructions prior to administration.</p> <p>Administer by intramuscular injection. The deltoid region of the upper arm may be used in individuals over one year of age. The anterolateral aspect of the thigh should be used for infants under one year vaccinated for the prevention of secondary cases of MenC disease.</p> <p>When administering at the same time as other vaccines, care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be given by deep subcutaneous injection to reduce the risk of bleeding (see the 'Green Book' <a href="#">Chapter 4</a>).</p> <p>The vaccine's normal appearance is a white powder and a clear colourless solvent. Following reconstitution the vaccine is a clear colourless solution.</p> <p>The vaccine should be visually inspected for particulate matter and discoloration prior to administration. In the event of any foreign particulate matter and/or variation of physical aspect being observed, do not administer the vaccine.</p> <p>The vaccine's SPC provides further guidance on administration and is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Dose and frequency of administration</b></p> <p>continued over page</p>	<p>Single 0.5ml dose</p> <p><b>Routine Childhood Immunisation Schedule</b></p> <p>A single dose to be administered, usually on or after their first birthday, although it may be administered until 10 years of age.</p> <p>When primary vaccination with Hib has been delayed, the Hib booster dose (Hib/MenC) may be given at the scheduled visit, on or after their first birthday, provided it is at least 4 weeks since the last primary Hib dose was administered.</p> <p><b>Incomplete immunisation history</b></p> <p>Children from their first birthday to under 10 years of age who have completed a primary course of diphtheria, tetanus, pertussis and polio but have not received Hib containing vaccines should receive a single dose of Hib/MenC vaccine.</p> <p>All unimmunised or incompletely immunised children under 10 years of age require one dose of Hib and MenC over the age of 1 year in accordance with the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a> flow chart.</p> <p><b>Secondary prevention of MenC disease</b></p> <p>Vaccination for the prevention of secondary cases of MenC disease should be in accordance with recommendations from the local Public Health England Health Protection Team and informed by the Public</p>

<b>Dose and frequency of administration</b> (continued)	<p>Health England <a href="#">Guidance for Public Health Management of Meningococcal Disease in the UK</a>.</p> <p>Unless they have been vaccinated against MenC in the preceding 12 months, contacts from one year of age should receive one dose of MenC containing vaccine.</p> <p>Individuals less than one year of age should receive two doses of MenC containing vaccine one month apart.</p>
<b>Duration of treatment</b>	<p>A single dose from 1 year of age or a two dose course for contacts under 1 year of age.</p> <p>Other meningococcal vaccines (such as MenACWY) are used for subsequent routine boosters in adolescence.</p>
<b>Quantity to be supplied / administered</b>	<p>Single 0.5ml dose per administration.</p>
<b>Supplies</b>	<p>Centrally purchased vaccines for the national immunisation programme can only be ordered via ImmForm. Vaccines for use for the national immunisation programme are provided free of charge.</p> <p>Vaccine for the management of contacts of MenC disease should ideally be ordered from the manufacturer/wholesalers.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see Green Book <a href="#">Chapter 3</a>).</p>
<b>Storage</b>	<p>Store between +2°C to +8°C.</p> <p>Store in original packaging in order to protect from light.</p> <p>Do not freeze.</p> <p>After reconstitution, the vaccine should ideally be administered promptly or kept between +2°C to +8°C and used within 24 hours. Experimental data show that the reconstituted vaccine could also be kept up to 24 hours at ambient temperature (25°C). If it is not used within 24 hours, do not administer the vaccine.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01</a>: Safe management of healthcare waste (Department of Health, 2013).</p>
<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of drug interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>

<p><b>Identification &amp; management of adverse reactions</b></p>	<p>Local reactions following vaccination are very common such as pain, swelling or redness at the injection site. A small painless nodule may form at the injection site.</p> <p>Mild side effects such as irritability, loss of appetite, drowsiness and slightly raised temperature commonly occur. Less commonly crying, diarrhoea, vomiting, atopic dermatitis, rash, malaise and fever over 39.5°C have been reported.</p> <p>Hypersensitivity reactions and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the vaccine's SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Reporting procedure of adverse reactions</b></p>	<p>Healthcare professionals and patients/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<p><b>Written information to be given to patient or carer</b></p>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Immunisations up to 13 months of age</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
<p><b>Patient advice / follow up treatment</b></p>	<p>Inform the individual/parent/carer of possible side effects and their management.</p> <p>The individual/parent/carer should be advised to seek medical advice in the event of an adverse reaction.</p> <p>When administration is postponed advise the individual/parent/carer when to return for vaccination.</p>
