## Pertussis Vaccine Patient Group Direction (PGD)

This PGD is for the administration of low dose diphtheria, tetanus, acellular pertussis and inactivated poliomyelitis vaccine (dTaP/IPV) to women from 16 weeks of pregnancy in accordance with the pertussis vaccination for pregnant women national immunisation programme and to contacts of pertussis, from 10 years of age, in accordance with PHE Guidelines for the Public Health Management of Pertussis in England and/or PHE Guidelines for the Public Health Management of Pertussis Incidents in Healthcare Settings.

This PGD is for the administration of dTaP/IPV by registered healthcare practitioners identified in [Section 3](#), subject to any limitations to authorisation detailed in [Section 2](#).

**Public Health England has developed this PGD to facilitate the delivery of publicly funded immunisation in line with national recommendations.**

Those using this PGD must ensure that it is organisationally authorised and signed in Section 2 by an appropriate authorising person, relating to the class of person by whom the product is to be supplied, in accordance with Human Medicines Regulations 2012 (HMR2012)<sup>1</sup>. **The PGD is not legal or valid without signed authorisation in accordance with [HMR2012 Schedule 16 Part 2](#).**

Authorising organisations must not alter, amend or add to the clinical content of this document (sections 4, 5 and 6); such action will invalidate the clinical sign-off with which it is provided. In addition authorising organisations must not alter section 3 'Characteristics of staff'. Only sections 2 and 7 can be amended within the designated editable fields provided.

Operation of this PGD is the responsibility of commissioners and service providers. The final authorised copy of this PGD should be kept by the authorising organisation completing Section 2 for 8 years after the PGD expires if the PGD relates to adults only and for 25 years after the PGD expires if the PGD relates to children only, or adults and children. Provider organisations adopting authorised versions of this PGD should also retain copies for the periods specified above.

<b>Continued training requirements</b>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and NHS Improvement and other sources of medicines information. Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<b>Clinical condition or situation to which this PGD applies</b>	Indicated for the immunisation of women from 16 weeks of pregnancy in accordance with the recommendations given in <a href="#">Chapter 24</a> of Immunisation Against Infectious Disease: 'The Green Book' and for the immunisation of contacts of pertussis, from 10 years of age, in accordance with <a href="#">Guidelines for the Public Health Management of Pertussis in England</a> or <a href="#">PHE Guidelines for the Public Health Management of Pertussis Incidents in Healthcare Settings</a>
<b>Criteria for inclusion</b>	<p>Pregnant women from 16 weeks<sup>2</sup> of pregnancy.</p> <p>Mothers with an infant less than 2 months of age who did not receive pertussis vaccination during their pregnancy.</p> <p>Contacts of pertussis, from 10 years of age, recommended pertussis vaccination in accordance with <a href="#">Guidelines for the Public Health Management of Pertussis in England</a> or <a href="#">PHE Guidelines for the Public Health Management of Pertussis Incidents in Healthcare Settings</a></p>
<b>Criteria for exclusion<sup>3</sup></b>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are less than 16 weeks pregnant (with the exception of post-exposure vaccination, at any stage of pregnancy, of contacts at risk of transmitting pertussis to 'vulnerable' individuals)</li> <li>• have had a confirmed anaphylactic reaction to a previous dose of diphtheria, tetanus, pertussis or poliomyelitis containing vaccine, including any conjugate vaccines where diphtheria or tetanus toxoid is used in the conjugate</li> <li>• have had a confirmed anaphylactic reaction to any component of the vaccine or residual products from manufacture, these may include formaldehyde, glutaraldehyde, streptomycin, neomycin, polymyxin and bovine serum albumin (refer to relevant SPC)</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<b>Cautions including any relevant action to be taken</b>	<p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. However, vaccination should proceed in accordance with the national recommendations.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>

<sup>3</sup> Exclusion under this PGD does not necessarily mean the medication is contraindicated, but it would be outside its remit and another form of authorisation will be required

<b>Action to be taken if the patient is excluded</b>	<p>If less than 16 weeks of pregnancy delay vaccination until indicated unless post-exposure vaccination is indicated in accordance with <a href="#">Guidelines for the Public Health Management of Pertussis in England</a> or <a href="#">PHE Guidelines for the Public Health Management of Pertussis Incidents in Healthcare Settings</a>.</p> <p>In case of postponement due to acute severe febrile illness, advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, the local Health Protection Team or the individual's clinician where appropriate.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>
<b>Action to be taken if the patient or carer declines treatment</b>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carers about the protective effects of the vaccine, the risks of infection and potential complications.</p> <p>Document advice given and the decision reached.</p> <p>Inform or refer to the GP or a prescriber as appropriate.</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	<p>Low dose diphtheria, tetanus, pertussis (acellular, component) and poliomyelitis (inactivated) vaccine (adsorbed), eg:</p> <ul style="list-style-type: none"> <li>Boostrix®-IPV, suspension for injection in pre-filled syringe (reduced antigen content), dTaP/IPV</li> <li>Repevax®, suspension for injection in pre-filled syringe (reduced antigen content), dTaP/IPV – see <a href="#">Supplies</a> section.</li> </ul>
<b>Legal category</b>	Prescription only medicine (POM)
<b>Black triangle▼</b>	No
<b>Off-label use</b>	<p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/patient/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route / method of administration</b>	<p>Administer by intramuscular injection, preferably into deltoid region of the upper arm.</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be given by deep subcutaneous injection to reduce the risk of bleeding (see 'The Green Book' <a href="#">Chapter 4</a>).</p> <p>The vaccine's normal appearance is a uniform cloudy, white suspension which may sediment during storage. Shake the prefilled syringe well to uniformly distribute the suspension before administering the vaccine.</p> <p>The vaccine should not be used if discoloured or foreign particles are present in the suspension.</p> <p>The vaccine's SPC provides further guidance on administration and is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Dose and frequency of administration</b>  Continued over page	<p>Single 0.5ml dose per administration</p> <p><b>Routine immunisation in pregnancy schedule</b></p> <p>A single dose of dTaP/IPV should ideally be administered between 16 weeks and 32 weeks of pregnancy to maximise the likelihood that the baby will be protected from birth. For operational reasons, vaccination is best offered on or after the fetal anomaly scan at around 20 weeks.</p>

<b>Dose and frequency of administration</b> continued	<p>Women may still be immunised after week 32 of pregnancy but this may not offer as high a level of passive protection to the baby. Vaccination late in pregnancy may, however, directly protect the mother against disease and thereby reduce the risk of exposure to her infant.</p> <p>This vaccine should be offered regardless of prior vaccination status. Vaccination is indicated in each pregnancy.</p> <p>For women who have not received the vaccine in pregnancy, pertussis-containing vaccine can be offered to mothers in the two months following birth, up until their child receives their first dose of pertussis containing vaccine, to reduce the risk of the mother contracting pertussis in the post-partum period and therefore prevent her from infecting her infant.</p> <p><b>Public health management of pertussis</b></p> <p>A single dose of dTaP/IPV should be administered to contacts recommended immunisation in accordance with <a href="#">Guidelines for the Public Health Management of Pertussis in England</a> or <a href="#">PHE Guidelines for the Public Health Management of Pertussis Incidents in Healthcare Settings</a> who have not received a dose of pertussis-containing vaccine in the last five years and no Td/IPV vaccine in the preceding month.</p> <p>A dTaP/IPV dose is recommended at any stage of pregnancy for pertussis contacts (in Group 2 b), c) or d))<sup>4</sup>, at increased risk of transmitting to 'vulnerable' individuals (in Group 1)<sup>5</sup>, who have not received a pertussis containing vaccine in the last five years, and who happen to be pregnant as well. Where such vaccination of pregnant contacts occurs before 16 weeks of pregnancy, a further dose of pertussis containing vaccine will be required after 16 weeks of pregnancy in accordance with the routine immunisation schedule and at least 4 weeks after the preceding dose.</p>
<b>Duration of treatment</b>	See dose section above
<b>Quantity to be supplied / administered</b>	Single 0.5ml dose per administration.
<b>Supplies</b>	<p>Centrally purchased vaccines for the national immunisation programme for pregnant women can only be ordered via ImmForm and are provided free of charge.</p> <p>Supplies for the vaccination of contacts of pertussis should be sourced directly from manufacturers/wholesalers. Where vaccine cannot be directly sourced from manufacturers/wholesalers, please contact the national immunisation team for further advice.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see Green Book <a href="#">Chapter 3</a>).</p>

<sup>4</sup> b) healthcare workers working with infants and pregnant women c) people whose work involves regular, close or prolonged contact with infants too young to be fully vaccinated d) people who share a household with an infant too young to be fully vaccinated

<sup>5</sup> Individuals at increased risk of severe complications ('vulnerable'): • unimmunised infants (born after 32 weeks) less than 2 months of age whose mothers did not receive pertussis vaccine after 16 weeks of pregnancy and at least 2 weeks prior to delivery • unimmunised infants (born < 32 weeks) less than 2 months of age regardless of maternal vaccine status • unimmunised and partially immunised infants (less than 3 doses of vaccine) aged 2 months and above regardless of maternal vaccine status

<b>Storage</b>	<p>Store at +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.</p> <p>Upon removal from the cold chain, Boostrix®-IPV is stable for 8 hours at 21°C.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01</a>: Safe management of healthcare waste (Department of Health, 2013).</p>
<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment. Vaccination is recommended for eligible individuals even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of drug interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Identification &amp; management of adverse reactions</b>	<p>Local reactions following vaccination are very common ie pain, swelling or redness at the injection site. A small painless nodule may form at the injection site. Injection site haematoma, pruritus, warmth and numbness have also been reported.</p> <p>Common adverse reactions include fever, headache, gastrointestinal disturbances (nausea, diarrhoea, vomiting, abdominal pain), arthralgia, myalgia, malaise, and fatigue/asthenia.</p> <p>Hypersensitivity reactions and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the SPC, at the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme at <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a> or search for MHRA Yellow Card in the Google Play or Apple App Store.</p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Pregnant? There are many ways to help protect you and your baby</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
