SWAST sets up new phone numbers of urgent ambulances

South Western Ambulance Service is introducing new telephone numbers for booking urgent A&E transport.

The new numbers go live on Wednesday 10 August. The old numbers will still be active but will only take you to a recorded message giving the new numbers to call.

BCG Vaccine Supply

Further to our earlier correspondence we are writing to remind practices of the current situation with regard to BCG Vaccine Supply. The current BCG vaccine held by provider expires on 31 August 2016 and there is a limited supply of this vaccine with some providers across the South West.

The recent addition of Vaccine Update Vaccine Update 247_June 2016_Special BCG (attached) describes plans for an alternative unlicensed BCG vaccine. Stock is still very limited and for that reason only areas with a large eligible population will be able to order initially. In the South West, only two providers in Bristol will be able to place orders for BCG vaccine for the time being.
