Administration of diphtheria, tetanus, acellular pertussis, inactivated poliomyelitis and *Haemophilus influenzae* type b conjugate vaccine (DTaP/IPV/Hib) to individuals from 3 years 4 months to under 10 years of age in accordance with the national immunisation programme for a pre-school booster of DTaP/IPV.

This PGD is for the administration of diphtheria, tetanus, acellular pertussis, inactivated poliomyelitis and *Haemophilus influenzae* type b conjugate vaccine (DTaP/IPV/Hib) by currently registered nurses or paramedics.



<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>This PGD supports the use of DTaP/IPV/Hib as an alternative to DTaP/IPV for the pre-school booster to utilise remaining national stocks of pentavalent vaccine following the introduction of hexavalent vaccine (DTaP/IPV/Hib/HepB) into the routine childhood immunisation schedule.</p> <p>Indicated for the active immunisation of individuals from 3 years 4 months to under 10 years of age for the prevention of diphtheria, tetanus, pertussis and poliomyelitis, in accordance with the national immunisation programme and recommendations given in <a href="#">Chapter 15</a>, <a href="#">Chapter 24</a>, <a href="#">Chapter 26</a> and <a href="#">Chapter 30</a> of Immunisation Against Infectious Disease: “The Green Book”.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals from 3 years 4 months to under 10 years of age who:</p> <ul style="list-style-type: none"> <li>• require a booster following a primary course of immunisation against diphtheria, tetanus, pertussis and poliomyelitis (this booster is usually offered from 3 years 4 months of age)</li> <li>• have a tetanus prone wound and tetanus boosters are not up to date or are due soon and convenient to give now (See “The Green Book” <a href="#">Chapter 30</a>)</li> </ul>
<p><b>Criteria for exclusion<sup>2</sup></b></p>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are less than 3 years 4 months of age</li> <li>• are aged 10 years and over</li> <li>• have had a confirmed anaphylactic reaction to a previous dose of diphtheria, tetanus, pertussis, poliomyelitis or <i>Haemophilus influenzae</i> type b containing vaccine, including any conjugate vaccines where diphtheria or tetanus toxoid is used in the conjugate</li> <li>• have had a confirmed anaphylactic reaction to any component of the vaccine or residual products from manufacture, these may include neomycin, polymyxin, polysorbate 80, streptomycin, glutaraldehyde, formaldehyde and bovine serum albumin (refer to relevant SPC)</li> <li>• have not yet completed primary immunisation with three doses of diphtheria, tetanus, pertussis and poliomyelitis antigen</li> <li>• received a dose of diphtheria, tetanus, pertussis and poliomyelitis containing vaccine within the last 12 months</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p> <p>Continued over page</p>	<p>The presence of a neurological condition is not a contraindication to immunisation but if there is evidence of current neurological deterioration, deferral of vaccination may be considered, to avoid incorrect attribution of any change in the underlying condition. The risk of such deferral should be balanced against the risk of the preventable infection, and vaccination should be promptly given once the diagnosis and/or the expected course of the condition becomes clear.</p>

<p><b>Cautions including any relevant action to be taken</b> (continued)</p>	<p>If a child has experienced encephalopathy or encephalitis within seven days of immunisation, it is unlikely that these conditions will have been caused by the vaccine and they should be investigated by a specialist. If a cause is identified or the child recovered within seven days, immunisation should proceed as recommended. In children where no underlying cause was found and the child did not recover completely within seven days, immunisation should be deferred until the condition has stabilized or the expected course of the condition becomes clear.</p> <p>If a seizure associated with a fever occurred within 72 hours of a previous immunisation with pertussis containing vaccine, immunisation should continue as recommended if a cause is identified or the child recovers within 24 hours. However, if no underlying cause has been found and the child did not recover completely within 24 hours, further immunisation should be deferred until the condition is stable.</p> <p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. Vaccination should proceed in accordance with the national recommendations. However, re-immunisation may need to be considered. Seek medical advice as appropriate.</p>
<p><b>Action to be taken if the patient is excluded</b></p>	<p>If the individual is aged less than 3 years 4 months assess for immunisation with DTaP/IPV/Hib/HepB or DTaP/IPV/Hib (see DTaP/IPV/Hib/HepB PGD and DTaP/IPV/Hib PGD for the primary immunisation series).</p> <p>If the individual is aged 10 years or over assess for immunisation with Td/IPV as required.</p> <p>If the individual has not yet completed primary immunisation with three doses of diphtheria, tetanus, pertussis and poliomyelitis antigen provide priming doses of DTaP/IPV/Hib/HepB, DTaP/IPV/Hib or DTaP/IPV as required. Note: this is outside the remit of this PGD.</p> <p>If a dose of diphtheria, tetanus, pertussis and poliomyelitis containing vaccine has been received within the last 12 months, defer immunisation until appropriate interval.</p> <p>In case of postponement due to acute severe febrile illness, advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required rather than delay immunisation.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document reason for exclusion and any action taken in the individual's clinical records.</p> <p>In a GP practice setting, inform or refer to the GP or prescriber as appropriate.</p>

<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications of disease.</p> <p>Document advice given and the decision reached.</p> <p>In a GP practice setting, inform or refer to the GP as appropriate.</p>

## 5. Description of treatment

<b>Name, strength &amp; formulation of drug</b>	<p>Diphtheria, tetanus, pertussis (acellular, component), poliomyelitis (inactivated) and <i>Haemophilus influenzae</i> type b conjugate vaccine (adsorbed), DTaP/IPV/Hib, eg:</p> <ul style="list-style-type: none"> <li>• Infanrix<sup>®</sup>-IPV+Hib, powder (Hib) in vial and suspension (DTaP/IPV) for suspension for injection in pre-filled syringe</li> <li>• Pediacel<sup>®</sup>, suspension for injection in pre-filled syringe</li> </ul>
<b>Legal category</b>	<p>Prescription only medicine (POM)</p>
<b>Black triangle ▼</b>	<p>No</p>
<b>Off-label use</b>	<p>Administration of Infanrix<sup>®</sup>-IPV+Hib to individuals over 3 years of age and Pediacel<sup>®</sup> to individuals aged 4 years and over is off-label but is indicated until 10 years of age under this PGD in accordance with PHE recommendations for the <a href="#">vaccination of individuals with uncertain or incomplete immunisation status</a>, the relevant chapters of “<a href="#">The Green Book</a>” and <a href="#">The hexavalent DTaP/IPV/Hib/HepB combination vaccine information for healthcare professionals</a>.</p> <p>Administration of DTaP/IPV/Hib to individuals who experienced an encephalopathy of unknown cause occurring within 7 days following previous vaccination with pertussis containing vaccine is off-label. Individuals may be vaccinated under this PGD once the condition has stabilized or the expected course of the condition becomes clear (see <a href="#">Cautions</a>), in line with the recommendations in the associated chapters of “<a href="#">The Green Book</a>”.</p> <p>Administration by deep subcutaneous injection to patients with a bleeding disorder is off-label administration in line with advice in <a href="#">Chapter 4</a> of “<a href="#">The Green Book</a>”.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<b>Route / method of administration</b>  Continued over page	<p>Some vaccine products (eg Infanrix<sup>®</sup>-IPV+Hib) must be reconstituted in accordance with the manufacturers’ instructions prior to administration.</p> <p>Administer by intramuscular injection, preferably into deltoid region of the upper arm.</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual’s records.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an intramuscular route should be given by deep subcutaneous injection to reduce the risk of bleeding (see “<a href="#">The Green Book</a>” <a href="#">Chapter 4</a>).</p> <p>The vaccine's normal appearance is a uniform cloudy, white suspension which may sediment during storage. Shake the prefilled syringe well to uniformly distribute the suspension prior to</p>

<b>Route / method of administration</b> (continued)	reconstitution (if applicable) and before administering the vaccine. The vaccine should be inspected prior to and after any required reconstitution and should not be used if discoloured or foreign particles are present. The vaccine's SPC provides further guidance on administration and is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a>
<b>Dose and frequency of administration</b>	Single 0.5ml dose per administration <b>Routine Childhood Immunisation Schedule</b> Diphtheria, tetanus, pertussis and polio containing vaccine should ideally be given three years after completion of the primary course of diphtheria, tetanus, pertussis and polio vaccination as the first booster dose and is recommended as a pre-school vaccine at around 3 years and 4 months of age though it may be used until 10 years of age. When primary vaccination has been delayed, this first booster dose may be given at the scheduled visit provided it is at least 12 months since the last primary dose was administered. Where children have had a fourth dose of tetanus, diphtheria and polio containing vaccine at around 18 months of age, this dose should be discounted as it may not provide satisfactory protection until the time of the teenage booster. The routine pre-school and subsequent boosters should be given according to the UK schedule. <b>Management of tetanus prone wound</b> Individuals with incomplete or uncertain history of tetanus immunisation should be vaccinated in accordance with the recommendations in the "The Green Book" <a href="#">Chapter 30</a> Table 30.1. Individuals may also require human tetanus immunoglobulin (see "The Green Book" <a href="#">Chapter 30</a> ).
<b>Duration of treatment</b>	<b>Routine Immunisation</b> A single dose as pre-school booster. See other PGDs for primary immunisation (DTaP/IPV/Hib/HepB or DTaP/IPV/Hib) and subsequent boosters (Td/IPV) to complete immunisation in accordance with national recommendations.
<b>Quantity to be supplied / administered</b>	Single 0.5ml dose per administration.
<b>Supplies</b>	Centrally purchased vaccines for the national immunisation programme for the NHS can only be ordered via ImmForm. Vaccines for use for the national immunisation programme are provided free of charge. Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see <a href="#">protocol for ordering storage and handling of vaccines</a> and Green Book <a href="#">Chapter 3</a> ).
<b>Storage</b>	Store at +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.

<b>Disposal</b>	Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of at the end of a session by sealing in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01</a> : Safe management of healthcare waste (Department of Health, 2013).
<b>Drug interactions</b>	<p>Immunological response may be diminished in those receiving immunosuppressive treatment.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of drug interactions is available in the SPC, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Identification &amp; management of adverse reactions</b>	<p>Local reactions following vaccination are very common ie pain, swelling or redness at the injection site. A small painless nodule may form at the injection site.</p> <p>Common adverse reactions include fever, abnormal crying, irritability, restlessness, diarrhoea, vomiting, appetite loss, somnolence, decreased activity and injection site bruising.</p> <p>Hypersensitivity reactions, such as bronchospasm, angioedema, urticaria, and anaphylaxis can occur but are very rare.</p> <p>A detailed list of adverse reactions is available in the vaccine's Summary of Product Characteristics, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Reporting procedure of adverse reactions</b>	<p>As with all vaccines, healthcare professionals and patients/parents/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme on: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to a vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Pre-school immunisations: guide to vaccinations (2 to 5 years)</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
<b>Patient advice / follow up treatment</b>	<p>Inform the individual/carer of possible side effects and their management.</p> <p>The individual/carer should be advised to seek medical advice in the event of an adverse reaction.</p> <p>When administration is postponed advise the individual/carer when to return for vaccination.</p>
<b>Special considerations / additional information</b>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>Minor illnesses without fever or systemic upset are not valid reasons to postpone immunisation. If an individual is acutely unwell,</p>

<p><b>Special considerations / additional information</b> (continued)</p>	<p>immunisation may be postponed until they have fully recovered.</p> <p>Tetanus vaccine given at the time of a tetanus-prone injury may not boost immunity early enough to give additional protection within the incubation period of tetanus. Therefore, tetanus vaccine is not considered adequate for treating a tetanus-prone wound. However, this provides an opportunity to ensure that the individual is protected against future exposure. Individuals may also require human tetanus immunoglobulin (see “The Green Book” <a href="#">Chapter 30</a>).</p> <p>If a person has received vaccination for a tetanus-prone wound with the same vaccine as due for routine immunisation or booster and was administered at an appropriate interval then the routine booster dose is not required, refer to advice in “The Green Book” <a href="#">Chapter 30</a>.</p>
<p><b>Records</b></p>	<p>Record:</p> <ul style="list-style-type: none"> <li>• that valid informed consent was given</li> <li>• name of individual, address, date of birth and GP with whom the individual is registered</li> <li>• name of immuniser</li> <li>• name and brand of vaccine</li> <li>• date of administration</li> <li>• dose, form and route of administration of vaccine</li> <li>• quantity administered</li> <li>• batch number and expiry date</li> <li>• anatomical site of vaccination</li> <li>• advice given, including advice given if excluded or declines immunisation</li> <li>• details of any adverse drug reactions and actions taken</li> <li>• supplied via Patient Group Direction (PGD)</li> </ul> <p>Records should be signed and dated (or a password controlled immuniser’s record on e-records).</p> <p>All records should be clear, legible and contemporaneous.</p> <p>This information should be recorded in the individual’s GP record. Where vaccine is administered outside the GP setting appropriate health records should be kept and the individual’s GP informed.</p> <p>The local Child Health Information Systems team (Child Health Records Department) must be notified using the appropriate documentation/pathway when vaccine is administered to individuals under 19 years of age.</p> <p>A record of all individuals receiving treatment under this PGD should also be kept for audit purposes in accordance with local policy.</p>
