Delay in the distribution of Agrippal Inactivated Influenza vaccine

Public Health England has been informed by Seqirus that there will be a delay in distributing its Agrippal inactivated influenza vaccine. The delay is from week commencing 19th September 2016 to week commencing 10th October 2016. Seqirus will be writing to you directly if you are a customer affected by this delay.

Vaccination of practice staff with MMR

The recent update on the measles outbreak currently affecting the south west emphasised that the protection of practice staff is especially important in the context of their ability to transmit measles, mumps or rubella infections to vulnerable groups, as well as for their own benefit. NHS England has agreed that in response to the current outbreak all practice staff can be immunised in their practice of employment. To further clarify this arrangement:

• There is no specific national guidance that covers the vaccination of staff, but in these circumstances practices can apply the guidance on pages 37 to 39 of the document 'vaccination and immunisation programmes 2016/17 guidance and audit requirements' to their staff. - Individuals born before 1970 are likely to have had all three natural infections and are less likely to be susceptible (see Green Book for Guidance). However, to ensure the protection of GP practice staff and their patients during the outbreak any member of staff should be offered vaccination of MMR regardless of their age unless they have current evidence of immunity (previous immunisation with two doses of MMR or documented positive IgG antibodies on serological testing to measles and rubella). A manually claimed payment of £9.80 per dose will apply to all staff as per the guidance above.
- There is no requirement for antibody testing. Routine immunity testing is not currently available for primary care staff; MMR will provide more rapid protection and is safe to give to someone who may already be immune. The risks of harm arising from acquiring measles infection are far higher than from a vaccination.
- NHS England has agreed that as a time limited outbreak control measure, practices can classify their employed staff as requiring immediately necessary treatment and use national supplies of MMR vaccine.
- The employing practice will supply the staff member with confirmation of the vaccine being given to enable them deliver it to their practice to update their notes.
- Refusal of immunisation should be documented.

These measures are in place from 1 August 2016 to 31 December 2016 and will be reviewed at this time in line with epidemiological data. Practices will be updated at this time to clarify arrangements in 2017.
