#### **Response to measles outbreak in Devon – Devon Practices only**

You will be aware there has been an increase in cases of measles across the south west during 2016. In particular there has been a community outbreak in the south Devon area. In response to this we are offering a locally commissioned service to practices in Devon in order to help reduce the spread of measles within the local community. The specific details can be found in the attached document - locally commissioned service in a response to a measles outbreak. Some services (part one in the attached) are only applicable to the listed practices in areas with the highest incidence of measles. This will reviewed in line with the epidemiology of the outbreak. The services listed in part two - service elements commissioned from practices outside the outbreak area, are applicable to all practices in Devon.
