

<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies.

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals, detailed in the inclusion criteria, against <i>Neisseria meningitidis</i> group A, C, W and Y in accordance with the recommendations given in <a href="#">Chapter 22</a> of Immunisation Against Infectious Disease: 'The Green Book' and <a href="#">Guidance for Public Health Management of Meningococcal Disease in the UK</a>.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals who are:</p> <ul style="list-style-type: none"> <li>• eligible for routine MenACWY immunisation, that is the whole birth cohort in school year 9 and/or 10 as per national recommendations and local delivery of concurrent adolescent immunisations including Td/IPV</li> <li>• eligible for routine MenACWY conjugate vaccine, born on or after 1 Sep 1996 and until their 25th birthday, who have missed the routine vaccination offer in year 9 or year 10, and have unknown or incomplete MenACWY vaccination history (Note: this includes individuals in catch-up cohorts)</li> <li>• aged 10 years to less than 25 years with an incomplete or unknown MenC vaccination history</li> <li>• prospective students up to 25 years of age who are entering university for the first time and who have not received a dose of MenACWY conjugate vaccine after their tenth birthday Note: Vaccination should be offered before they enrol or as soon as possible thereafter, ideally at least two weeks before attending university to ensure timely protection.</li> <li>• a close contact of a confirmed case of <i>Neisseria meningitidis</i> group A, C, W or Y disease</li> <li>• in a cohort recommended MenACWY immunisation following a local outbreak of <i>Neisseria meningitidis</i> and specific advice from Public Health England and the local Health Protection Team</li> </ul> <p>Note: Individuals with an underlying medical condition which puts them at increased risk from <i>Neisseria meningitidis</i>, such as individuals with asplenia, splenic dysfunction or complement disorders (including those on, or due to receive, complement inhibitor treatment such as eculizumab), may require additional 'routine' vaccination outside the inclusion criteria for this PGD - see MenACWY Risk Groups PGD and <a href="#">Chapter 7</a> of 'The Green Book'.</p>
<p><b>Criteria for exclusion<sup>2</sup></b></p> <p>Continued over page</p>	<p>Individuals for whom no valid consent has been received.</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• have had a confirmed anaphylactic reaction to a previous dose of the vaccine</li> <li>• have had a confirmed anaphylactic reaction to any constituent or excipient of the vaccine, including diphtheria toxoid, CRM 197 carrier protein (Menveo<sup>®</sup>), tetanus toxoid (Nimenrix<sup>®</sup>)</li> <li>• have previously received MenACWY conjugate vaccine when over 10 years old, with the exception of contacts of confirmed <i>Neisseria meningitidis</i> group A, C, W or Y infection</li> <li>• require vaccination for occupational health reasons, such as</li> </ul>

<sup>2</sup> Exclusion under this PGD does not necessarily mean the medication is contraindicated, but it would be outside its remit and another form of authorisation will be required.

<b>Criteria for exclusion</b> (continued)	laboratory workers working with meningococci <ul style="list-style-type: none"> <li>• require vaccination for the purpose of travel</li> <li>• are suffering from acute severe febrile illness (the presence of a minor illness without fever or systemic upset is not a contraindication for immunisation)</li> </ul>
<b>Cautions including any relevant action to be taken</b>	<p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. Vaccination should proceed. However, re-immunisation may need to be considered.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>
<b>Action to be taken if the patient is excluded</b>	<p>Individuals who have received MenACWY conjugate vaccine over the age of 10 years do not routinely require further MenACWY immunisation with the exception of contacts of confirmed <i>Neisseria meningitidis</i> group A, C, W or Y infection. Contacts should be offered an appropriate meningococcal sero-group containing vaccine if not received in the preceding 12 months.</p> <p>Individuals requiring vaccination for occupational health reasons, such as laboratory workers working with meningococci, should be referred to their occupational health service provider for vaccination.</p> <p>Individuals requiring vaccination solely for the purpose of travel are not covered by this PGD and should be referred to, or immunised as part of, a travel immunisation service. MenACWY vaccine is not available on the NHS for the purpose of travel.</p> <p>In case of postponement due to acute severe febrile illness advise when the individual may be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document reason for exclusion and any action taken in individual's clinical records.</p> <p>In a GP practice setting, inform or refer to the GP or prescriber as appropriate.</p>
<b>Action to be taken if the patient or carer declines treatment</b>	<p>Informed consent, from the individual or a person legally able to act on the individual's behalf, must be obtained for each administration.</p> <p>Advise individual/parent/carers about the protective effects of the vaccine, the risks of infection and potential complications of disease.</p> <p>Document advice given and the decision reached.</p> <p>In a GP practice setting, inform or refer to the GP as appropriate.</p>

## 5. Description of Treatment

<p><b>Name, strength &amp; formulation of drug</b></p>	<p><b>Menveo®</b>, 0.5ml reconstituted vaccine solution containing:</p> <p>Originally contained in powder vial:  Meningococcal group A oligosaccharide<sup>1</sup> 10micrograms</p> <p>Originally contained in the solution vial:  Meningococcal group C oligosaccharide<sup>1</sup> 5 micrograms  Meningococcal group W135 oligosaccharide<sup>1</sup> 5 micrograms  Meningococcal group Y oligosaccharide<sup>1</sup> 5 micrograms  <sup>1</sup>conjugated to <i>Corynebacterium diphtheriae</i> CRM<sub>197</sub> protein</p> <p>Or</p> <p><b>Nimenrix®</b>, 0.5ml reconstituted vaccine solution containing:</p> <p>Originally in powder:  <i>Neisseria meningitidis</i> A polysaccharide<sup>2</sup> 5 micrograms  <i>Neisseria meningitidis</i> C polysaccharide<sup>2</sup> 5 micrograms  <i>Neisseria meningitidis</i> W135 polysaccharide<sup>2</sup> 5 micrograms  <i>Neisseria meningitidis</i> Y polysaccharide<sup>2</sup> 5 micrograms  <sup>2</sup> conjugated to tetanus toxoid carrier protein 44 micrograms  Solvent for solution for injection in pre-filled syringe</p>
<p><b>Legal category</b></p>	<p>Prescription Only Medicine (POM).</p>
<p><b>Black Triangle▼</b></p>	<p>No</p>
<p><b>Off-label use</b></p>	<p>Administration by deep subcutaneous injection to individuals with a bleeding disorder is off-label administration in line with advice in <a href="#">Chapter 4</a> of 'The Green Book'.</p> <p>Menveo® is off-label for children under 2 years of age. Nimenrix® is licensed from 6 weeks of age for a schedule with a two month interval between doses, but a one-month interval is in accordance with the advice in <a href="#">Chapter 22</a> of 'The Green Book'. Either vaccine is recommended in accordance with the advice in <a href="#">Chapter 22</a> of 'The Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<p><b>Route / method of administration</b></p> <p>Continued over page</p>	<p>The MenACWY vaccines must be reconstituted in accordance with the manufacturers' instructions prior to administration.</p> <p>Following reconstitution, MenACWY conjugate vaccine should be given as a single 0.5ml dose by intramuscular injection, preferably in the deltoid region of the upper arm. The anterolateral aspect of the thigh is the preferred site for infants under one year old.</p>



<p><b>Route / method of administration</b> (continued)</p>	<p>The MenACWY conjugate vaccines must not be given intravascularly or intradermally.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an IM route should be given by deep subcutaneous injection to reduce the risk of bleeding (see 'The Green Book' <a href="#">Chapter 4</a>).</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>The vaccine should be inspected visually for any foreign particulate matter and/or variation of physical aspect before reconstitution and following reconstitution prior to administration. In the event of either being observed, discard the vaccine.</p> <p>It is recommended that the vaccine be administered immediately after reconstitution, to minimize loss of potency. Discard reconstituted vaccine if it is not used within 8 hours (see <a href="#">storage</a> section).</p> <p>The SPCs for Menveo® and Nimenrix® provide further guidance on reconstitution and administration and are available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Dose and frequency of administration</b></p>	<p><b>Aged 12 months and over</b> Single 0.5ml dose of either Menveo® or Nimenrix® vaccine.</p> <p>Note: Unless they are confirmed to have been immunised against the relevant meningococcal sero-group within the preceding 12 months, vaccination should be offered to close contacts of any age.</p> <p><b>Contacts aged under 12 months</b> Two 0.5ml doses administered at least 4 weeks apart (see <a href="#">Off-label</a> section)</p>
<p><b>Duration of treatment</b></p>	<p>Single dose of 0.5ml (repeated at least 4 weeks later in children under 12 months of age).</p>
<p><b>Quantity to be supplied / administered</b></p>	<p>Single dose of 0.5ml.</p>
<p><b>Supplies</b></p>	<p>Centrally purchased vaccines for the national immunisation programme for the NHS can only be ordered via ImmForm. Vaccines for the national immunisation programme are provided free of charge.</p> <p>Vaccine for the national immunisation programme should not be used for the vaccination of contacts of confirmed cases and in outbreaks of MenACWY infection. Vaccine should be ordered from the manufacturers/wholesalers.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see <a href="#">protocol for ordering storage and handling of vaccines</a> and Green Book <a href="#">Chapter 3</a>).</p>
<p><b>Storage</b>  Continued over page</p>	<p>Store between +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.</p>

<b>Storage</b> (continued)	<p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p> <p>After reconstitution, the vaccine should be used immediately. However, stability after reconstitution has been demonstrated for 8 hours below 25°C (below 30°C for Nimenrix®). Discard any reconstituted vaccine not used within 8 hours.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or syringes, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01</a>: Safe management of healthcare waste (Department of Health, 2013).</p>
<b>Drug Interactions</b>	<p>Immunological response may be diminished in individuals receiving immunosuppressant treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p> <p>A detailed list of interactions associated with Menveo® or Nimenrix® is available in the SPC for the vaccine, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Identification &amp; Management of Adverse Reactions</b>	<p><b>Menveo®</b></p> <p>The most common adverse reactions observed after administration of Menveo® vaccine are drowsiness, malaise, headache, nausea, irritability and injection site pain, erythema and induration. Fever, chills, nausea, vomiting, diarrhoea, eating disorders, myalgia, arthralgia and rash are also listed as common side effects.</p> <p><b>Nimenrix®</b></p> <p>The most common adverse reactions observed after administration of Nimenrix® vaccine are drowsiness, fatigue, headache, loss of appetite, irritability, fever and injection site pain, erythema and induration.</p> <p>Gastro-intestinal symptoms (including nausea, vomiting and diarrhoea) and injection site haematoma are also listed as common side effects.</p> <p>A detailed list of adverse reactions associated with Menveo® or Nimenrix® is available in the SPC for the vaccine, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<b>Reporting procedure of Adverse Reactions</b>	<p>Healthcare professionals and individuals/parents/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme on: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to the vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to patient or carer</b> Continued over page	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate.</p>

<p><b>Written information to be given to patient or carer</b> (continued)</p>	<p>For parents of 'contact' children under 12 months:</p> <ul style="list-style-type: none"> <li>• <a href="#">Why is my child being offered an 'off-label' vaccine.</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
<p><b>Patient advice /Follow up treatment</b></p>	<p>Menveo® or Nimenrix® will only confer protection against <i>Neisseria meningitidis</i> group A, C, W and Y. The vaccine will not protect against any other <i>Neisseria meningitidis</i> groups. There is no evidence of risk from vaccinating pregnant women or those who are breast-feeding with inactivated virus or bacterial vaccines or toxoids.</p>
