#### CPCF settlement: 2019/20 to 2023/24

In brief, the settlement consists of the following main elements:

**Funding for the Community Pharmacy Contractual Framework (CPCF):** £2.592bn per year for 2019/20, and for subsequent years until the end of 2023/24.

#### NHS Community Pharmacist Consultation Service (CPCS):

a new Advanced service where patients are referred into community pharmacy by other NHS providers. Commencing October 2019, this service replaces the current NHS Urgent Medicine Supply Advanced Service (NUMSAS) and local pilots of the Digital Minor Illness Referral Service (DMIRS).

**Pharmacy Quality Scheme (PQS):** a new name for the Quality Payments Scheme. The gateway and quality criteria from previous years will change on an annual basis, with some becoming CPCF Terms of Service requirements from April 2020.

#### Help prepare/get ahead...

The Centre for Pharmacy Postgraduate Education (CPPE) has published their four main learning and e-assessments linked to the 2019/20 Pharmacy

Quality Scheme (PQS). Contractors are therefore encouraged to make a start on completing the learning and e-assessments as the next step for participating in PQS.

### Supply of Denosumab (Prolia) in primary care...

Pharmacies in ALL areas of the South West are asked to note that delivery and wholesale charges can be avoided by ordering Prolia direct from Movianto (see the information <u>HERE</u>) and so you should consider using this ordering route. As it is possible to obtain Prolia without such charges, we would not expect pharmacies to be claiming Out of Pocket Expenses when submitting a prescription for Prolia.

# Patient Safety Incident Process...

When an incident is reported to NHS England the pharmacy concerned are contacted via an email, to their nhs.net generic store account, to request that a SEA (Significant Event Audit form) be completed and returned accordingly to the <u>pharmacy mailbox</u> within 7 days of the request.

Where no response is received a second email will be sent to the stores generic nhs.net email account, again asking for the information to be returned within 7 days. If then no response is received (to this second email), NHS England will send a dispute resolution letter to the contractor, by post and email, requesting the information be returned within 14 days. Where no response to this request is received a remedial notice will then be issued giving 30 days for the information to be submitted.

This process will also apply whereby the SEA has been submitted but further information has been requested by NHS England. An initial request and follow-up email will be sent, if the information is not received at the first request. This will be followed by a dispute resolution letter and remedial notice, if the information is still outstanding.

### Mandatory Public Health Campaigns: Resources...

As all Contractors will be aware, we have Antimicrobial Resistance and Stoptober coming up in September and October respectively.

For efficiency, materials for both campaigns are being delivered to all community pharmacies together in the same clearly marked envelope.

An activation guide will be included in the pack with further information on both the campaigns. Social media and digital resources for these campaigns will be available on PHE's <u>Campaign Resource</u> <u>Centre</u> closer to the campaign launches and it would be great if pharmacies use these to support the campaigns where possible.

### NUMSAS/DMIRS Deregistration's...

With the introduction of the Community Pharmacist Consultation Service (CPCS) and as preparation commences to facilitate registration and payment for CPCS we have instructed NHSBSA to close the existing NUMSAS and DMIRs pilots to new registrations via their online portal. CPCS registration details will be available soon!

If a contractor wishes to de-register from NUMSAS or DMIRs now the NHSBSA portal has been closed off, you will need to notify us directly that you are giving notice to withdraw (remember you must give 1-month notice, you cannot just cease the service with immediate effect). You will then need to advise your local DOS lead so they can stop the pharmacy getting further referrals to the relevant service. Please remember to submit any outstanding activity claims as quickly as possible so that final payments can be made against the service.

### <u>Community Pharmacy Contractual Framework: 2019 to 2024: Supporting</u> <u>Delivery for the NHS Long Term Plan...</u>

The new contractual arrangements will come into force from 1 October 2019 and will help to deliver the ambitions set out in the <u>NHS Long Term Plan</u>.

This agreement is between the government, the NHS and the Pharmaceutical Services Negotiating Committee (PSNC).

The PSNC is releasing a series of recommended actions for contractors to help community pharmacy teams to understand the details of the CPCF agreement as the details are finalised. ...this week it is recommended...

...to register for the NHS Business Services Authority (NHSBSA) Manage Your Service (MYS) application as the first step for participating participating in the <u>Pharmacy Quality Scheme</u> (PQS) 2019/20. MYS will be the only way to claim a PQS <u>Aspiration payment</u> and make a PQS declaration. The system will also be the route for claiming payment for the Flu Vaccination Service 2019/20 and notifying readiness to provide the new <u>Community Pharmacist</u> <u>Consultation Service (CPCS)</u>.

### Licensed Melatonin liquid...

We would like to draw to the attention of colleagues working in community pharmacy that the new licensed formulation of melatonin 1mg/ml oral solution, according to the terms of its license "should not be used in children and adolescents aged 0 - 18 years due to safety concerns."

For this reason, many prescribers who are aware of the licensed formulation are intentionally choosing to instead prescribe special order products by brand - such as 'Kidnaps' or 'Kidmel' when prescribing for children. If you see a prescription for these products and are unsure how to source them, please do refer to your SOPs and check with the relevant contacts at your company. You can then claim reimbursement and remuneration for unlicensed special-order products along with any associated charges in the usual way.

### Supply Issues:

Nardil (phenelzine Sulphate) (MAOI) 15mg tablets:

- Kyowa Kirin, the sole supplier of Nardil (phenelzine sulfate) 15mg tablets in the UK, have informed the Department of Health and Social Care that due to manufacturing delays, Nardil will be out of stock from the beginning of August until at least the end of October 2019.
- DHSC have contacted specialist importer companies, who have advised that unlicensed imports can be sourced from abroad.
- UK Medicine Information have also published guidance on management including the need for specialist referral to mental health teams if unlicensed supplies of phenelzine sulfate 15mg tablets are deemed unsuitable: <u>https://www.sps.nhs.uk/articles/shortage-of-phenelzine-15mg-tablets-nardil/</u>

### Methadone (Physeptone) 5mg tablet...

- Ethylpharm are currently out of stock. Further stock is expected by the end of August 2019.
- During this time unlicensed methadone 5mg capsules are being manufactured and can be ordered directly from Ethlypharm. The product code is **P034663** Methadone Capsules 5mg 50 [CD]. Please allow 1-2 days delivery for the unlicensed.

# Primary Care Networks (PCN's)...

Primary Care Networks (PCNs) are a key part of the <u>NHS Long Term</u> <u>Plan</u>, with all general practices being required to be in a network by June 2019, and <u>Clinical Commissioning Groups (CCGs)</u> being required to commit recurrent funding to develop and maintain them.

The networks will have expanded neighbourhood teams which will comprise a range of staff such as GPs, pharmacists, district nurses, community geriatricians, dementia workers and Allied Health Professionals such as physiotherapists & podiatrists/chiropodists, joined by social care and the voluntary sector'.

Under the plans, all general practices will be aligned to a PCN, covering 30,000-50,000 patients, with local Enhanced services funded by CCGs and provided through the <u>new network contracts</u>. The networks will provide the structure and funding for services to be developed locally, in response to the needs of the patients they serve. It is important that community pharmacy teams are fully involved in the work of their PCN.

# <u>CORNWALL: Community Pharmacy Emergency Supply</u> <u>Service - Summer Holiday In-Hours Extension...</u>

During this time, pharmacists working in participating pharmacies will be able to supply a sufficient quantity of medication to Cornish residents (up to five days treatment) and to visitors to the area, (up to 14 days treatment) both in and out of hours. The Emergency Supply Service (in-hours and out-of-hours) is only available for UK registered patients.
