About this bulletin

The NHS England and NHS Improvement (NHSE/I) South West Integrated Public Health Team has taken over responsibility from the NHSE/I South West Primary Care Team for collating and issuing a rebranded, weekly Public Health GP Bulletin. This weekly bulletin is the main method of communicating with practice managers covering the 579 practices in Bristol, North Somerset, South Gloucestershire, Bath & North East Somerset, Swindon, Wiltshire, Gloucestershire, Somerset, Devon, Dorset, Cornwall and the Isles of Scilly.

The bulletins contain important public health information for practice managers on Section 7a screening and immunisation programmes, which are commissioned by NHSE/I. Content may include requests for information and deadlines affecting payments, as well as updates on issues relating to GP contracts.

CQRS NOTIFICATION – REMINDER NOTICE OF CQRS DOWNTIME 18 TO 22 SEPTEMBER INCLUSIVE AND ACTION REQUIRED FOR CQRS LOG IN

Please be aware that from Friday 18 September to the evening of the 22 September inclusive, CQRS will be offline due to system enhancements including the transition to cloud hosting. During this period, you will not be able to access CQRS for any purpose.

Data for August activity was collected between the 1-8 September and the current deadlines for practices to declare Public Health Services remains unchanged.

Signing in to CQRS from Wednesday 23 September

Once the system enhancements to CQRS have been completed, from Wednesday 23 September you will be asked to log in to CQRS via single sign-on using your NHSmail "@nhs.net" email address as given in the attached guidance.

This enhancement of moving to the cloud and introducing multi factor authentication (MFA) will introduce a better user experience. Users will be able to access CQRS via the internet from any machine rather than solely those on N3/HSCN, and MFA will provide the level of security needed to meet national cyber security strategy obligations using an established and trusted strategic solution. NHSmail is the best option in terms of coverage and will provide the best user experience of all the options that were considered. Other key benefits you will notice are fewer usernames and passwords to remember and the ability to reset passwords via NHSmail rather than having to contact the service desk.

It's also important to note that this change only affects how you login to CQRS. Your profile and permissions will remain the same and all other functions, for example offering services, viewing achievement, approving payments and granting user access will also remain the same.

Action required by CQRS users without an NHSmail account

- 1. CQRS users who do not have an NHSmail account should continue to sign in using their username and password until further guidance is released.
- 2. On first login on or after Wednesday 23 September, users may be prompted to call the CQRS service desk.
- 3. Once this guidance is available, we will issue a comms directly to the relevant users.

Action required by CQRS users with an NHSmail account

- 1. All CQRS users are asked to check their CQRS account to ensure that the correct email address is associated with their account.
- 2. If your email address does not match the email address associated with your account, you will be unable to login to CQRS on Wednesday 23 September.
- 3. If your email addresses do not match, please contact your commissioner, regional office or CQRS administrator to request a new account be set up using your correct email address.
- If your CQRS account is set up with a "@nhs.uk" email address but you have an additional NHSmail account, follow the steps in 3. and request a new account be set up using your NHSmail email address.

To note

 Please be aware that you cannot amend the email address for an existing account in CQRS

- The historical activity on your account, for example participation offers and approvals that you have made, will not be deleted from the system - provided you have the same permissions applied to your new account, you will be able to view this activity
- The same activity will remain viewable to other users in your organisation with the relevant permissions

CQRS will also issue these instructions directly to active CQRS users using the NHSmail email address registered in the system.

Breast screening programme update: pause of self-referrals

A reminder to practices that **self-referrals for breast screening from women aged 71 or over are currently paused**. This is to support services in prioritising high risk patients or those that need follow up tests and treatment: this will be kept under close review To support this change please you check if you have any promotional materials on display (e.g. posters/leaflets) and remove any which refer to self-referrals for breast screening.

Why are women aged 71 not able to self-refer at the moment?

The immediate priority for the programme is to make sure women that have been identified as being at higher risk (for example because they have a faulty gene which puts them at higher risk of developing breast cancer) are offered the opportunity for a screen as soon as possible. The programme is also prioritising women aged 53 who are due their first screen, and those who have passed their 71st birthday and are waiting for their final routine screen. We will keep this under close review. Any woman who is concerned about symptoms of breast cancer should speak to her GP as soon as possible.

As always, anyone who thinks they may have symptoms of breast cancer should contact their GP practice as soon as possible and appropriate referral pathways should be followed.
