Items for all Practices

Flu Vaccine Eligibility Carers and Health and Social Care Staff

Practices are asked to note that there appears to be some confusion being reported in regards to eligibility for the flu vaccine for health and social care workers and carers.

Carers

Anyone who is in receipt of a carers allowance, a part time carer or the main carer of an older or disabled person, or a young carer, is eligible for a flu vaccine from their registered GP or pharmacy. If the carer falls ill the welfare of the person/people they look after may be at risk. It is important carers are protected, so they can continue to give care to those they support and stay healthy throughout flu season.

Health and social care staff

There are three groups:

- **1)**All health and social care staff employed by a registered residential care / nursing home or registered domiciliary care provider, who are directly involved in the care of vulnerable patients / clients who at are increased risk from exposure to flu.
- **2)**All health and care staff employed by voluntary managed hospice providers, who are directly involved in the care of vulnerable patients/ clients who are at increased risk from exposure to flu.
- **3)**Health and social care workers employed through Direct Payments (personal budgets) and / or Personal Health Budgets, such as Personal Assistants, to deliver domiciliary care to patients and service users.

All these three groups are eligible for a flu vaccine and can be delivered either by an occupational health offer from their employer, through their registered GP or with a pharmacy.

The flu letter also states that the <u>health care professional should also apply clinical</u> judgement to take into account the risk of flu. If a patient is presenting as a carer or health care worker and they are looking after vulnerable / at risk people, they should

<u>be offered a flu vaccine</u> and payment can be claimed for this. Codes for those groups are listed within the technical requirements.

Revised guidelines for the movement of flu vaccines

Revised guidelines for the movement of flu vaccines has now been approved by MHRA. These guidelines enable clinical commissioning groups (CCGs), primary care networks (PCNs), general practitioners and NHS trusts to move local flu vaccine stock between NHS providers as necessary. This is a very short interim measure to help with this year's expanded flu programme as a consultation exercise is currently being conducted on this issue. Any sharing arrangements should ensure that vaccines are kept and transferred correctly.

Flu vaccine for people with a medical condition

Further to the <u>flu immunisation programme update</u> sent to practices and local systems on 5 August; this is a reminder that people with long term respiratory conditions such as asthma (that requires an inhaled or tablet steroid treatment, or has led to hospital admission in the past), Chronic Obstructive Pulmonary Disease (COPD), emphysema or bronchitis should be offered the flu vaccine. Respiratory diseases are a major factor in winter pressures. It is imperative this cohort of patients undertake prevention activities to reduce the risk of flu and deterioration of their respiratory condition as soon as possible. Details were outlined in the <u>national flu immunisation programme letter</u> of 5 August 2020.

Diabetic eye screening intervals extended for people at lowest risk

This information is for people waiting longer than usual for their regular diabetic eye screening (DES) appointment during the restoration of the NHS DES Programme due to the coronavirus (COVID-19) pandemic.

Services are working to restore DES safely while implementing social distancing and personal protective equipment (PPE) COVID-19 requirements. People at greatest risk of sight loss are being prioritised as services restore.

Patients may wait longer than normal for their next screening appointment because they had no diabetic retinopathy detected at their most recent screening test and are therefore in the lowest risk group.

This is to notify users that the CQRS system enhancements have now been successfully completed and full functionality has been restored. Users are now able to declare achievement and approve payments.

A communication has been sent directly to all active users of the CQRS system with guidance on how to log in. Log in guidance attached for reference.

For all users, profile and permissions will remain the same and all other functions, such as offering services, viewing achievement, approving payments and granting user access, will also remain the same.

Delay to go live of PCSE online

We have received notification from PCSE that the move of our GP Payment Systems from NHAIS to PCSE online has been delayed and will no longer be completed on 28 September as previously advised.

Practices should continue to declare achievement and commissioners should continue to approve payments as normal. We will send a further communication once we have more information and confirmation of a new go-live date. NHS Cervical Screening Programme Sample Results

We are writing to let you know that we will be processing less cervical screening samples over the next couple of weeks.

This is because of a short-term shortage in the supply of reagents for the testing process. We have been informed by the supplier that stocks will become available again the w/c 8th October 2020 and we are working with them to minimise any risk of this happening again.

Please continue to take cervical screening samples and send them to the laboratory as you would normally. On receipt, the samples will be stored in a suitable environment until they can be processed, and the results will not be affected.

We advise that when taking samples, you inform your patient that results may take a little longer and that they should contact you in the practice if they've not received anything within 6 weeks. Please also reassure people that this is unlikely to cause or increase the risk of clinical harm to them and that cervical cancer takes many years to develop in most cases.

We will update you if there are any changes to the situation.
