PPV 23 (Pneumovax) notification of limited supply

PCV13 Infant dose at 12 weeks – Clarification of importance of 12 weeks + 0 days delivery

As you know on the 1st January 2020, there was a schedule change for PCV13 and babies born on or after 1st January 2020 should be offered the revised PCV13 schedule of a single priming dose at 12 weeks of age (with the DTaP/IPV/Hib/HepB and rotavirus vaccines), followed by a booster dose at 12 months of age (with Hib/MenC, MMR and MenB vaccines). This schedule change has repeatedly been communicated through the primary care bulletin and national vaccine updates.

For Infants born on/after 01/01/2020 who are inadvertently given a dose of PCV13 before 12 weeks of age, they should be offered an additional dose of PCV13 from 12 weeks of age allowing a minimum interval of 4 weeks between PCV13 doses.

Following queries regarding the age threshold of the vaccine given too early (i.e. if given 1-2 days prior to the child turning 12 weeks), further clarification was sought from the national team who have confirmed that the evidence on which the JCVI made their recommendation to offer a single priming dose of PCV13 at 12 weeks of age, was based on a study by Goldblatt et al in which vaccine was administered from 12 weeks of age. It has not been studied as a single priming dose schedule offered at an earlier age than this. It is possible that vaccine given slightly earlier than 12 weeks produces a satisfactory immune response, but there have no evidence to show this is the case hence the recommendation.

We have also sought clarification about the definition of 12 weeks: immunisation at 12 weeks of age means the vaccine should be administered from 12 weeks plus 0 days and ideally by 12 weeks plus 6 days. Weeks should be calculated in weeks/days from the day of birth, not the time of day on the day of birth.

Children immunised ahead of the national schedule may be protected however the recommendation for GPs to follow national advice is so if the child does get invasive pneumococcal disease, the practice would be able to evidence the child was given the vaccine at the correct time.

We would recommend that where practices have given the single priming dose of PCV prior to 12 weeks + 0 days they should offer an additional dose of PCV13 to the parent, outlining the above but it should be the parents choice as to whether they wish their child to have an additional dose.

CQRS Seasonal Flu programme 2020/21 your declarations and payments

The seasonal flu season is well under way and we aware of all the hard work you and your teams are doing to deliver this programme, with the added pressures due to the current climate. We thank you for your continued support with this important Public Health vaccination programme.

The current flu programme does not include those in the 50-64 year-old age group, who are not in an eligible group detailed within the service specification. The programme may be extended in due course to include these patients, however, until this is confirmed Practices will not receive payment for vaccinating these patients.

Following the Seasonal flu extractions for September and October activity, we have noticed that some practices across the South West appeared to have activity in the 50-64 year-old age group who are not in an eligible group detailed within the service specification, and therefore are not eligible for payment.

Indicators not currently included for payment are detailed below, and there should be no activity against these indicators -

SFLU011	Monthly count of patients aged 50-54 years on 31 March 2021 who have received a seasonal influenza vaccination using the recommended vaccine by the GP practice, within the reporting period.
SFLU012	Monthly count of patients aged 55-59 years on 31 March 2021 who have received a seasonal influenza vaccination using the recommended vaccine by the GP practice, within the reporting period.

SFLU013 Monthly count of patients aged 60-64 years on 31 March 2021 who have received a seasonal influenza vaccination using the recommended vaccine by the GP practice, within the reporting period.

For those practices who have activity against this cohort, we are asking you to review your data before you declare to resolve any discrepancies. Please note that where you have declared activity against these indicators, we may place your payment on hold or request a post payment verification at a later stage.

Action to be taken

If your practice has not yet declared your September or October activity, please log into CQRS and check your data against your clinical system. If the data is inaccurate and requires amendment, please submit the appropriate manual data amendment request form with the appropriate supporting information.

If you <u>have delivered to this group</u> in error, you will not receive payment and you will need to complete a manual data amendment request form requesting that those vaccinations are removed from your claim.

If <u>you have not delivered to this group</u> and you believe this error is due to a coding issue, please complete a manual data amendment request form to remove the activity from the above indicators and move the activity to the correct indicator(s), with the appropriate supporting information.

Coding issues

Where you have identified a coding issue, please provide details with your data amendment request (do not include patient information) and ensure that the appropriate actions are in place to resolve this for future extractions.

If you have not been able to identify the reason for incorrectly extracted data, please contact your clinical system supplier to help you investigate and resolve any issues for future extractions.

We are working on some further guidance following feedback received from you and we will issue this is in due course.

Future extractions

To ensure that your future seasonal flu payments are not placed on hold please ensure that you are-

- adhering to the Seasonal Flu service specification and business rules and only delivering to agreed cohorts (links below)
- providing adequate training to your staff and so that they are aware of current business rules (links below)
- checking the extracted data every month and only declare for payment if it is correct, if the data is inaccurate and requires amendment, please submit the

appropriate manual data amendment request form with the appropriate supporting evidence

This version (version 3) replaces the version published in September, and has been updated in part 2 to reflect the arrangements for practices accessing, administering and claiming payment for administering centrally supplied flu vaccines in line with the <u>process laid out by the</u> <u>Department of Health and Social Care</u>.
