#### RELEVANT TO BSPS LAB ONLY

Advice for practices on the correct procedure for sending cervical screening samples to Berkshire & Surrey Pathology Services (BSPS)

This article is relevant to <u>ALL</u> practices that have their cervical screening samples processed by BSPS.

We have been made aware that BSPS is receiving inappropriate samples (blood, histology, urine, etc) from practices, with these samples being put in to the bags reserved for cervical screening samples. BSPS have provided a letter (attached) that explains the correct procedure for sending cervical screening samples to the lab, as well as a reminder that cervical screening sample vial expiry dates must be checked before use to ensure they are still in date, and have at least 14 days before expiry once the vial contains a specimen.
