Administration of childhood immunisations under a Patient Group Direction (PGD)

Please be reminded that when administering childhood immunisations under the legal framework of a PGD, the whole process (consent, drawing up, administration and recording) must be carried out by the same practitioner, and no parts of the process can be delegated, including to other healthcare professionals. We understand that in some cases, clinics are run by two practice nurses or a practice nurse and an administrator, in order to maximise efficiency of the clinic and provide reassurance to the child. The legislation for PGDs does not allow for delegation of any part of the vaccination process to be undertaken by anyone other than the administering clinician, and therefore one nurse undertaking consent and record keeping and another preparing/administering is not valid within the legislation.
