#### About this bulletin

# Bowel Cancer Screening Programme and Age Extension: The Expansion of the Home Testing (FIT kit) Programme

From April 2021, NHS England and Improvement expanded the population eligible to receive a Faecal Immunochemical Test (FIT) as part of the NHS bowel cancer screening programme to include 50-59-year olds. The age extension will be gradually rolled out across the South West in a phased approach over the next four years, meeting a key commitment as part of the NHS Long Term Plan 2019 to modernise the programme and ensure alignment with the government commitments to improve earlier diagnosis.

Following expert clinical advice and engagement with stakeholders including the UK National Screening Committee (UKNSC), Ministers made the decision that NHSEI should decommission bowel scope screening in December 2020.

This self-test is easy for people to use at home. Since this test was introduced into the NHS Bowel Screening Programme in 2019, uptake has increased and is expected to be in line with trials which suggested increased uptake among groups with low participation rates, such as men, people from ethnic minority backgrounds and people in more deprived areas. We continue to encourage you to support your populations in taking up the offer of screening when invited.

A FAQ document is attached to support any questions you, or your patients may have so please do share with all relevant colleagues within your practice.

The move to commence age extension will also support our continued emphasis on fully restoring bowel screening provision amidst the impact of COVID-19, helping to ensure that people are receiving any follow-up diagnostic tests in a timely way.
