### **Roving and mobile models SOP**

Paper sent with newsletter.

This standard operating procedure (SOP) describes how to operate roving and mobile vaccination models. These models enable the administration of COVID-19 vaccines at identified locations outside of vaccination 'base' sites – vaccination centres, hospital hubs, PCN-led sites and community pharmacies. They include care homes, the housebound, other residential settings or settings of multiple occupancy, temporary vaccination clinics (eg pop-ups or satellites), vaccination buses and drive-through clinics. The aim of roving and mobile models is to improve access and maximise vaccine uptake in communities or among groups with low coverage.

### **Inviting 25 to 29 year olds to book their COVID-19 vaccine**

From tomorrow (Tuesday 8 June), 25 to 29 year olds will be invited to book their COVID-19 vaccination through the National Booking Service (on the NHS website or by calling 119). Text messages will be sent to this group inviting them over the course of this week, starting tomorrow, and letters will be sent to them arriving from Saturday.

In addition to inviting 25 to 29 year olds in cohort 12, vaccination sites should continue to work through vaccination of cohort 11. This is alongside continued action to increase uptake across all eligible cohorts and to ensure

there is sufficient capacity to bring forward second doses for those in cohorts 1-9 in line with JCVI guidance:

There has been a concern raised elsewhere in the country that people have been signposted to Lloyds Pharmacy for Viraleze if they are needle phobic.

The labelling suggests that this allegedly 'inactivates >99.9% of Covid'

People should be clear that this is not a suitable vaccine alternative.
