Seasonal flu vaccine reimbursement

Seasonal fluvaccine reimbursement

2021/22 flu reimbursement claims are expected to be reviewed. Throughout the flu season providers should keep records of the vaccines ordered, received, and administered.

CQRS NOTIFICATION - 2021/22 NHSEI PUBLIC HEALTH COMMISSIONED SERVICES

This is a notification regarding the Public Health Section 7a Services that NHS England commission from you for 2021-22 via CQRS.

The first extraction to include Influenza vaccinations delivered will take place on 9th October 2021.

Updated CQRS manual form, Service Descriptions and Payment Indicators

Attached to this bulletin is an updated CQRS manual form (v.7) for use by **BaNES**, **Gloucestershire**, **Swindon**, **Wiltshire and Dorset** practices only.

BNSSG, Somerset, Devon and Kernow practices should continue to use the current form.

Also attached is an updated service descriptions and payment indicator document (v4.0) which now includes information for the Seasonal and Childhood Influenza programmes.

Claiming delivery of Flu vaccinations for non-registered patients

As per section 9.1.11 of the updated Enhanced specification practices will be required to first register the patient within their existing GP IT clinical system using the 'Immediately Necessary Treatment' registration status and then code the vaccination event as per the usual process for registered patients in these cohorts. Practices must not create Temporary Residence (TR) records for non-registered patients.

We request that practices do not submit manual claim forms for patients coded as 'Immediate and Necessary'

Further information regarding how payment will flow will be shared as soon as available.

Amended Enhanced Service Specification: Seasonal Influenza Vaccination Programme 2021/22

An updated version of the amended Enhanced Service Specification: Seasonal Influenza Vaccination Programme 2021/22 document which included reference to co-administration and synergistic delivery of influenza vaccine with COVID was circulated in a special bulletin dated 4th October 2021. This is to confirm that there is no expectation for practices to co-administer the COVID vaccine with the Influenza vaccination but can choose to do so where it naturally lines up.

Newborn Bloodspot Test Results

Attention Practice Manager and Practice Nurse,

As you may be aware a bi-partite letter has been issued relating to rotavirus vaccination and SCID newborn bloodspot screening.

- A 2-year evaluation of screening for severe combined immunodeficiency (SCID) started on 1st September.
- Babies with SCID should not be vaccinated with a live virus so BCG and Rotarix are contraindicated.

CHIS (Child Health Information Service) will be sending you the results of all 10 newborn bloodspot tests for babies registered at your practice (or whose mother is registered if they are not yet registered) at approximately 28 days of age. SCID screening is not being offered in this area so the results will show "Screening not offered" unless the baby has moved here from an area where screening is taking place. We do not yet have a confirmed start date as of yet but in an addition a column has been added to the CSV list we send of children due immunisations showing the SCID result for each baby. It is not on the PDF version of the list.

Finally, we have added a line to the immunisation reminder letter asking parents/carers to bring their baby's bloodspot results letter to their first appointment for clinicians to see if they wish.
