### **CQRS Notification- 2021/22 NHSEI Public Health Commissioned Services**

This is a notification regarding Public Health Section 7a services that NHS England and NHS Improvement (NHSEI) commission from you via Calculating Quality Reporting Service (CQRS)

### **Incorrect Flu Coding on Pinnacle**

There has been a number of situations whereby incorrect data for flu has shown against practice activity due to incorrect coding on Pinnacle. We advise practices to have some enhanced scrutiny on their flu activity prior to declaration on CQRS. If the number is incorrect, do correct prior to declaration/submission

### **Extract Issue Childhood 6 in 1 and PCV Hib MenC services**

As previously communicated, EMIS notified NHS Digital of an issue with their extracts for the Childhood 6 in 1 and PCV Hib MenC services. This issue resulted in an incorrect submission of data between April and September 2021.

The extract for October 2021 has been completed and payment approvals for these services will recommence.

EMIS has started the process to re-extract the correct data for July to September to CQRS. Once data is resubmitted to CQRS, unapproved claims for these months will be updated with the correct values and the necessary approvals will proceed. Further information will be provided on when these extracts have been run.

It has been confirmed that re-extractions will not be completed for April to June 2021.

Payments for April-September will be approved by us as commissioners for you by Friday 3<sup>rd</sup> December latest. These payments will then fall into your normal payment schedule.

All discrepancies associated with approved or unapproved claims for April to June 2021 will be accounted for within the analysis scheduled to take place after all re-extracts have been completed. This analysis is expected to be completed by mid-December, due the current dependency upon re-extract of the data by EMIS.

### **Next Update**

A further update is expected from the CQRS team week commencing Monday 29<sup>th</sup> November 2021 and we will share with practices as appropriate.
