# Hundreds of thousands of women experiencing menopause symptoms to get cheaper HRT

Around 400,000 women across England will get better access to menopause support – saving hundreds of pounds and making treatment more accessible.

- Women in England will be able to access cheaper hormone replacement therapy (HRT) for menopause through a new prescription prepayment certificate (PPC)
- To be rolled out from 1 April 2023, the certificate will help around 400,000 women save hundreds of pounds a year, reducing their HRT costs to less than £20 a year
- Better access to HRT will improve the lives of millions of women in England who suffer from negative symptoms of the menopause

From 1 April 2023, women prescribed HRT - the main treatment for menopause symptoms - will have access to a new scheme enabling access to a year's worth of menopause prescription items for the cost of 2 single prescription charges (currently £18.70).

As part of commitments to reduce the cost of HRT for menopausal women, the PPC will be valid for 12 months. It can be used against a list of HRT prescription items, and a patient can use this against an unlimited number of HRT items, such as patches, tablets and topical preparations. There will be no limit to how many times the certificate can be used while it is valid.

The HRT PPC, valid for 12 months, can be used against any listed HRT prescription item(s) licensed for the treatment of menopause (a list of the item(s) is shown in the link below. The list of eligible HRT medicines will also be published in the April 2023 Drug Tariff. To read more on this article click <a href="here">here</a>.

Once systems are ready, the HRT PPC will be available to purchase through the <a href="NHS Business Services">NHS Business Services</a>
<a href="Authority">Authority</a> website or in person at a pharmacy registered to sell PPCs. Note, patients in possession of a HRT PPC will continue to pay for other prescribed medicines that fall outside of the scope of the certificate.

# Group A Streptococcus (GAS) interim clinical guidance

On 15 February, the <u>Group A Streptococcus (GAS) interim clinical guidance</u>, released on 9 December 2022, was retired. In light of the decrease from exceptionally high rates of infections, the decision to reinstate the <u>NICE Sore Throat (Acute) NG84 guidelines</u> for all age groups for management of sore throat was taken following a review by the NHS England Clinical Advisory Group, professional bodies and UKHSA Group A Strep Incident Management team.

The situation will continue to be monitored and clinicians are advised to be alert to the severe complications of GAS and when assessing patients, particularly those with preceding viral infection (including chickenpox) or close contacts of scarlet fever/iGAS.

# New asthma resources to support patients and the environment

NHS England has been working in partnership with <u>Asthma + Lung UK</u> to help patients improve their lung health and support the environment with the provision of new information on inhaler choices.

This information, developed in partnership with clinicians, patients, and partners, is available on the Asthma + Lung UK website, and supports patients to use their inhalers as prescribed, adhere to the right inhaler technique via discussion with their healthcare professional, consider changing to a lower-carbon inhaler, and return used or unwanted inhalers to their community pharmacy for appropriate disposal.

# **New Medicines Service (NMS) Quarterly Summary Data**

NHS England wish to work with pharmacy contractors to collect NMS quarterly summary data to support monitoring of uptake of NMS in the expanded therapeutic areas and to inform potential future developments of the service into new areas.

NHS England has agreed with PSNC that this will initially be on a voluntary basis for Q3 2022/23.

Voluntary submissions can be made via the NHSBSA website shortly, where an updated reporting spreadsheet will also be available for head offices to use who are able to submit data on behalf of multiple pharmacies. The last date for voluntary submissions for Q3 is 19 March 2023.

In preparation for No Smoking Day on Wednesday 8 March 2023, ASH (Action on Smoking and Health) has created a new communications toolkit to support any local quit smoking marketing activity.

The theme for No Smoking Day this year is brain health and the link between smoking and dementia. ASH has been working with Alzheimer's Research UK in development of the toolkit whose research demonstrates low awareness amongst smokers of the increased risk of dementia caused by smoking. # Reminder: Have you made your Pharmacy Quality Scheme (PQS) declaration yet?

Community pharmacy contractors have until **11.59pm on Friday 3rd March 2023** to make their Pharmacy Quality Scheme (PQS) 2022/23 declaration through the **MYS portal**, as the window for claiming this payment will then close.

Contractors must have evidence to demonstrate meeting the gateway criteria and the domains that they have claimed for by the end of 31st March 2023. However, contractors must make their declaration by 11.59pm on Friday 3rd March 2023 based on what domains they intend to meet.

# Priority Access to Utilities – have you signed up yet?

To further support your pharmacy's business continuity plan you can now sign up for the Priority Services Register. Inclusion on this register should mean your pharmacy has priority access to electricity, water, and gas supplies.

The Priority Services Register is run by the UK's utility companies. Your utility bills may explain how to sign-up and provide contact details.

Alternatively, identify who your energy supplier is at the <u>Energy Networks Association's (ENA's) website</u> or search for "PSR" and or "Priority Service Register" on your utility company websites.

You will need to send a separate request to your water supply company explaining you are a 'sensitive property', as relevant data sharing between water and other utility companies is not yet in place.

## **Serious Shortage Protocols (SSPs)**

- Serious Shortage Protocol (SSP) has been issued for paracetamol 120mg suppositories SSP050.
   This SSP will enable community pharmacists to supply patients with paracetamol 125mg suppositories.
   The SSP came into effect on 16 February and is currently scheduled to end on Friday 5 May 2023.
- 2. The Serious Shortage Protocol (SSP) currently in effect for **Estradot® 50mcg and 100mcg patches** (SSPs 048 and 049) has been extended.

The revised end date for SSP048 will now be Friday 24 February 2023. The revised end date for SSP049 will now be Friday 17 March 2023.

3. Ongoing supply issues the Serious Shortage Protocols (SSPs) currently in effect for **Sandrena®** (SSPs 029-031) and **phenoxymethylpenicillin** (SSPs 040-047) are being extended. The revised end date for the SSPs is now Friday 31 March 2023.

If NHS Digital do not manage to increase the rate of renewal now, it will inevitably result in a rush of users requiring smartcard renewals through the Care Identity Service with increasing urgency.

This could lead to delays in access to systems and services, due to backlogs of renewals being requested for processing by Registration Authorities. Any impact on the Care Identity Service will not affect authentication and

# Independent Prescribing for pharmacists – Applications open now for 2023/24 courses

Funding is now available for another year of independent prescribing courses for pharmacists.

Health Education England is offering more independent prescribing courses from March 2023 for pharmacists working across several settings, including locums.

This training enables pharmacists to support patients from diagnosis to prescribing, and to provide advice and follow-up – while also helping them to feel confident and prepared for the new challenges of their role.

Courses will be available between April 2023 and March 2024, with several universities offering multiple dates for cohort intakes. Start dates will depend on the university provider.
