### Shingles vaccination programme changes webinar: Tuesday 18 July 10:00-11:30

## **HPV vaccination records – interim solutions supporting the HPV immunisation and cervical screening programmes**

As part of the NHS Primary Care Digital Transformation Programme, the National Health Application and Infrastructure Service (NHAIS) is being decommissioned for the NHS Cervical Screening Programme and will eventually be replaced with the Cervical Screening Management System (CSMS). Agreed interim solutions to maintain, capture, flow and reporting of HPV vaccination records will commence from September 2023. The impact of this is set out below:

- Practices will cease their manual uploads of HPV records to Open Exeter/NHAIS on Monday 21 August 2023; an automated data extraction directly with GPIT suppliers will be implemented at a national level as for the Flu and COVID-19 programmes (date to be confirmed). No further action is needed from Practices other than to ensure any records awaiting upload are uploaded to Open Exeter by 21 August 2023.
