### **REMINDER: Sign up Process for Primary Care Providers**

This is a reminder that the 23-24 COVID-19 and flu vaccination campaigns sign-up processes are now open.

The deadline for Pharmacy Contractors to have registered and completed their COVID-19 vaccination expression of interest submission is **5pm on 29 August 2023.** 

GPs are invited to sign up to participate in the Autumn / Winter COVID-19 vaccination campaign by notifying their local commissioner by **5pm on 29 August 2023.**

# NEW: COVID-19 Planning Principles – Autumn / Winter 23-24 Campaign

The Planning Principles were shared this week for regions to use to assure themselves that ICBs are prepared for Autumn 2023 Campaign. They reflect the priorities outlined in the system letter (<a href="here">here</a>), published 10 August 2023.

### Cohort Eligibility – COVID-19:

Last week, the Government accepted final Joint Committee for Vaccination and Immunisation (JCVI) advice for a COVID-19 Autumn 2023 seasonal campaign. The groups to be offered a COVID-19 booster vaccine are:

- Residents in a care home for older adults.
- All adults aged 65 years and over.
- Persons aged 6 months to 64 years in a clinical risk group, as laid out in the Immunisation Green Book, COVID-19 Chapter (Green Book).
- Frontline health and social care workers.
- Persons aged 12 to 64 years who are household contacts (as defined in the Green Book) of people with immunosuppression.
- Persons aged 16 to 64 years who are carers (as defined in the Green Book) and staff working in care homes for older adults.
- The JCVI also advises primary course vaccination for individuals in the above cohorts
  who have not had any previous doses should be offered. They should receive a single
  dose of COVID-19 vaccine during the campaign period.

### Cohort Eligibility – Flu:

Eligible cohorts for the flu programme remain unchanged from those set out in the <u>National flu</u> immunisation programme 2023 to 2024 letter.

The below groups will be eligible for a flu vaccine from 1 September 2023:

- Those aged 65 years and over.
- Those aged 6 months to under 65 years in clinical risk groups (as defined by the <u>Green Book, chapter 19 (Influenza)</u>).
- Pregnant women.
- All children aged 2 or 3 years on 31 August 2023.
- Primary school aged children (from Reception to Year 6).
- Those in long-stay residential care homes.
- Carers in receipt of carer's allowance, or those who are the main carer of an elderly or disabled person.
- Close contacts of immunocompromised individuals.
- Frontline workers in a social care setting without an employer led occupational health scheme. This includes those working for a registered residential care or nursing home, registered domiciliary care providers, voluntary managed hospice providers and those that are employed by those who receive direct payments (personal budgets) or Personal Health budgets, such as Personal Assistants.

The age cohorts for flu and COVID-19 vaccinations have been aligned and facilitate coadministration.

All those who turn 65 years by 31 March 2024 are eligible for both vaccinations.

### **NEW: Care Home Eligibility Guidance**

All care homes should be visited during the autumn winter campaign, including non-older adult care homes. Consideration will need to be given to non-older adult care homes – this may be individual residents, household contacts/setting wide offer.

A permissive approach to vaccination in line with advice in the Green Book COVID-19 Chapter 14a is encouraged throughout all care home settings as there is a clear benefit in reducing the risk of transmission within these populations, given the high risk of exposure. All residents in care homes for older adults are eligible, as per JCVI guidance.

All residents living in non-older adult care homes should also be considered for vaccination. It is anticipated that they will fall into one or more of the following eligible groups.

- Persons aged 65 years and over (by 31 March 2024).
- Persons aged 6 months to 64 years in a clinical risk group see Green Book COVID-19
  Chapter 14a (Tables 3 and 4) for a full list of eligible clinical conditions and medical
  treatments.
- Persons aged 12 to 64 years who are household contacts (as defined in the Green Book) of people with immunosuppression.

Please note, the Green Book recommends vaccination of the whole resident population, including younger adults in long-stay nursing and residential care settings where a high proportion of the population is considered eligible.

### **NEW: Covid/Flu Start Date**

The start of the Autumn-Winter (AW) 2023-24 Flu & Covid 19 vaccination programmes has been confirmed by NHSE in the Seasonal campaign letter of 10/08/23. ## NEW: Open Consultation - Supporting the Delivery of COVID-19 and Influenza Vaccination

The Human Medicines Regulations (<u>The Human Medicines (Coronavirus and Influenza)</u> (<u>Amendment) Regulations 2020</u>) were amended to provide greater flexibilities for the movement and supply of certain type of vaccines, in light of the COVID-19 pandemic.

The Department of Health and Social Care is now looking to ensure that the flexibilities established by those regulations are maintained for a further time-limited period to support the continuing supply, distribution and administration of COVID-19 and influenza vaccines as we transition out of the pandemic. Specifically, in the following provisions:

- Regulation 3A
- Regulation 19
- Regulation 247A

An open consultation, "supporting the delivery of COVID-19 and influenza vaccination" was launched by the Department of Health & Social Care on the 7<sup>th</sup> of August and we want to encourage participation from our SW teams in responding to the proposals. The aim of the proposal set out in the consultation is to enable the continued deployment of safe and effective COVID-19 and influenza vaccines to the pace and scale required, both now and in the future, whilst maintaining public safety.

### **REMINDER: Changes to Q-flow/NBS for Autumn Winter 2023**

We are undertaking essential maintenance and user experience upgrades in Q-Flow in preparation for the next vaccination campaign. This includes:

- changes to the vaccine calendars for adding and managing appointment availability.
- an improved and more secure way for users to be added to multiple vaccination sites.
- a new ICB > Region structure to increase site visibility and enhance user support.

To complete these changes and improve data security, **all users have been removed from Q-Flow**. Before the upcoming campaign the site Lead User, listed within Foundry, will be added to each site and they can then begin to add Site Managers, Arrival Stewards, and other vaccination colleagues.

<u>Action:</u> Please can sites ensure that the Lead Users and Site Leads in Foundry are correct and up to date by 25 August.

If you are still unable to access your site on Q-Flow by 10 September 2023 please contact your SVOC or RVOC.

# REMINDER: Decommissioning and Pausing of Inactive COVID-19 Vaccines From the Vaccine Deployment Programme

To simplify our COVID-19 vaccine portfolio, significantly reduce operational complexity, and reduce wastage levels, three inactive COVID-19 vaccines will be decommissioned from 17 August 2023:

- Spikevax Original
- Comirnaty 30 Concentrate
- Spikevax Bivalent Original/Omicron.

Use of these vaccines has already ceased within the programme, as they have been replaced by newer variants on the recommendation of the JCVI and all stocks have now expired.

In addition, two further vaccine types will be officially paused from 17 August:

- Comirnaty Bivalent Original/Omicron
- Nuvaxovid

Use of both these vaccine types has also temporarily ceased within the programme and all site level inventory has now expired.
