# Community Pharmacy Contractual Framework: Year 5 (2023 to 2024) update for contractors

Year 5 of the Community Pharmacy Contractual Framework (CPCF) has been agreed between the Pharmaceutical Services Negotiating Committee (PSNC), the Department of Health and Social Care (DHSC) and NHS England (NHSE). Please click <u>here</u> to read the full update.

# Number of repeat prescriptions ordered via NHS App up by 92% in the last year

More than 500,000 repeat prescriptions are now booked through the NHS App every week. <u>New figures we've</u> released show that since the NHS App's launch in December 2018, more than 42 million repeat prescriptions have been ordered through the app.

#### NHS delivers two million spring boosters

The NHS COVID-19 Vaccination Programme has <u>vaccinated more than two million</u> of the most at-risk people in England with a spring covid jab since the programme launched last month.

#### End of antiviral medicine prescribing for 2022/23 influenza season

In light of surveillance data indicating that circulation of influenza in the community has returned to baseline levels, the Department of Health and Social Care has published an alert to inform prescribers working in primary care and pharmacy teams that antiviral medicines should no longer be prescribed.

Community pharmacists should no longer supply antiviral medicines for the prophylaxis and treatment of influenza on a FP10 prescription form.

## Referrals from Urgent and Emergency Care (UEC) into the Community Pharmacist Consultation Service (CPCS)


The May 2023 Drug Tariff has been amended to allow CPCS referrals from UEC, e.g., urgent treatment centres and emergency departments. Contractors may start to receive referrals from 15 May 2023 if local UEC providers have implemented an electronic referral process.

The service specification for the advanced service will be published in due course. We are working with the community pharmacy IT supplier market to develop integrated referrals to support this pathway.

# Change to route of delivery of Medicine Supply Notifications and Serious Shortage Protocols (SSPs)

Following discussions with DHSC and the NHS England National Primary Care Team the route by which Medicine Supply Notices (MSN's) and Severe Shortage Protocols (SSP's) is moving away from delivery by the Primary Care Team at NHS England (National) to following the standard cascade route via the National Operations Centre.

This change is with immediate effect and will see the following cascade route used moving forward.



NOTE: this does not affect the CAS Alert cascade route and applies only to routine MSN's and SSP's

# Pharmacy Quality Scheme

### Launch of year 5 scheme

The <u>year 5 Community Pharmacy Contractual Framework (CPCF) PQS scheme</u> will launch on 1 June 2023 and will consist of one gateway criterion (NMS) and three domains with annual funding of £45 million to support national health priorities.

# Antimicrobial Stewardship Activities in England's Community Pharmacies through the Pharmacy Quality Scheme

The Use of the TARGET Antibiotic Checklist to Support Antimicrobial Stewardship in England's Community Pharmacies has recently been published. Antimicrobial Stewardship (AMS) requires effective teamwork with patients receiving consistent messages from all healthcare professionals on appropriate antimicrobial use, providing indication-specific education, and positively impacting the uptake of influenza vaccinations.

Community pharmacy teams successfully promoted AMS using the TARGET Antibiotic Checklist through the Pharmacy Quality Scheme, the review of which has been published online

#### Mental Health Awareness Week 15-23 May 2023

15-23 May is Mental Health Awareness Week (MHAW) and that Better Health - **Every Mind Matters** (EMM) has a wealth of digital, social and printed resources to support this year's theme of anxiety on the <u>Campaign Resource</u> <u>Centre</u>.

Focusing over the next couple of weeks, on how regular physical activity can have an significant impact on reducing the symptoms of anxiety and improving mental wellbeing. Public Health England have enlisted celebrities NHS Dr. Ranj Singh, comedian Tom Davis, and DJ Reece Parkinson to encourage people to 'make the first move for your mental health' using NHS-approved Couch to 5k or Active 10 apps to help make starting physical activity a little less challenging.

There is a <u>MHAW toolkit</u> full of social content and copy, editable posters & digital screens conversation starters and posters and more.

In addition the PR campaign will encourage people to sign up to <u>EMM's anxiety easing emails</u>, or take the <u>Mind</u> <u>Plan</u> quiz, offering expert advice to help you stay on top of your mental wellbeing and showing you how to make these new steps part of your routine.

For related e-learning, these free bite-sized introductions to <u>mental health and wellbeing</u> and <u>physical activity</u> include key evidence, data and signposting. Go to the <u>Campaign Resource Centre</u> and help get more people to make the first move for their mental health.

#### **Clinical Examination Skills Training for Community Pharmacists**

NHS England are making available 10,000 module places which will be delivered by <u>CliniSkills</u> until March 2024.

This exciting new training offer will give community pharmacists the opportunity to build on their existing clinical examination and consultation skills - to assess, treat and manage common health problems.

The training is designed to be complementary to independent prescribing training and can be completed prior to or after independent prescribing training courses.

This offer is available to community pharmacists, including part time staff and locums working in community pharmacy.

#### **NHS Smart Card Renewal**

If you have received automated messages about NHS smartcard renewal, please self-renew as soon as possible.

If NHS Digital do not manage to increase the rate of renewal now, it will inevitably result in a rush of users requiring smartcard renewals through the Care Identity Service with increasing urgency.

This could lead to delays in access to systems and services, due to backlogs of renewals being requested for processing by Registration Authorities. Any impact on the Care Identity Service will not affect authentication and access to clinical systems for users with a valid smartcard.
