## UPDATE: SRO Update and FAQs

Please find attached a copy of the SRO clinical briefing update 7<sup>th</sup> September from the regional team, following last week's national cascades. This update aims to support some of the FAQs raised by systems to support the launch of the AW23/4 campaign. All information in the attached was correct as per the Green Book update [4<sup>th</sup> September] and information released on or before 8<sup>th</sup> September. Please continue to refer to the most updated guidance.

## NEW: Green Book Chapter 14a Update and PGD Update

The <u>Green Book</u> for COVID-19 (Chapter 14a) has been updated and published on 4 September 2023 to support delivery of the Autumn 2023 COVID-19 Campaign.

The Patient Group Directions (PGD) and National Protocol for adults is now available here: <u>National protocol for COVID-19 vaccine (adults) - GOV.UK (www.gov.uk)</u>. The PGD and National Protocol for 5-17 years olds will follow later, anticipated 22 September 2023.

## NEW: Additional 6-Month Shelf-Life Update (18 Months to 24 Months) for Comirnaty® Original/Omicron BA.4-5 When Stored at Ultra-Low- Temperature Storage Conditions (-90°C to -60°C)

A new 24-month shelf-life for Comirnaty® BA.4-5 when stored at ultra-low temperature conditions (-90 °C to -60 °C) has been authorised by the Medicines and Healthcare products Regulatory Agency. This is an update to the previous 18months ultra-low-temperature (ULT) shelf-life which was issued in January 2023.

Full details are in the letter from Pfizer-BioNTech, which can be viewed here.

All Comirnaty® BA.4-5 vaccine being sent out to sites for the Autumn/Winter 2023/24 campaign will have this extension applied, and as a result **the thawed expiry date on the post thaw carton label will be later than the expiry date printed on the vial of vaccine.** 

**Sites do not need to take any further action to update expiry dates upon receiving their delivery.** The updated shelf-life will already have been applied by our Specialist Pharmaceutical Logistics (SPLs) partner prior to the product being thawed and delivered to your site. The 10 weeks post-thaw storage and transportation at 2 °C to 8 °C is unchanged.

#### **Key Information:**

- Sites are not required to update any expiry dates on the carton or vials upon receipt of vaccine deliveries.
- It is always the thawed expiry date at 2°C to 8°C as displayed on the post thaw label on the carton that must be adhered to by sites.
- The expiry date on the post thaw carton label will be later than the expiry date printed on the vial of vaccine.
- Sites will not receive a reminder communication with their deliveries of Comirnaty® BA.4-5 for a temporary period commencing 7 September.

#### In all circumstances it is always the thawed expiry date as displayed on the post thaw label on the carton that must be adhered to when using the vaccine. Please be assured that the vaccine is safe to use until the expiry date on the post thaw label on the carton.

## NEW: Update to the Requirement for Recording of Flu Vaccination Events by PCN Groupings

Following feedback from practices, the <u>2023/24 seasonal flu ES specification</u> is being updated to amend the recording requirements for synergistically delivered flu vaccinations by PCN groupings (i.e. flu only clinics run by a PCN Grouping). A PCN grouping's constituent practices will now be able to elect to record **flu only** vaccination events in either their GP IT clinical system or their PCN grouping's point of care system (PoC).

The system to be used must be agreed and adopted by all practices in the PCN Grouping to reduce the burden of post payment verification work to address any duplicate recordings and payments.

The position with regards to the following has not changed:

- PCN Groupings that co-administer flu and COVID-19 vaccinations must still record their flu (and COVID-19) vaccination events in a PoC system.
- Individual practices must continue to use their GP IT system for practice delivered flu vaccinations or collaborations under an Influenza Collaboration Agreement.

## **NEW: Maternity and Neonatal Programme Masterclass**

As set out in the recent system letter, the Government has accepted JCVI advice that seasonal COVID-19 vaccinations should be offered this Autumn to all persons aged 6 months to 64 years in a clinical risk group – including pregnant women – because they are at higher risk of severe Covid-19 infection in the Winter. Pregnant women are also eligible to receive vaccination against flu, as part of the seasonal programme, and against pertussis as part of the year-round offer.

On 20 September, 15:30-16:30, the Maternity and Neonatal Programme will be hosting a masterclass for midwives and fellow NHS professionals, to give objective advice on vaccination, based on the best available evidence. National experts will give talks on the risks of COVID-19, flu and pertussis around pregnancy; the science behind vaccination; common questions and concerns; and what professionals can do to safeguard women, parents and

babies. There will also be an opportunity for attendees to raise questions and concerns in a Q&A.
