### **Cross-programme updates**

#### NEW: Vaccine Supply Christmas and New Year Vaccine Delivery Schedule 2023

Please find below the planned vaccine delivery schedule covering the weeks commencing (w/c) 25 December 2023 and 1 January 2024.

## Please Note: There will be no vaccine deliveries made between Saturday 23 December and Wednesday 3 January inclusive.

Sites planning to carry out vaccinations between 23 December and 3 January must ensure they have requested any additional vaccine via the Supply Planner exceptions process by **19 December**.

All requests for vaccine will need to be approved by system, region and central teams. The decision on whether to approve exception requests depends on the following conditions being met:

- An up to date stocktake for all vaccine types has been completed within the last 3 days prior to the request being made
- Site has booked activity within the next 7 days of the request being made
- Region has considered local stock movement options.

If requests are approved, exception requests processed on the 19 December will be delivered Friday 22 December.

Any sites requiring vaccine for delivery on 4 or 5 January 2024 will need to ensure this is requested no later than Friday 29 December and Tuesday 2 January respectively.

#### Planned Christmas and New Year Vaccine Delivery Schedule:

- Please take note of these changes and place all vaccine requests by deadlines
- This schedule is intended as a vaccine delivery schedule only; all site level operational activity should continue to be planned as required.

#### **REMINDER: Stocktake frequency**

Following the communication sent on 2 November titled Vaccine Supply Update – Site Stocktake frequency and Targeted Deployment, all sites must ensure they conduct a stocktake every 3 days in order to avoid having their vaccine replenishment blocked. Stocktakes will need to be submitted for each vaccine type held via Site Stock Manager (in Foundry).

The 3 days is applied from the day of the last stocktake. For example: If a site submits a stocktake at 08:00hrs on a Tuesday, they will need to submit their next stocktake no later than 23:59hrs on a Friday. The next stocktake would then be due no later than 23:59hrs the following Monday. Once stocktakes are up to date, vaccine replenishment will recommence. Please note the same rule applies for TDM replenishments and exception requests via Supply Planner.

#### NEW: Flu/Coadmin GP Dashboard Release

This month we have released a new version of the GP Dashboard. This version builds upon existing COVID-19 vaccination functionality and includes for the first time a new additional flu and co-administration dashboard.

The flu dashboard lists eligible patients who have yet to have the flu vaccination and the co-administration dashboard lists people who are eligible for both vaccines and have not received either.

We appreciate it is late in the season to release this functionality but, whilst it is subject to further development, it is hoped this can be used as an additional tool to help further identify and vaccinate eligible patients.

#### NEW: NHS COVID pass service closure

The NHS COVID pass closed on 4 December 2023, as vaccination status no longer needs to be demonstrated domestically or for international travel and the pass is no longer needed. Practices may see an increase in the number of people asking about their COVID-19 vaccination information. Most patients can see this information in their GP health record on the NHS App. <u>The NHS App continues to provide a simple and secure way for people to access a range of NHS services.</u>

#### NEW: Autumn/Winter 23/24 COVID-19 and Flu Campaign – Closure of NBS, NHS App and 119

As announced <u>last week</u>, from 15 December the national booking service, NHS App and 119 phone service will be closed for winter vaccine bookings. Please

continue to encourage those eligible to come forwards by 14 December whilst it is most convenient to book and ensure they are protected in time for the winter holidays. Materials to support this are in our <u>national communications toolkit</u>. After 14 December, COVID-19 and flu vaccinations may continue through local outreach until 31 January 2024 and 31 March 2024 respectively. Make sure that you have local outreach and engagement plans in place to encourage those yet to do so to come forward for their vaccines – this could include signposting to local booking systems, walk in sites or opportunistic vaccinations.

# **REMINDER:** Autumn/Winter 23/24 COVID-19 and Flu Campaign Timing for the End of Campaign

The autumn/winter 23/24 COVID-19 and flu campaign timing Operational Note shared on 22 November 2023, highlighting dates for ending the autumn campaign for COVID-19 and flu, including an update regarding the Targeted Deployment Model can be found <u>here</u>.

Key dates include:

#### COVID-19

14 December 2023: Last day for NBS bookings for COVID-19 vaccinations. Sites should **not** post NBS clinics after this date (appointments can be posted to take place no later than 15 December).

15 December 2023: Closure of NBS for bookings; it will remain open for cancellations only on this day.

16 December 2023 to 31 January 2024: COVID-19 vaccinations may continue for eligible cohorts, where it will improve uptake in the local population.

31 January 2024: Final day of COVID-19 vaccinations for the autumn/ winter 2023 campaign.

#### Flu

14 December 2023: Last day for NBS bookings for flu vaccinations. Sites should **not** post NBS clinics after this date (appointments can be posted to take place no later than 15 December).

15 December 2023: Flu vaccinations completed for school aged cohorts.

15 December 2023: Closure of NBS for bookings; it will remain open for cancellations only on this day.

31 March 2024: Final day of flu vaccinations for all other eligible cohorts.

#### **REMINDER: IT Licence Terminations**

The Vaccination Deployment Programme distributed a large number of computers (iPads, laptops and Desktops) to each vaccination centre during the past few years. All these computers were set up in 'Kiosk mode' with a number of application software packages pre-installed. **All the software licences will terminate on 31 December 2023**. This means that none of these devices will be able to access vaccination applications after this date unless your site takes some of the following actions:

LAPTOPS – Ask your IT support person to install new software on to the laptop.

**DESKTOPS** – Ask your IT support person to install new software on to the desktop.

**IPADS** – Send an email to <u>VaccinationIT@england.nhs.uk</u> with a title of '*iPad factory Reset*' and details of the SERIAL NUMBER of the device (embossed on the back side of the iPad), your NHS.NET email address and your region and site. NHS England will release the iPad from their Mobile Device Management (MDM) domain, and you can then follow some simple instructions which will be emailed to you to 'factory reset' the iPad. It can then be used as though it were a 'new' iPad.

The above instructions can be followed at any time **before** 31 December. After this date, the computer will not be usable until you follow one of the above instructions.

If your site does not have access to IT Support, then please note that the computer will not be able to access any Vaccination Programme systems after 31 December.

If you no longer wish to use the computer at your site then you must either

- Arrange to dispose of the computer following Waste electrical & Electronic Equipment (WEEE) regulations for safely disposing of electrical goods – see <u>Regulations: Waste Electrical and Electronic Equipment (WEEE) - GOV.UK</u> (www.gov.uk);
  - or
- Send your computer (iPad, Laptop or desktop) to NHS England for them to recycle/dispose of to: ICT 5th Floor - Vaccine Returns, Wellington House 133-155 Waterloo Road, London, SE1 8UG.

## **Clinical Update**

# Primary COVID-19 vaccinations for 6 month to 4 year olds in a clinical risk group after AW 23/24

After the close of the Autumn/Winter 2023/24 COVID-19 vaccination campaign, the offer of primary doses for those aged 6 months to 4 years in a clinical risk group will be paused. Sites are advised to not plan COVID-19 vaccination appointments for this cohort beyond 31 January 2024, including for those that have not completed their primary vaccination. Further information will be provided ahead of the next seasonal campaign(s) to clarify if and when this offer can be resumed.

During the inter-seasonal period, those in this age cohort who are severely immunosuppressed (SIS) may receive catch up or additional doses based on clinical judgement, utilising a Patient Specific Direction, as per eligible SIS individuals of other age cohorts.
