## **Cross-programme updates**

### **NEW: Spring COVID-19 vaccination campaign + contracts**

In preparation for a Spring COVID-19 vaccination campaign, the end date of the current COVID-19 vaccination contracts will be extended from 31 March 2024 to 31 August 2024. Please note we are expecting final JCVI guidance on a Spring campaign soon. Providers must let their local commissioner know by 22 February 2024 if they are able to continue delivering the COVID-19 vaccination service until 31 August 2024

The enhanced service specifications and Standard Contract Schedules have been updated and are published here:

- General Practice Enhanced Service Specification and PCN Grouping Collaboration Agreement
- Community Pharmacy Enhanced Service Specification
- Standard Contract Schedules
- Standard Contract Schedule 2A Detained Estates

This includes updated payment arrangements from 1 April 2024. A process will be announced shortly for the award of COVID-19 vaccination contracts from 1 September 2024 onwards. We will share further information about this soon.

### **REMINDER: Campaign Closure and Year-Round Pathway Operations Note**

An Operational Note was shared on 23 January 2024 to provide regions, systems and sites with their actions for the closure of the campaign on 31 January 2024 and the ongoing offer of the vaccine on a case-by-case basis to individuals who are severely immunosuppressed. - Pausing or hibernating sites
- Stock management

- Decommissioned / paused vaccines

# NEW: Help us with the next phase to design Point of Care systems used to capture and report on various vaccination data

As this is a new phase in the project we need to verify your data and consent even if you have been previously involved.

We are working to improve the experience of staff involved with using Point of Care (POC) systems to capture and report on vaccination events. This next phase will involve supporting the ongoing design & development of the working end-to-end service based on what we discovered during the previous two phases of the project.

We will be conducting a series of 30 - 60 minute research sessions over Microsoft Teams soon, if you'd like to take part, please complete the short form here.

### **NEW: Stock Management**

Following the end of the Autumn/Winter campaign on 31 January, sites should submit their final stocktake by 7 February. If a site is pausing or hibernating prior to this date, a stocktake must be completed before it is paused. If a site is continuing to vaccinate as per the year-round vaccination pathway, a stocktake should be completed every seven days. Sites should mark their stocktake as "zero" if they have no XBB vaccine left.
