## 2025 Mandatory Workforce Survey - Open 22 September 2025

Pharmacies will start receiving invitations via email from NHSBSA to complete the survey from **Monday 22 September 2025**. Reminder emails will be sent where surveys remain incomplete.

Where a head office submits data centrally, the NHSBSA email will confirm this. In these cases, individual branches do not need to complete the survey. If in doubt, branches should check with their head office

Completion of the survey is compulsory for all pharmacy owners, and the deadline is 11:59pm on Friday 21st November 2025.

The 2025 Community Pharmacy Workforce Survey contains the same questions as the 2024 survey, focusing on:

- Number of staff
- Full-time equivalents (FTE)
- Vacancies across ten staff categories employed in community pharmacy

As with previous years, there are two submission routes:

- 1. Online survey accessed via:
  - o A unique link emailed to pharmacies by NHSBSA, or
  - o The Manage Your Service (MYS) portal.
- 2. Head Office submission via Excel spreadsheet:
  - NHSBSA will send this to multiple pharmacy groups that submitted centrally last year.

# Community Pharmacy Assurance Framework (CPAF) 2025/26 Update

We would like to thank all community pharmacies who have completed the CPAF screening questionnaire. We have already been in contact with a small number of pharmacies who have been selected for a validation visit.

Based on the results of the screening questionnaire, and other mandatory selection factors, a number of community pharmacies across the South West have then been identified to complete the full CPAF questionnaire. This information has been shared with the NHSBSA, who will be in contact with those selected pharmacies shortly. The window for completing the full questionnaire is expected to run from 1st October 2025 to 23:59 on 31st October 2025 (this is subject to change).

The full version of the CPAF questionnaire, which may be helpful to view before starting to complete it, will be available on the <a href="MISSA">NHSSA</a> Number 1 weeks a query about accessing or competing this questionnaire when the completion window is open, please email <a href="mailto:pharmacysupport@nhsbsa.nhs.uk">pharmacysupport@nhsbsa.nhs.uk</a>. Be sure to include your pharmacy ODS code and pharmacy contact details.

Based on the results of the full CPAF questionnaire and/or other mandatory selection factors, pharmacies may be selected for a contract monitoring visit. Further information will follow early next year about those visits.

## Flu & COVID-19 Vaccination Programme 2025/26

Key programme dates are:

Pregnant women & eligible children:

Start 1 September 2025

School-aged cohorts: vaccination in schools should be completed by 12 December 2025 (with catch-up where needed).

All other adult flu cohorts:

Start 1 October 2025 → 31 March 2026

Aim to complete the majority of vaccinations by end of November 2025 to maximise protection ahead of winter.

COVID-19 Vaccinations:

Run from 1 October  $2025 \rightarrow 31$  January 2026 Aim to complete the majority by 19 December 2025.

The aligned start date for adult flu and COVID-19 vaccinations is intended to support co-administration, ensuring maximum protection for patients as we enter the winter period.

## **National Health Campaigns**

The first national campaign topic has now been confirmed with NHS England and DHSC. The campaign will focus on promoting **Pharmacy First** to the public and is expected to run later in 2025.

All pharmacies will be required to participate, using the campaign materials provided to raise awareness locally.

Campaign requirements (from 2025/26):

- 2 national health campaigns
- 2 local health campaigns
- Pharmacy owners must participate in all four campaigns

More details will be shared when we have received the information relevant to the campaigns

# **Regulatory Changes Effective 1 October 2025**

Several regulatory changes will come into effect from **1 October 2025**, following the introduction of the amendment regulations – *The National Health Service (Pharmaceutical and Local Pharmaceutical Services) (Miscellaneous Amendments) Regulations 2025* – laid before Parliament last week.

Key changes include:

- Terms of Service updates amendments relating to practice leaflets.
- Minor clarifications small changes introduced to improve clarity and reduce ambiguity.
- HPV vaccine availability the HPV vaccine will now be added to the list of those that can be supplied to community pharmacies via centrally procured stock.

A number of these changes were agreed, with the intention of easing some of the regulatory burden on pharmacy owners while ensuring patients continue to receive safe and effective care.

## **Distance Selling Premises (DSP) Changes**

From 1 October 2025:

DSP pharmacies will no longer be able to provide Directed services (Advanced, National Enhanced, Enhanced Services) face-to-face on site.

DSPs will only be permitted to deliver:

- o Directed services remotely from the DSP premises, or
- o Face-to-face off-site if the service specification allows.

This brings DSP provision in line with how Essential services are currently delivered.

## **National Neighbourhood Health Implementation Programme**

All ICBs across the South West have submitted proposals in response to this invitation to be involved in a national Neighbourhood Health Implementation Programme. Across the South West, there will be a minimum of 1 proposal taking forward per ICB Cluster:

- Cornwall / Devon
- · Dorset, BSW and Somerset
- BNSSG and Gloucestershire

The selected proposals will be confirmed to ICBs in September. Your representative committee will be aware of the ICB approach through their involvement in the ICB primary care operational group (or equivalent) and the Primary Care Commissioning Team will work with ICB colleagues as the role of Community Pharmacy, Optometry and Dental providers in neighbourhoods is developed.

# Help with NHS health costs if you're in full-time education-Information about prescription charges

#### **Under 16**

Automatically entitled to help with NHS health costs (education status doesn't matter).

#### Aged 16-18 and in full-time education

If you're in full-time education (school, college, university, or home schooling), you're automatically entitled to:

- Free NHS prescriptions
- Free NHS sight tests
- A voucher towards the cost of glasses or contact lenses
- Free NHS wigs and fabric supports

This applies until your 19th birthday **or** until you leave full-time education (whichever comes first).

#### Important to note:

- Apprenticeships or workplace learning are *not* considered full-time education.
- If you're between two full-time education courses, you remain entitled until you turn 19.

Your entitlement is not affected by whether your next course offer is conditional or unconditional.

Any emails with patient details must not be sent from a non-secure email address as this could result in a breach of GDPR.

## **DHSC Medicine Supply Notifications**

## **Reporting a Temporary Suspension of Service**

In accordance with regulations, contractors must notify the commissioner of any temporary suspension in service; including those for reasons due to illness or causes beyond the control of the contractor. In accordance with pharmacy regulations contractors must provide evidence to the commissioner that they have undertaken the following:

- Notified the commissioner of the suspension as soon as practical.
- Used all reasonable endeavors to implement the business continuity plan required by paragraph 29D, Schedule 4 of the NHS (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013, and
- Used all reasonable endeavors to resume the provision of pharmaceutical services as soon as is practicable. (Paragraph 23(10), Schedule 4, of the NHS (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013.

In the event of you being unable to open please complete a Temporary Suspension closure form via one of the following ways either:

- 1. via Manage Your Service (MYS) portal.
- 2. Completing the Temporary Suspension Form found <a href="https://example.com/here-titled-Annex-18">here titled Annex 18 and sending this to the SW generic email address: <a href="mailto:england.pharmacysouthwest@nhs.net">england.pharmacysouthwest@nhs.net</a>.

Details of the new Temporary Suspension policy can be found <u>here</u>, the new temporary suspension policy went live on the 1<sup>st</sup> of April.

# Changes of director and/or superintendent pharmacist

When a body corporate appoints a new director and / or a new superintendent they must inform the commissioner within 30 days of the person taking up that new position. Recent experience suggests that contractors sometimes overlook making these declarations.

To make such a declaration you should go to the Primary Care Support England (PCSE) website at <a href="https://pcse.england.nhs.uk/services/pharmacy-market-administration-services/market-entry/">https://pcse.england.nhs.uk/services/pharmacy-market-administration-services/market-entry/</a> where you will be able to complete the necessary declarations. Failure to notify any changes to directors and / or superintendent pharmacist maybe a breach of your terms of service.
