GLP-1 receptor agonists interactions with oral contraception

Pharmacy owners delivering the Pharmacy Contraception Service are reminded of recent guidance from the Faculty of Sexual and Reproductive Healthcare (FSRH) regarding the use of contraception in individuals prescribed Glucagon-like peptide-1 (GLP-1) receptor agonists, including tirzepatide.

The FSRH advises that:

- Individuals using GLP-1 medications should use effective contraception during treatment.
- There is additional guidance for those prescribed tirzepatide, given its potential effects on the absorption of oral contraceptives.

In addition, the Medicines and Healthcare products Regulatory Agency (MHRA) has updated its public guidance. NIHR Programme Grants for Applied Research (PGfAR) Funding Opportunity Opening in October 2025

 Building on NIHR's Strategic Focus - Strengthening careers for under-represented disciplines and specialisms, we are delighted to announce that the NIHR Programme Grants for Applied Research (PGfAR) Funding Opportunity, opening in October 2025, will be a ring-fenced call dedicated to 'Research inspired by under-represented disciplines and specialisms to drive transformational changes for patients and the public'.

- NIHR Programme Grants for Applied Research (PGfAR) is seeking to grow a portfolio of applied health and care research programmes with leadership/co-leadership from underrepresented disciplines, specialisms and/or methodologists, that is:
- Registered health and care professionals (HCPs), who are not doctors or dentists (i.e., proposals cannot solely be led by doctors or dentists but in alignment with the above, a co-lead arrangement is permitted given the scale and complexity of research programmes).
- Allied health professionals.
 Research methodologists specifically the following disciplines: medical statistics, health economics, clinical trial design, operational research, modelling, bioinformatics, qualitative research, mixed methods, and epidemiology.
- Offers multidisciplinary research teams considerable flexibility to focus on any health and care topics
 within remit and scope of the NIHR PGfAR programme. We welcome applications with leadership from
 underrepresented disciplines, specialisms and/or methodologists that present a coherent applied
 research programme of interrelated, multidisciplinary projects which individually and together produce
 outputs and outcomes that are likely to realise a transformative step change in the way the health and
 care services can meet the needs of the UK public.
- The amount awarded and the length of the funding period depends on the nature of the proposed work. In recent competitions PGfAR awards attract funding of around £2.0 £3.5 million across 4 6 years.

Core Opening Hours

Contractors wishing to reduce or redistribute the core opening hours of their pharmacy premises must first apply to the ICB. All core hour applications are decided by the NHS South West Pharmaceutical Services Regulations Committee (SW Committee).

Pharmacy owners have no right to change core opening hours and this is not a notification process, they must apply for any changes. Consequently, applications to change core opening hours may be granted or refused. Applications are determined against the 2013 Regulations as amended, and if refused, the contractor may appeal the decision to NHS Resolution.

If a contractor wishes to maintain the total core opening hours of its pharmacy premises but change the timing of them or the days on which they are, they may apply to do so under paragraph 26(1), Schedule 4. On 23 June 2025, a second test was introduced at paragraph 26(2ZB) Schedule 4 and contractors are required to state in their application whether they wish their application to be determined on the basis of:

- The test in paragraph 24(1), or
- The new test in paragraph 26(2ZB)

As part of their application applicants are required to provide the information necessary to satisfy the SW Committee in respect of the test they are applying for.

For the test in paragraph 24(1), a pharmacy owner must ensure evidence is provided to show that the proposed change to the core opening house will either:

- maintain as necessary the existing level of service provision for the people in that area or other likely users of the pharmacy premises; or
- maintain a sustainable level of adequate service provision for the people in that area or other likely users
 of the pharmacy premises, in circumstances where maintaining the existing level of service provision is
 either unnecessary or not a realistically achievable outcome.

For the test in paragraph 26(2ZB) a pharmacy owner must ensure evidence is provided to show that the proposed change to core opening hours demonstrates that the proposed hours will:

ensure that the people who are accustomed to accessing pharmaceutical services at the pharmacy
premises are likely to benefit from the changes because, overall, they would be more likely to access
those services at those premises during the proposed core opening hours than during the existing core
opening hours.

Evidence could include, for example, changes to the local surgery hours, and the opening hours of neighboring pharmacies, but provide as much factual information as possible about the needs of the pharmacy's patients – patient surveys, records of levels of use (prescriptions and requests for advice / OTC medicines sales). This is not an exhaustive list.

Recent appeal cases (which can be found on the Primary Care Appeals decisions website) identify key evidence such as the distance from the pharmacy to nearby pharmacies, how patients could travel to them, the opening hours and the services those pharmacies offer. To support this evidence applicants could provide survey data for the hours they wish to change, to show how patients are travelling to the pharmacy and the reason for their visit (e.g. dispensing services).

Please note that 100-hour pharmacies can only apply to redistribute core hours under 24(1) (if not already reduced under 26(2A)) or reduce core opening hours in line with paragraph 26(2A), Schedule 4 (or redistribute in line with that paragraph if already reduced).

Community Pharmacy Workforce Survey 2024: key findings now available

The Community Pharmacy Workforce Survey (CPWS) provides valuable insights to support future workforce planning and investment, ensuring continued access to vital pharmacy services.

Key findings from the 2024 survey, now available on the CPWS webpage, show:

- Five per cent increase in pharmacists
- 22 per cent rise in pre-registration trainee pharmacy technicians
- Four per cent overall reduction in workforce, mainly due to fewer trainee dispensing assistants, medicines counter assistants, and delivery drivers
- Nine per cent of community pharmacists are now independent prescribers

Reporting a Temporary Suspension of Service

In accordance with regulations, contractors must notify the commissioner of any temporary suspension in service; including those for reasons due to illness or causes beyond the control of the contractor. In accordance with pharmacy regulations contractors must provide evidence to the commissioner that they have undertaken the following:

- Notified the commissioner of the suspension as soon as practical.
- Used all reasonable endeavors to implement the business continuity plan required by paragraph 29D, Schedule 4 of the NHS (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013, and

 Used all reasonable endeavors to resume the provision of pharmaceutical services as soon as is practicable. (Paragraph 23(10), Schedule 4, of the NHS (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013.

In the event of you being unable to open please complete a Temporary Suspension closure form via one of the following ways either:

- 1. via Manage Your Service (MYS) portal.

Pharmaceutical Clinical Waste- Waste Segregation

Effective segregation of waste delivers important benefits for workplace health and safety. With the correct waste type disposed of in the right containers, needlestick injuries can be reduced, the risk of dangerous infections and diseases can be better controlled, and staff and patients are protected from encountering hazardous substances that could cause them harm. It also means that everyone who handles the waste once it leaves your site is protected, and with correctly segregated waste reaching the most appropriate place for treatment and disposal.

Changes of director and/or superintendent pharmacist

When a body corporate appoints a new director and / or a new superintendent they must inform the commissioner within 30 days of the person taking up that new position. Recent experience suggests that contractors sometimes overlook making these declarations.

To make such a declaration you should go to the Primary Care Support England (PCSE) website at https://pcse.england.nhs.uk/services/pharmacy-market-administration-services/market-entry/ where you will be able to complete the necessary declarations. Failure to notify any changes to directors and / or superintendent pharmacist maybe a breach of your terms of service.

South West Controlled Drugs Team

Following the roll out of the Pharmacy First Urgent Supply of Repeat Medicines Service, we would like to take this opportunity to remind colleagues to please consider the following points before making supplies as part of this service:

- Supplies carried out for urgent repeat medicines supply under Pharmacy First MUST comply with
 emergency supply legislation (regulation 225 HMR 2012), including the pharmacist being satisfied
 that there is an immediate need and that it is not practical for the patient to obtain a prescription
 without undue delay. An entry MUST be made in the POM register and the medicine labelled
 'emergency supply'. The medicine MUST have been previously prescribed, and consideration should be
 given to when it was last prescribed.
- Legislation <u>limits any supplies</u> of Schedule 4, and 5 controlled drugs made through this service <u>to five</u> <u>days</u>. This includes codeine containing products such as co-codamol which are schedule 5 controlled drugs. This restriction also applies to other lower schedule-controlled drugs including dihydrocodeine, diazepam, lorazepam, morphine sulfate solution 10mg/5ml, zopiclone, zolpidem, testosterone and

others. If a medicine comes in a container containing more than 5 days' supply, that cannot be split, it is not legal to supply (this applies to most testosterone products).

- Codeine, related products and other lower schedule-controlled drugs are medicines that can be subject
 to abuse and pharmacists should always access the patient's national care record or where available the
 GP record via GP Connect: Access Record and check for previous supplies. If a patient refuses to
 provide consent to view their clinical record, consideration should be given as to whether it is clinically
 appropriate to make that supply.
- Please also be aware that <u>it is for the pharmacist to determine whether any urgent medicines</u>
 <u>referral to supply a medicine is appropriate</u>, not the person who issued the referral. The supplying
 pharmacist needs to balance the potential for misuse against clinical need and to consider any impact on
 the patient if not supplying a medicine or appliance, and also if supplying. If thought appropriate, a
 limited supply of one or two days can be considered to allow the patient time to access their GP practice.
- Please note that with the exception of supply of phenobarbitone for the treatment of epilepsy, <u>schedule</u>
 1, 2 or 3 controlled drugs (including tramadol) <u>cannot be supplied under emergency supply</u> regulations
- If a referral is received for a controlled drug that cannot be supplied under emergency supply regulations and the pharmacist believes that there is a genuine patient need to obtain a supply of their medicine, although it would not be possible to make an emergency supply, the pharmacist should ensure the patient is able to speak to another appropriate healthcare professional by either:
 - o Referring the patient to their own general practice; or
 - By contacting a local out-of-hour provider.

An entry should be made to the Pharmacy First IT system, and a consultation fee can be claimed in this instance.
