## **COVID-19 and the production of statistics**

### (Updated 7<sup>th</sup> September 2021)

Due to the coronavirus illness (COVID-19) and the need to release capacity across the NHS to support the response, NHS England and NHS Improvement paused the collection and publication of some of our official statistics. Initially this applied to the statistics listed in section 5, for data due to be submitted between 1 April and 30 June 2020.

The list of data collections was updated at Quarter 1 2021/22 and again in September 2021. The tables below outline which collections continue to be paused; which have been reinstated having been paused previously; and which have been permanently stopped.

NHS England and NHS Improvement will keep the paused collections under review to establish at which point further collections should be reinstated and update published information when the status of any of the collections change.

This decision is informed by the Office for Statistics Regulation's <u>guidance on Changes to statistical</u> <u>outputs during the coronavirus outbreak</u>.

A consultation took place to seek feedback from users regarding proposals to terminate the Quarterly Activity return (QAR), and significantly reduce the scope of the Monthly Activity Return (MAR). The rationale was that much of the information could be similarly derived from patient-level data sets, thereby reducing the NHS data collection burden. Responses to the consultation were reviewed and a decision made to retire QAR following the publication of Q4 2019/20 and reduce the scope of MAR to collect referrals information only following the publication of May 2020 data.
