



## **Cancer Waiting Times, April 2022 - Provider Based - Provisional**

The latest monthly Official Statistics on waiting times for suspected and diagnosed cancer patients accessing NHS services, produced by NHS England and NHS Improvement, were released on 16/06/2022 according to the arrangements approved by the UK Statistics Authority.

### **Waiting Times for Cancer Services - April 2022**

The key results for outpatient services and first definitive treatments show that, in England, during the period April 2022:

#### **Two week Wait:**

- 79.1% of people were seen by a specialist within two weeks of an urgent referral for suspected cancer (80.6% in March 2022)
- 62.3% of people urgently referred for breast symptoms (where cancer was not initially suspected) were seen within two weeks of referral (59.5% in March 2022)

#### **One month (31-day) wait from diagnosis to first definitive treatment:**

- 92.8% of people treated began first definitive treatment within 31 days of receiving their diagnosis, all cancers (93.4% in March 2022)
- 92.1% of people treated for breast cancer began first definitive treatment within 31 days of receiving their diagnosis (93.4% in March 2022)
- 95.2% of people treated for lung cancers began first definitive treatment within 31 days of receiving their diagnosis (95.7% in March 2022)
- 89.4% of people treated for lower gastrointestinal cancers began first definitive treatment within 31 days of receiving their diagnosis (90.8% in March 2022)
- 93.3% of people treated for urological cancers began first definitive treatment within 31 days of receiving their diagnosis (93.3% in March 2022)
- 89.8% of people treated for skin cancers began first definitive treatment within 31 days of receiving their diagnosis (91.5% in March 2022)

#### **Two month (62-day) wait from urgent referral to first definitive treatment:**

- 65.2% of people treated began first definitive treatment within 62 days of being urgently referred for suspected cancer, all cancers (67.4% in March 2022)
- 69.3% of people treated for breast cancers received first definitive treatment within 62 days of being urgently referred for suspected cancer (72.1% in March 2022)
- 59.0% of people treated for lung cancers received first definitive treatment within 62 days of being urgently referred for suspected cancer (61.7% in March 2022)

- 45.5% of people treated for lower gastrointestinal cancers received first definitive treatment within 62 days of being urgently referred for suspected cancer (47.8% in March 2022)
- 60.3% of people treated for urological cancers (excluding testicular cancer) received first definitive treatment within 62 days of being urgently referred for suspected cancer (61.8% in March 2022)
- 87.9% of people treated for skin cancers received first definitive treatment within 62 days of being urgently referred for suspected cancer (90.1% in March 2022)

### **62-day wait extensions**

- 77.8% of patients began first definitive treatment within 62 days of a consultant's decision to upgrade their priority, all cancers (77.1% in March 2022)
- 72.8% of people began first definitive treatment for cancer within 62 days of referral from an NHS cancer screening service, all cancers (74.6% in March 2022)

The key results for waiting times for second or subsequent treatment show that, in England, during the period April 2022:

### **31-day wait for subsequent treatment**

- 82.2% of people began treatment within 31 days where the subsequent treatment was surgery (82.2% in March 2022)
- 98.1% of people began treatment within 31 days where the subsequent treatment was an anti-cancer drug regimen (98.5% in March 2022)
- 92.0% of people began treatment within 31 days where the subsequent treatment was a course of radiotherapy (93.7% in March 2022)

The key results for waiting times for urgent referral to a patient being told they have cancer, or that cancer is definitively excluded show that, in England, during the period of April 2022:

### **28-day Faster Diagnosis (All Routes):**

- 70.8% of people were told by a specialist if they had cancer, or if cancer was definitively excluded within four weeks (28-days) of an urgent referral (73.1% in March 2022)

The estimated shortfall of these missing and partial submissions on national activity volumes is given in the table below. The estimated impact on national performance is very small (for all measures it was 0.4 percentage points or less).

We are working with the providers concerned to resolve the issues and we will be publishing revisions later in the year.
