### **National Wheelchair Data Collection**

The National Wheelchair Data Collection is an Integrated Care Board (ICB) level collection. It provides a national view of NHS wheelchair services in England by collecting information on the number, cost, and access to wheelchair services to enable transparency and benchmarking. It allows NHS England to better understand NHS wheelchair services and improve the commissioning of those services and the outcomes for people who use wheelchairs.

The indicator for performance is that people referred for a wheelchair, or a modification, receive one within 18 weeks from referral (or re-referral to the service) in 92% of cases.

Data is submitted quarterly via the Strategic Data Collection Service (SDCS).

## **Summary Statistics**

The proportion of patients whose episode of care was closed in the reporting period and prescribed equipment was delivered within 18 weeks or less:

- Child 81.6%
- Adult 84.9%

Percentages are calculated as numerator divided by denominator. The numerator is the count of individual patients whose episode of care was closed in the reporting period and prescribed equipment was delivered within 18 weeks or less. The denominator is the matching count of all patients prescribed equipment.

Quality assurance is conducted as part of the processing of the data set to ensure the reasonableness of the data. Details are provided as part of the published data set. ### **Definitions**

Adult A patient is an adult from the date of their 18<sup>th</sup> birthday onwards.

Child A patient is a child up to their 18<sup>th</sup> birthday.

Closed episode of care Patient pathway is complete, i.e., equipment, accessories or

modification received by the patient.
