

Nomenclature for partnership agreements



Statement of purpose – clarify the functions of the organisations, and therefore identify where shared interests might lie.

Compact – principles for the relationship, setting tone and vision, and capturing shared purpose, signed by CEOs, usually underpinned by a number of formal operating agreements.

Agreements with representative bodies – for organisations where compacts are not appropriate, but where a written understanding of expectations of the relationship would be useful.

Formal operating agreement – detailed summary of how a specific business process will work, and how each party involves the other at key points, identifying named individuals for this purpose.
