The Equality and Diversity Council recently made the Equality Delivery System and the Workforce Race Equality Standard mandatory for all NHS organisations, in particular, the WRES was embraced because the “Snowy White peaks” report highlighted among other things that “The proportion of senior and very senior managers who are BME has not increased since 2008, when comparable grading

data was available, and has fallen slightly in the last three years. The likelihood of white staff in London being senior or very senior managers is three times higher than it is for black and minority ethnic staff.” In an effort to address this underrepresentation NHS England advertised a post for a 2 year secondment to the role of Workforce Race Equality Standard Senior Programme Lead. This post was on NHS Jobs for 3 days and was withdrawn on the 15th May 2015 even though the closing deadline was the 28th May. The successful applicant for the post was in fact the author of the snowy white peaks report who was neither a member of staff of the NHS nor BME. In essence the author drafted a report highlighting the plight of BME staff in the NHS and was rewarded with a senior job in the NHS to the detriment of aspiring black staff already in the NHS. The implications for the success of the WRES as a result will be devastating for BME staff and BME communities simply because we appear to be saying that there are no BME staff within the NHS worthy of progression so we must recruit from outside. I come now to my freedom of information request. I believe the recruitment process is flawed, it lacked transparency and accountability and I would therefore request the following information. How long was the post advertised and where? How many people applied for the post in total? How many applicants were black and minority ethnic? How many people were shortlisted? How many of those shortlisted were from BME background? I am informed by the your HR department that the recruitment process was managed by your HR Director, Please confirm this? Please confirm the makeup of the selection panel (personnel)? Please confirm that the Director of HR and the successful candidate have been working together on WRES workshops prior to the recruitment process. I attended a workshop where this was the case. Given that WRES is a recognition of underrepresentation by way of Race, please confirm whether consideration was given to using this role to develop an existing BME member of staff with the support of the successful applicant by way of positive action? Please confirm that the successful applicant was in post prior to the creation of the role in a consultant capacity? Please confirm if successful applicant was employed by the NHS as a Member of staff and in what capacity?
