1 Introduction

Over the coming months, NHS bodies will need to work together to produce an operational plan for 2017/18 and 2018/19 for each organisation, which is consistent across the planning footprint and with the Sustainability and Transformation Plan (STP).

A number of supporting, technical and supplementary guidance documents have been developed to support commissioners and providers in developing their operational plans. The expectations for the content of operational plans are described more fully in Annex E for commissioners and Annex F for providers. This technical and supplementary guidance and its supporting Annexes also provide more information about: the expectations in relation to key policy areas and deliverables including transformation and efficiency, the timetable, where to find support, content and assurance arrangements for operational plans, and guidance on the various data returns and templates organisations will need to use.

2 Support, Review and Assurance for 2017/2018 and 2018/2019 Operational Plans

The operational plan of each commissioner and provider will need to be approved by its individual Board or Governing body.

NHS England and NHS Improvement will undertake a joint assurance process, working with local organisations in a coherent and joined-up way. Equally, commissioners and providers are expected to ensure their plans reconcile and are agreed locally prior to submission.

This joint assurance approach will focus on:

- How operational plans set out to deliver the next two years of the system STP, covering agreed plans to close the three gaps care and quality, health outcomes and finance;
- Ensuring milestones and deliverables are clear;
- Provider and commissioner plans reconcile both to the system STP and to each other and share planning assumptions;
- Agreement of robust, stretching and deliverable activity plans by commissioners and providers. They are directly derived from the projections agreed within system STPs and reflect historic growth levels moderated by agreed transformation and efficiency schemes. They enable agreed performance trajectories to be delivered within available financial resources;
- Ensuring that finance, workforce and activity projections are fully aligned with activity projections; and
- That risks inside and outside of the direct control of the organisation are identified and mitigated. This involves considering both the assumptions in individual plans and the shared understanding across the system in terms of how the system will work together to manage risks.

NHS England and NHS Improvement are developing a joint prospectus of practical planning support for localities to access, including a range of planning tools and a series of workshops and webinars.

The main elements are:

- Areas asked to self-assess their readiness for local health and care community working and support designed around need;
- Structured support and challenge (for example, site visits) provided by joint national teams and STP leads;
- Workshops/webinars on specific aspects of planning; and
- Practical tools, resources and guides.

To support commissioner and provider plans a series of regional Demand and Capacity training events have been held throughout 2016. These events provided a shared understanding of the principles underpinning demand and capacity planning and promoted the use of a series of demand and capacity models that will help inform activity plans.

We encourage attendees to use these skills to help inform the activity plans for 2017/18 and 2018/19. Further one day training events are being held throughout 2016. For further information and support please access the webpage www.england.nhs.uk/demand-capacity

Demand and capacity planning should be regarded as business-critical rather than an optional skillset. The suite of demand and capacity modelling tools has been produced to assist commissioners and providers in embedding these skills in the planning process. 2.1 Joint data collections

To ensure coherence of plans across the locality, activity and finance assumptions made by providers and commissioners should be consistent. For the 2017/18 and 2018/19 planning rounds, commissioners and providers will provide aligned planning information to NHS England and NHS Improvement respectively. Information from these collections should be shared locally between commissioners and providers, allowing transparency and understanding of common data and enabling alignment of plans.

The contract tracker collection (Technical Guidance Annex G) will commence on 21st November 2016. Throughout the contracting round, providers and commissioners will submit information through UNIFY relating to their individual contracts. This will help all parties to understand misalignment and contract risk early on, thus; providing meaning support to commissioners and providers; encouraging contracts that contain realistic levels of activity that providers have the capacity to deliver; and helping to ensure that contracts are signed by the national contract deadline.

Support is available from regional NHS England and NHS Improvement teams to help organisations make progress and resolve outstanding issues. Where contract

discussions have not progressed, the escalation processes detailed in the Joint Contract Dispute Resolution Annex should be followed. However, they should be used only as a last resort. Details of the joint contract dispute resolution process can also be found on the NHS England website.

The scheme sets out goals for change, how improvements for patients will be rewarded, and how success will be measured: The scheme retains multi-year CQUINs introduced in 2016/17 The number of CQUINs per contract is proportionate to the financial value of CQUIN investment, with up to 10 schemes for the largest providers of services As now, Hepatitis C network lead providers will earn up to 2.8%, other acute providers 2.0% and mental health providers 2.5% Incentive payments have been increased from 'typical provider cost plus 25%' to 'plus 50%' rather than fixed percentages of contract, so financial rewards relate to the scale of patient benefits.

NHS England will invest almost £600m through the Specialised CQUIN scheme in the next two years. Some CQUINs apply across acute or mental health services, but many are service specific, by programme of care. To ensure sufficient time to deliver change, PSS CQUIN schemes are again multi-year, with most CQUINs continuing from 2016/17. New schemes are designed for implementation over two years.
