1.0 ITEMS FOR THE BOARD'S INFORMATION AND ASSURANCE

Capital Budget Allocation Setting 2016/17

The Committee agreed to the recommendations and approach to capital budget allocation setting for NHS England and CCGs for 2016/17 and five year indicative requirements to 2020/21, as set out in the paper.

London Office Accommodation Capital Business Case

Subject to a follow-up note detailing potential additional costs to the health system of the preferred option, the Committee approved the recommendations in the London Office Accommodation Capital Business Case. The Committee also requested a follow-up note to further clarify the economic cost of the preferred option compared to other options considered.

New Care Models – New Care Models – Vanguard Funding 2016/17

The Committee noted the method and process that had been applied in determining allocations for the vanguard sites in 2016/17 and agreed to the recommendations and conditions put forward, the conditional allocations to vanguards in 2016/17 and the delegation of budgetary authority to Paul Baumann and Ian Dodge for approvals resting on conditions. The Committee noted that a further discussion at Board level was required on delivery mechanisms and alignment with Sustainability and Transformation Plans (STPs), and that the impact of final allocations on the shape of the Transformation Fund would be brought back to a future Committee.

Papers circulated by correspondence

The Committee noted an update from the Oversight Group for Service Change and Reconfiguration (OGSCR) and an update on children and young people's (CYP) services.
