Matters for the Board's attention

- 1. The Committee was informed formally of the decisions taken by Chair's Action to approve the removal of:

- 2. The Committee received two reports on the GP contract. One on overall proposed changes, including a refresh of the quality outcomes framework (QOF) and the second on digital services. It was agreed to:
 - continue work with NHS Employers on GP contract negotiations for 2019/20;
 - implement the proposed engagement on digital primary medical services; and
 - hold a Board development session on digital primary medical services.

Items for the Board's information and assurance

- 3. The Committee received report on the Cancer programme noting the progress on survival rates, the 62 day target with the further work required to sustain.
- 4. The Committee were updated on the Breast Cancer Screening programme noting the joint work with Public Health England, the support offered to patients and the responsiveness of the service to provide additional capacity to meet needs.
- 5. The Committee received a progress report on the Learning Disability programme noting progress made and the need to accelerate including strengthening specialist community support.
- 6. The Committee received report on the clinical evidence on the effective, safe and appropriate use of anticoagulation medicines. They supported the recommendations including continued engagement with NICE and a review of current guidance.
- 7. The Finance report for month 12 was presented, with NHS England expecting to achieve a balanced position.
