'YOUTH NATIONAL QUALITY BOARD – EXPO 2017

Purpose and Structure of the Session

One of the key themes at this year's Expo is children and young people; as both current and future users of health care services for themselves and in their roles as parents, or carers, or peer supporters. Expo 2017 provides opportunity to bring young adults together with health care leaders to discuss CYP issues and provide a platform for an audience whose voice is often missing in national conversations on quality improvement.

The purpose of this special NQB meeting is threefold:

1. To raise the public profile of the National Quality Board, using the platform of Expo 2017;
2. To validate the National Quality Board's commitment to involving young people in its work and develop policy in a number of key areas ;
3. To demonstrate to commissioners and providers how to engage meaningfully with children and young people on quality matters.

The meeting will be co-chaired by Sir Bruce Keogh (NHS England) and Susie Williams (NHS England Youth Forum), with Luke O'Shea (NHSE Quality Strategy) acting as the central facilitator.

Themed across three items, the NQB and NHSE Youth Forum panel will discuss topics relating to service involvement, AMR and digital health care. Each item will involve a presentation from external presenters and then discussion will take place across the floor, leading with NQB and Youth Forum members. Audience members will have the opportunity to ask questions as relevant after each item. The agenda was developed in partnership with NHSE Youth Forum members looking at NQB areas of interest.
