BACKGROUND

NHS England accepted enforcement undertakings under section 106 of the Health and Social Care Act 2012 from the Licensee on 14 March 2023 ("the Undertakings").

UNDERTAKINGS TO BE DISCONTINUED (COMPLIANT)

NHS England hereby certifies that it is satisfied that the Licensee has complied with:

- All of paragraph 1 (Quality of Care) of the section titled "Undertakings" in the Licensee's Enforcement Undertakings accepted by NHS England on 14 March 2023.
- Sub-paragraph 2.1.1 of the section titled "Undertakings" in the Licensee's Enforcement Undertakings accepted by NHS England on 14 March 2023; "Reduce and ultimately eliminate 104+ week waits for elective treatment, and to minimise waits in excess of 52 weeks. It is noted that the Licensee has committed to eliminate waits of over 104 weeks as a priority and maintain this position through 2022/23".
- Sub-paragraph 2.1.3 of the section titled "Undertakings" in the Licensee's Enforcement Undertakings accepted by NHS England on 14 March 2023; "In line with any actions agreed as part of the Quality Improvement Plan in relation to management of access and flow of patients and long waits for inpatient beds, the Licensee should set and agree trajectories with the LUHFT System Oversight Group to include suitable metrics for flow including decision to admit delays and total time in department".
- All of paragraph 5 (General) of the section titled "Undertakings" in the Licensee's Enforcement Undertakings accepted by NHS England on 14 March 2023.
