## Request under the Freedom of Information Act 2000 (the "FOI Act")

I refer to your email of **8 August 2017** in which you requested information under the FOI Act from NHS Improvement. Since 1 April 2016, Monitor and the NHS Trust Development Authority are operating as an integrated organisation known as NHS Improvement. For the purposes of this decision, NHS Improvement means Monitor and the TDA.

## Your request

You made the following request:

"Please send me the 2017/18 A&E and RTT Improvement Trajectories for NHS Trusts.

Please send the details in an Excel file by email."

### **Decision**

NHS Improvement holds the information that you have requested.

NHS Improvement has decided to withhold all of the information that it holds on the basis of the applicability of the exemption in section 31 of the FOI Act as explained in detail below.

#### Section 31 – law enforcement

NHS Improvement considers that the withheld information is exempt from disclosure under section 31(1)(g) of the FOI Act which provides that information is exempt information if its disclosure would, or would be likely to, prejudice the exercise by any public authority of its functions for any of the purposes specified in section 31(2).

NHS Improvement considers that section 31(2)(c) is engaged and that disclosure of the information in question would be likely to prejudice the exercise by NHS Improvement of its functions for the purpose of ascertaining whether circumstances exist which would justify regulatory action in pursuance of an enactment. NHS Improvement considers that releasing the A& E and RTT Improvement trajectories for trusts would be likely to prejudice its relationship with providers and therefore NHS Improvement's regulatory role in the performance management of the service.

The information requested is used by NHS Improvement to plan for activity across the financial year and ensure that trajectories are financially viable and that the trusts are in line with national performance standards. NHS Improvement relies on the full and frank information from trusts in order to carry out its functions effectively. NHS Improvement relies on having a safe space in which providers are freely able to share sensitive and confidential information in the knowledge that the information, or any analysis derived directly from it, will not be disclosed more widely. To disclose that information more widely is likely to have a detrimental impact on the quality and content of exchanges between NHS Improvement and the bodies it collectively regulates and its ability to make effective and fully informed regulatory decisions.

#### Public interest test

Section 31 is a qualified exemption and therefore requires that a public interest test is carried out to determine whether the exemption should be maintained. There is a public interest in the performance of NHS providers. In future months, the NHS Improvement board paper will include the trajectories within the content of the published report. Trajectory data will be published in the report against monthly performance that has been achieved for the year to date. NHS Improvement therefore considers that the public interest will be addressed by the publication of this information and that the information you have requested should not be disclosed.

## **Review rights**

If you consider that your request for information has not been properly handled or if you are otherwise dissatisfied with the outcome of your request, you can try to resolve this informally with the person who dealt with your request. If you remain dissatisfied, you may seek an internal review within NHS Improvement of the issue or the decision. A senior member of NHS Improvement's staff, who has not previously been involved with your request, will undertake that review.

If you are dissatisfied with the outcome of any internal review, you may complain to the Information Commissioner for a decision on whether your request for information has been dealt with in accordance with the FOI Act.
