Request under the Freedom of Information Act 2000 (the "FOI Act")

I refer to your email of **11 May 2017** in which you requested information under the FOI Act from NHS Improvement. Since 1 April 2016, Monitor and the NHS TDA are operating as an integrated organisation known as NHS Improvement. For the purposes of this decision, NHS Improvement means Monitor and the NHS TDA.

Your request

You made the following request:

"Can you please provide the following information regarding NHS spend on Agency staff, broken down by:

Job role ie Nurse or Physiotherapist

Speciality within each job role ie General Nurse or Mental Health nurse Band ie Band 5 or 6 Spend per job role ie NHS spend on band 5 Mental health nurses Shown monthly for the Period Jan 2016 - April 2017"

Decision

NHS Improvement does not hold the information that you have requested.

NHS Improvement does not hold details of NHS spend on agency staff broken down per job role and specialty within each job role. However, further to our duty to provide advice and assistance under section 16 of the FOI Act, please find below a table setting out NHS spend on agency staff in respect of Quarters 1 to 3 of the Financial Year 2016/17, broken down into the categories of 'Qualified Nursing', 'Medical' and 'Other'.
