Request under the Freedom of Information Act 2000 (the "FOI Act")

I refer to your email of **4 May 2017** in which you requested information under the FOI Act from NHS Improvement. Since 1 April 2016, Monitor and the NHS Trust Development Authority (TDA) are operating as an integrated organisation known as NHS Improvement. For the purposes of this decision, NHS Improvement means Monitor and the TDA.

Your request

Dear

You made the following request [the numbering has been inserted by NHS Improvement for ease of reference]:

- "1. Please can I have a list of all the hospitals in the UK that use off framework nursing agencies with the spend per hospital on using off framework nursing agencies.
- 2. Also please can I have a list of all the hospitals in the UK that use off framework locum doctors agencies with the spend per hospital on using off framework locum doctors agencies.

Please can you provide the data in a list with the most spend on off framework agencies at the top and least at the bottom."

Decision

NHS Improvement holds some of the information that you have requested.

NHS Improvement **has decided to withhold** the information that it holds on the basis of the applicability of the exemptions in sections 21, 43, 31 and 41 of the FOI Act as explained in detail below.

Question One

NHS Improvement does not hold information on hospitals outside of England. For England, we hold only total agency spend for nursing and not off framework nursing agencies.

The information NHS Improvement holds on total agency spend is publicly available and can be found in our quarterly finance reports. NHS Improvement's most recent report can be found here: https://improvement.nhs.uk/uploads/documents/Quarter_Three_201617_NHS provider_sector_performance_report_-Feb_2017.pdf. Therefore, NHS Improvement has decided to withhold that information on the basis of the applicability of the exemptions in section 21.

Since 1st April 2017, NHS Improvement has been collecting increased weekly data from trusts, including additional data on shifts that are both off framework and above price caps. This data does not give full information on total off framework spend. NHS Improvement does not hold full information on total spend per hospital on nursing agency off framework spend.

NHS Improvement has decided to withhold the information we hold on the basis of the applicability of the exemptions in sections 43, 31 and 41.

Question Two

NHS Improvement does not hold information on hospitals outside of England. For England, we hold only total agency spend for locum doctor agencies and not off framework locum doctor agencies.

As noted in answer to question one, the total agency spend information we hold is publicly available within our quarterly finance reports.

NHS Improvement collects weekly information from trusts on the number of off framework shifts across all staff groups. Information up to the end of March was recently published here: https://improvement.nhs.uk/about-us/corporate-publications/publications/foi-agency-overrides-trust/. Through the 'break glass' clause, all trusts are permitted to use off framework agency staff in exceptional patient grounds. We have previously advised that all trusts have used the 'break glass' clause, although we cannot confirm if this is for framework breaches. We do not hold information on level of spend in each hospital in England that uses off framework locum doctors.

NHS Improvement is withholding the information it holds on the number of off framework shifts across all staff groups at these hospitals. We have decided to withhold the information we hold on the basis of the applicability of the exemptions in section 43, 31 and 41.

Please note that NHS foundation trusts, NHS trusts, and the Department of Health are subject to the FOI Act and as such it is open to you to seek information directly from them. They will need to consider whether information can properly be provided by them in response to any such requests within the terms of the FOI Act.

Section 21 (information accessible to applicant by other means)

Section 21(1) of the FOI Act provides that information is exempt if it is reasonably accessible to the applicant by other means.

NHS Improvement has published information relevant to this FOI request in our quarterly finance reports. NHS Improvement's most recent report can be found here: https://improvement.nhs.uk/uploads/documents/Quarter_Three_201617 - NHS provider sector performance report - Feb 2017.pdf.

Section 41

Section 41(1) provides that information is exempt information if: (a) it was obtained by the public authority from any other person (including another public authority) and; (b) the disclosure of the information to the public (otherwise than under this Act) by the public authority holding it would constitute a breach of confidence actionable by that or any other person.

The test in section 41(1)(a) is met as the information was obtained by NHS Improvement from third parties, in this case providers.

The test in section 41(1)(b) is met if it is demonstrated that disclosure would amount to an actionable breach of confidence. This means: (i) the information must have the necessary quality of confidence about it; (ii) the information must have been imparted in circumstances giving rise to an obligation of confidence; (iii) disclosure must amount to an unauthorised use of the information to the detriment of the confider.

NHS Improvement considers that disclosure of the information would amount to an actionable breach of confidence. The information shared by providers is potentially commercially sensitive and is shared by them on an expectation that it would be kept confidential by NHS Improvement.

Section 41 is an absolute exemption and does not require the application of the public interest test under section 2(2) of the FOI Act. However, in considering whether a confidence should be upheld, a court will have regard to whether the public interest lies in favour of disclosure. For the reasons stated above, NHS Improvement does not consider there is a strong public interest in disregarding the duty of confidence owed to NHS trusts and foundation trusts.

Section 31 – law enforcement

NHSI considers that the withheld information is exempt from disclosure under section 31(1)(g) of the FOI Act which provides that information is exempt information if its disclosure

would, or would be likely to, prejudice the exercise by any public authority of its functions for any of the purposes specified in section 31(2).

NHSI considers that section 31(2)(c) is engaged and that disclosure of the information in question would be likely to prejudice the exercise by NHS Improvement of its functions for the purpose of ascertaining whether circumstances exist which would justify regulatory action in pursuance of an enactment. NHSI considers that releasing the data collected weekly from trusts on off framework agency shifts would be likely to prejudice its relationship with providers and therefore NHS Improvement's regulatory role in the performance management of the service.

Paragraph 12.2 of the agency rules, published by NHSI in March 2016 ("the rules"), makes it clear that NHSI may investigate foundation trusts if there is sufficient evidence to suggest inefficient and/or uneconomical spending (e.g. agency and management consultant spend) which indicates wider governance concerns, and NHS trusts that are not managing their agency spend effectively.

NHSI relies on the full and frank information from trusts in order to carry out its functions effectively. NHSI relies on having a safe space in which providers are freely able to share sensitive and confidential information in the knowledge that the information, or any analysis derived directly from it, will not be disclosed more widely. To disclose that information more widely is likely to have a detrimental impact on the quality and content of exchanges between NHSI and the bodies it collectively regulates and its ability to make effective and fully informed regulatory decisions.

Section 43 (commercial interests)

Section 43(2) of the FOI Act provides that information is exempt if its disclosure would, or would be likely to prejudice the commercial interests of any person.

NHS Improvement considers the data it holds regarding doctor and nursing shifts that are off framework at hospitals in England, to be commercially sensitive.

Public interest test

Section 43 and 31 of the FOI Act are qualified exemptions and therefore requires that a public interest test be carried out to determine whether the exemption should be maintained. We consider that there is a public interest in transparency and that this is met by our disclosure of the information in this letter in a way that safeguards the interests described above that we are seeking to protect, together with the information already available to the public.

Review rights

If you consider that your request for information has not been properly handled or if you are otherwise dissatisfied with the outcome of your request, you can try to resolve this informally with the person who dealt with your request. If you remain dissatisfied, you may seek an internal review within NHS Improvement of the issue or the decision. A senior member of

NHS Improvement's staff, who has not previously been involved with your request, will undertake that review.

If you are dissatisfied with the outcome of any internal review, you may complain to the Information Commissioner for a decision on whether your request for information has been dealt with in accordance with the FOI Act.
