Request under the Freedom of Information Act 2000 (the "FOI Act")

I refer to your email of **6 April 2018** in which you requested information under the FOI Act from NHS Improvement.

Your request

You made the following request:

"I would like to get more detailed split of temporary recruitment across NHS Trusts for the Bank and Agency channel. In your latest 'Performance of the NHS provider sector for the month ended 31 December 2017', on page 22 you have highlight year forecast figures for the Bank at £2.8bn and Agency channel at £2.4bn. Furthermore on page 24 you highlight the Agency YTD split of spending across medical, nursing and other employees. I would like the same split also for the Bank.

I request the following information at NHS UK trusts level:

1. Agency recruitment splits (total spending and total WTE numbers) for medical, nursing and other employees (Forecast 2017/18, and actuals 2016/17, 2015/16 and 2014/15)

2. Bank recruitment splits (total spending and total WTE numbers) for medical, nursing and other employees (Forecast 2017/18, and actuals 2016/17, 2015/16 and 2014/15)"

Decision

NHS Improvement does not hold the following information you have requested:

- Agency or bank recruitment splits by total spending for medical, nursing and other employees: forecast and actuals 2014/15;
- Agency or bank recruitment splits by total WTE numbers for medical, nursing and other employees: forecast and actuals 2016/17, 2015/16, and 2014/15 and actuals for 2017/18.

NHS Improvement holds agency and bank recruitment splits by total spending for medical, nursing and other employees: forecast and actuals for 2017/18, but these figures will be published later in the year so we are withholding this information under section 22 of the FOI Act (information intended for future publication).

NHS Improvement has decided to release the other information it holds, i.e.: (i) figures we hold for 2015/16 and 2016/17 which are set out in the attached spread sheet; and (ii) agency and bank recruitment splits by total WTE numbers for medical, nursing and other employees: forecast 2017/18. This information is set out below.

(i) Please see attached spread sheet.

(ii) The table below contains NHS provider aggregate bank and agency WTE operational workforce plans for 2017/18. Please note that the figures represent operational plans which are developed within a specific financial timeframe and as such, may not fully represent the actual workforce pressures and demands which exist across NHS providers.
