If suitability is not clear, or the patient is suitable but not yet ready at their primary / first appointment with the prosthetic centre post amputation, and then the clock can be stopped for the 2 week timescale for casting, and restarted if indicated at the point when the MDT agrees it is clinically appropriate to proceed.
