# Foreword

## National Cost Collection 2020

1. Our aim is that costing data should support the delivery of high-quality care for patients and deliver better value for the NHS.
2. As a result of the pandemic and the first year of mandation for ambulance and mental health trusts, the cost collections for 2019/20 were spilt into two separate windows.

3. This document supports the publication of the National Cost Collection 2020 which comprises cost data for financial year 2019/20 (FY1920) for all sectors.
4. The cost data submitted by 208 NHS providers in England gives the most comprehensive insight into how the sector spent £72.6 billion delivering healthcare to patients in 2019/20.
5. The National Cost Collection is a nationally mandated collection of cost data from secondary care and tertiary care providers that are delivering services in the NHS.
6. In 2020, the publication comprises:
  - Aggregated costs<sup>1</sup> – the average unit cost to the NHS of providing defined services to NHS patients in England.

- Patient-level costs<sup>2</sup> – a unique cost that is based on the specific interactions a patient has and the events related to their healthcare activity. It provides data about how resources<sup>3</sup> are used at a patient level.
7. The data underpinning this publication has many uses. It informs:
    - costing standards development
    - developments to National Cost Collection, including the impact assessment on mandating the submission of PLICS
    - development of benchmarking metrics and development and population of a benchmarking tool
    - modelling new methods of pricing NHS services or changes to currency design
    - public accountability to Parliament.
  8. Therefore, the quality of a provider's submission is extremely important.
  9. It is a provider's responsibility to improve its internal costing systems, ensuring that the costing model appropriately represents the costs of delivering services.
  10. Due to this, providers are obliged to produce cost data under the conditions P1 and P2 of their provider licence (recording and report of costs).
  11. National bodies have a responsibility to ensure the costs collected are fit for purpose through the production of comprehensive and clear guidance. Those providers that do not comply or do not meet the required standard of data in any given financial year will be subject to actions under the compliance and enforcement policy for the National Cost Collection ratified in 2019.
  12. The following providers are excluded from the FY19/20 costing schedules used by NHS England and NHS Improvement:<sup>4</sup>

- RA2 - Royal Surrey County Hospital NHS Foundation Trust: the trust failed to meet the mandatory validation requirement of balancing the total cost of services delivered to their reconciliation statement to within +-1%.
- RN7 - Dartford and Gravesham NHS Trust: the trust failed to meet the mandatory validation requirement of balancing the total cost of services delivered to their reconciliation statement to within  $\pm 1\%$ .
- RWE - University Hospitals of Leicester NHS Trust: the 2019/20 financial statements have been audited and the auditors are unable to provide an unqualified opinion on one or more aspects of the accounts.
- RJ2 - Lewisham and Greenwich NHS Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- RGN - North West Anglia NHS Foundation Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- RBN - St Helens and Knowsley Teaching Hospitals NHS Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- RC9 - Luton And Dunstable University Hospital NHS Foundation Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- REN - The Clatterbridge Cancer Centre NHS Foundation Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- RYV - Cambridgeshire Community Services NHS Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.
- RY2 - Bridgewater Community Healthcare NHS Foundation Trust: failure to reconcile the cost quantum to within  $\pm 1\%$  of the 2019/20 published provider accounts.

13. The excluded providers' raw data will be published separately in a flat file alongside the national costing schedules.

## Costing Transformation Programme (CTP)

14. 2020 marked a significant step forward in delivering a single National Cost Collection that is submitted entirely from PLICS datasets.
15. The cost schedule for acute providers has been solely built from patient-level costs for admitted patient care (APC), outpatients (OP) and accident and emergency (AE) following the mandation of these services for acute providers.
16. In addition, 133 acute trusts submitted supplementary information (SI) and 69 acute trusts submitted adult critical care (SWC) at patient-level as part of the transition from the National Cost Collection workbook.

# 1. Acute services

17. The value of acute services in FY19/20, including APC, OP, AE, SWC and SI (see paragraphs 15 and 16), totalled £56.8bn.

18. Total costs for all acute services are shown in Table 2<sup>5</sup>.

## 2. Community health services

21. The total value of community health services in FY19/20 was £5.5bn.
22. These services are collected using care contact<sup>8</sup> as the unit of activity, with a few exceptions such as some audiology services, some elements of intermediate care and some wheelchair services.
23. Table 3 shows the unit cost and total costs for community health services between FY17/18 and FY19/20.

# 3. Mental health services

- 24. The total value of mental health services in FY19/20 was £8.0bn.
- 25. Of this:
  - i) £2.5bn was costed against mental health care contacts<sup>9</sup>
  - ii) £2.9bn was costed against mental health inpatient admissions<sup>10</sup>.
- 26. There was a change in the way providers submitted mental health data in FY19/20, with some mental health costs submitted in the previous aggregate format, and the remainder submitted at a patient level.

## 4. Ambulance services

30. The total value of ambulance services in FY19/20 was £2.3bn.
31. Ambulance services are split into four currencies, with units of activity, as follows:
- i) other
  - ii) hear and treat – per patient
  - iii) see and treat – per incident
  - iv) see, treat and convey – per incident.
32. Of the total value of ambulance services in FY19/20, £1.6 billion was reported against the ‘see, treat and convey’ currency.
33. Table 5 shows the unit cost and total costs for ambulance services from FY17/18 to FY19/20.

# 5. Introduction to the data

34. The NCC cost data is presented in four ways:

- the national schedule of NHS costs
- the national cost collection index (NCCI)
- the reconciliation statement
- organisation-level source data.

35. All the data will be published on NHS England website<sup>12</sup>.

## Low Number Suppression

36. In a change to previous years, we now follow NHS Digital's disclosure control rules for any data that they collect on our behalf. This year they were our collection partner for all the acute PLICS data. As this comprises over half of the cost data collected this year, we have decided to apply their disclosure control principles to all of the National Cost Collection data.

37. This means that in the sources data, which is provided at organisation>department>service code>currency level, where the activity count is less than 8 the actual figure has been replaced with a '\*'. The row of data will still be available with the costs shown so you are able to reconcile to a full national quantum of costs using the source data.

## National schedule of NHS costs

38. The national schedule of NHS costs<sup>13</sup> shows the national average unit cost for each service submitted by 208 NHS providers in 2019/20.

39. The schedule shows:

- activity, measured by the number of attendances, bed days, episodes, tests or other unit of activity appropriate to the service

- total cost, measured by the number of attendances, bed days, episodes, tests or other unit of activity appropriate to the service
  - the national average (mean) unit cost, ie total cost divided by total activity
  - the number of data submissions, ie the number of providers reporting costs against each service.
40. The costs included in the schedule are the average of the actual reported costs. We have not removed the market forces factor (MFF) index, which reflects unavoidable cost differences due to geographic location.
41. Within the schedule, we have used unit costs and activity reported by the NHS to estimate:
- the total cost of each activity (by healthcare resource group (HRG), etc) across all settings
  - the total cost of all activity in each setting (inpatients, day cases, outpatients, etc).
42. As in previous years, we exclude HRG UZ01Z (data invalid for grouping) from the schedules. It also excludes high cost homecare drugs, unmatched imaging and unmatched radiology.
