To Note:

The entry and exit criteria are currently under review as the CQC have updated the inspection protocols and no longer routinely give a rating on reinspection. Therefore, the CQC inspection will be one data point in the decision to enter or exit the programme.

The exit criteria from the MSSP will be defined and agreed with the regional team and Trust following completion of the diagnostic phase of the programme.

We are working with the CQC and organisations on the MSSP where sustained improvement would have resulted in an improved CQC rating, to manage their exit from the programme.
