These variations are made to comply with:

- The National Health Service (General Medical Services Contracts and Personal Medical Services Agreements) (Amendment) Regulations 2022; and

which came into force since the last update to the Standard Personal Medical Services Agreement.

These variations also remove four definitions which are no longer used in the Standard Personal Medical Services Agreement following changes made previously to comply with the National Health Service (General Medical Services Contracts and Personal Medical Services Agreements) (Amendment) Regulations 2021.

For the avoidance of doubt nothing in this notice shall affect accrued rights or liabilities up to the date of the variation.

Wording of Variations

Clause 1

1. In clause 1.1 **delete** the definitions of "Cervical Screening Services, "Child Health Surveillance Services", "Childhood Vaccines and Immunisations" and "Maternity Medical Services".

Clause 26A

- 2. In clause 26A.1 after the words "Exemption Confirmation Request" **insert** the words "if it is made at a relevant time"
- 3. After clause 26A.2.2, insert the following:
 - "26A.2A A valid Exemption Confirmation Request is made at a relevant time if, at the time the request is made to the Contractor:
 - (a) legislation in force in England requires a person or class of person to be vaccinated against coronavirus unless they can show that, for clinical reasons, they are exempt from vaccination with an authorised vaccine; or
 - (b) guidance issued by, or on behalf of, the Secretary of State provides that a person or class of person should be vaccinated against coronavirus unless they can show that, for clinical reasons, they are exempt from vaccination with an authorised vaccine."
- 4. In clause 26A.5 after the words "Exemption Confirmation Request" **insert** "made at a relevant time"

Clause 29.8

5. **Replace** clause 29.8 with the following:

"29.8 Reserved."

Clause 38.7A

6. Clause 38.7A.3.2:

Before the words "Relevant Financial Year" **insert** the words "Subject to subclause 38.7A.3.2A,"

7. After clause 38.7A.3.2.2, **insert** the following:

"38.7A.3.2A the financial year ending on 31 March 2021 is not a Relevant Financial Year;"

8. **Replace** clause 38.7A.3.3.2 with the following:

"38.7A.3.3.2 Reserved;"

- 9. In clause 38.7A.4.2, **replace** the words "subsequent financial year" with the words "other Relevant Financial Year"
- 10. In clause 38.7A.5, **delete** the words "(this means, for example, that "the Next Financial Year", in relation to the financial year ending 31 March 2021, is the financial year ending 31 March 2022)"

Clause 74

- 11. In clause 74.4.11, **delete** the word "and" at the end of the clause
- 12. In clause 74.4.12 after the word "chemoprophylaxis" **delete** the full stop and **insert** ": and"
- 13. After clause 74.4.12, **insert** the following:
 - for responding to an Exemption Confirmation Request as defined in clause 26A.2.1, if that request is not one which
