## Introduction

On 18 June 2018 the Prime Minister set out a funding settlement for the NHS in England for the next five years.

In return the NHS has been asked to set out a Long Term Plan for the future of the NHS setting out our ambitions for improvement over the next decade.

The NHS was also asked to ensure the Long Term Plan was developed based on the advice and experience of clinical experts and other stakeholders, including representatives of patients and the public. Engagement with these groups has therefore been a key feature of our work at all points of the plan's development.

We are grateful to everyone who shared their time, energy, expertise and experience through this process. We hope we will continue to work in partnership as we operationalise the Long Term Plan and start to deliver it across the country.



## **Our approach**

We set out to take a co-production approach to developing ideas for potential inclusion in the plan through ongoing dialogue with stakeholders – central to which was the inclusion of key non-NHS stakeholders on every working group.

Each of those working groups then took responsibility for engagement with a wider group of stakeholders within their area of focus, establishing ongoing dialogue to inform, develop and refine proposals. This took many forms, including direct mail-outs to key groups, meetings with established networks and bespoke focus groups and workshops with patients, carers and support organisations.

Further meetings and events were held with different audiences to explore cross-cutting themes and the needs and priorities of different communities, including focused events with the Older People's Sounding Board, the Youth Forum and organisations working with communities experiencing the poorest health outcomes.

As well as the iterative development of proposals through discussion, we also received written submissions from a large range of stakeholders, both via an online feedback form and directly via the dedicated email account; these were passed onto relevant workstream leads to feed into their ongoing work.



## **Working groups**

The Long Term Plan working groups were set up for each of the workstreams (as described in the discussion guide) to ensure that the development of proposals benefited from a breadth of expertise and experience.

Working group membership was drawn from a range of organisations and was composed of:

- 41 local NHS leaders (primarily Trust, CCG or STP leaders).
- 41 members from patient groups, staff and clinical representatives (such as Royal Colleges).
- 41 working group members were also senior clinicians, nurses or Allied Health Professionals.



The working groups also took a lead on engaging stakeholders to help meet the commitment that the plan involved a wide group of system leaders, clinicians, partners and third sector groups in drawing up the plan.

## The engagement workstream working group

The engagement working group was established to both oversee the engagement process for plan development and also to advise on how ongoing engagement should be established and mainstreamed through implementation.

## Meetings, events and conversations

During August and September, we held or attended over 150 meetings to discuss and develop the Long Term Plan. These ranged from one-to-one discussions with leaders of public bodies, think tanks and voluntary sector organisations; to large scale workshops with patients and the public; to presentations at national professional body conferences.

Particular effort was taken to hear from communities that experience the poorest health outcomes, working through partners in the community sector. For example, we held workshops with ex-prisoners, members of the traveller community, former addicts, sex-workers and rough sleepers to discuss their priorities for the NHS.

Further meetings took place in October and November as proposed policies were refined and brought together, including two well-attended policy development days with hundreds of Trust, CCG and STP/ICS leaders, and two bringing together the leaders of all the workstreams with leaders of key stakeholder organisations.



## **Broad based engagement**

Alongside the direct conversations described above, we made an online 'call for views' to give everyone an opportunity to take part and share their views.

To support this, we created a discussion guide (together with an Easy Read version) containing key questions covering a broad range of subjects aligned to the working groups.

This document was written to cover a mixed audience, ranging from patients and the public, to local and national special interest groups, to clinicians and senior NHS staff.

To ensure it reached as wide a group as possible, we worked with the VCSE Health and Wellbeing Alliance, The Patients Association and Healthwatch England to reach out via their members, supporters and local organisations, and encouraged all of our stakeholder organisations to do the same. We also promoted it through a series of blogs on the NHS England website and on social media.

We encouraged organisations to use the guide to hold discussions with their members and local communities and then feed back collated views via the online form.

We also established a dedicated email address to receive enquiries, written submissions, and requests for attendance at meetings and events.

## **Overview of outputs**

2,045 responses were received via the online feedback form, from a range of respondents:

- 56% (1172) of responses were from members of the public.
- 16% (335) of responses were from individual clinicians.
- 26% (538) of responses were from organisations.

In addition, around 500 direct written submissions (not via the online form) came from public bodies, professional representative groups and voluntary sector organisations.

Responses were received from all regions of England and the devolved administrations, and for all workstream questions.


The organisations – such as patient groups – that responded via the online portal reported to be doing so on behalf of a combined total of 3.5 million individuals or organisational members/ supporters.

Joint responses were also submitted from local authorities and health systems representing millions of people within their population.

Healthwatch England submitted evidence from over 85,000 people which has helped inform multiple workstreams.

## **Overview of online responses**


## **Online responses type of respondent**

## Feedback on the process

The broad response from stakeholders has been that the process of developing the plan has been open and inclusive in terms of providing opportunity for input, and that they have been wellinformed of the process, timelines and how they could play a part in it.

"Given the limited time available to develop the accompanying Long Term Plan ahead of the budget, we also welcome the level of engagement and consultation that NHS England has undertaken with staff, stakeholders, partners and the wider public - in particular, the commitment shown to engaging and consulting with the VCSE sector. ## What next?

The publication of the NHS Long Term Plan is not the end of the conversation around the future of NHS services.

We want to build on the activity that has taken place so far and the enthusiasm it has generated to ensure that the dialogue, insight and influence of staff, patients and other stakeholders continues as the plan is implemented.

Local NHS organisations – working with their local councils and other partners – are now being asked to co-produce their own strategies for the next five years, for how they will translate the plan's contents into local action.

This means that staff, patients, the public and other stakeholders should have the opportunity to help their local health and care organisations produce these plans.

We are also establishing an NHS Assembly, which will bring together representatives of clinicians, staff, patients and other stakeholders nationally to advise the boards of NHS England and NHS Improvement on progress.

Members of the NHS Assembly will bring insight and frontline experience to provide a 'reality check' on how effectively the initiatives in the Long Term Plan are being delivered on the ground, and to forge consensus on what is needed further to realise the ambitions described in the plan.
